- 3. All the technical sanction ceases at CE level. CE should be responsible for the correctness of the PE for any reason.
- 4. Utmost economy in expenditure shall however be ensured by Engineering Wing during execution of work.
- 5. Each work included in the PE shall be executed only through Proper call of Tenders after complying all codal formalities and department instructions issued from time to time.
- 6. The sanction authority of deviation will invariably ensure that there is no undue benefit should accrue to the contractor.
- It shall be ensured by TS Authority & Dy. CAO/CAU that the expenditure on the work charge establishment and petty items does not exceed the amount of 3% contingencies.
- 8. Provision kept in PE for different sub heads will not be misused/diverted in other Sub-Heads.
- No payment shall be released unless the AA&ES is accorded to the above extent.
- 10. The rates so allowed for additional quantities/items should be lowest as per market trend.
- 11. Utmost care is to the taken classification of expenditure on this upgradation.

Sub: MINUTES OF 45th BGDA (EAC) meeting held on 07.11.2025.

The 45th BGDA (EAC) meeting was held on 07.11.2025 at 01:00 pm in VC's Conference Hall, DDA, Vikas Sadan, New Delhi. The Vice Chairman, DDA presided over the meeting. The list of officers who attended the meeting is annexed as Annexure- 'A'.

The items discussed and decisions taken in the meeting are as under: -

### 1. Item No.01/45

Name of Work: SITC of VRV/VRF System and Substation Equipment at Vikas Minar

Amount of PE: Rs. 10,99,31,766/-

The agenda for seeking approval for sanctioning of Preliminary Estimate of above cited work was presented by CE (North Zone)/DDA. The Financial Concurrence to the Preliminary Estimate for the work has been accorded by Finance Member, DDA vide Sanction No. 12/2025-26 for an amount of Rs.10,99,31,766/- (Rs. Ten Crore Ninety-Nine Lakhs Thirty-One Thousand Seven Hundred and Sixty-Six only) including 3% contingencies i.e., Rs. 31,63,276/- (Rs. Thirty-One Lakh Sixty-Three Thousand Two Hundred and Seventy-Six Only), TPQA Charges @1% i.e. Rs.10,54,425/- (Rs. Ten Lakh Fifty-Four Thousand Four Hundred and Twenty-Five Only), Departmental Charges 0.25% i.e., Rs. 2,71,515/(Rs. Two Lakh Seventy-One Thousand Five Hundred and Fifteen Only) and conveyed by AO (Works-II)/DDA vide No. F.2(11)/AO(W)/PE/DDA/2025-26/69 Dated: 08.09.2025.

SE (Elec.)/North Zone explained the scope of work taken in this estimate. VC/DDA directed CE(North) to give a detailed presentation on VRV/VRF AC system taken in this estimate before approving the Estimate.

After due discussions and deliberations, the Committee deferred the item and directed that the item be put up after giving a detailed presentation on the proposal.

SE (Elec.)/South Zone explained the scope of work taken in the estimate. VC/DDA expressed that CCTV purpose in Vikas Sadan is only for deterring malafide activities of people and monitoring of feeds are only done after the occurrence of such incidents are reported. It has been directed some measures should be taken in software to analyze, point out and report the lapses in office premises in terms of malpractices. It is also directed that a clear-cut SOP should be issued by Commissioner cum secretary office in this regard.

After due discussions and deliberations, the Committee approved the estimate from administrative point of view as per details given below:
