The Details of Each section of Circular is given below –

(a) Circumstances to get the material tested from empanelled labs:-

- (i) Test is not available with Govt. Labs situated in Delhi.
- (i) Test is not available in Govt. Engineering Colleges situated in Delhi.
- (iii) Test is not available in Zonal & Central Lab of DDA (QAC lab at AGVC).

(c) The Terms and conditions to be followed by the empanelled labs:-

- 1. The empanelment shall be done for a period of 2 years.
- 2. Testing is to be done as per relevant CPWD specifications, BIS code, IRC Code, MORTH specifications, relevant International Codes and as required by the Department.
- 3. Performance Review of the lab shall be made by SE(QAC)/EE(HQ)QAC quarterly.
- 4. The empanelment shall remain liable for cancellation; in case any adverse remarks are received against any laboratories. However, Chief Engineer (QAC),DDA reserves the
- 5. Logo of NABL should be displayed on all testing reports issued by the lab.
- 6. The empanelled laboratories shall lift samples from work sites/offices of DDA as per requisition. The cost of lifting of samples from site shall be included in the cost of

testing. On refusal/delaying in lifting the samples by Lab, Chief Engineer (QAC), DDA reserves the right to cancel the empanelment anytime without assigning any reason. 7. The empanelled laboratories shall retain the balance material after testing for at least thirty days from date of report to the department, for conforming test results and sixty days in case of non-conforming test report/result, for witness/verification as per the

8. On receiving of samples, empanelled lab shall perform the tests within prescribed period as per relevant specification and shall submit the test results/reports within three days of conducting test. In case of frequent delay in submission of test reports, Chief Engineer (QAC), DDA reserves right to cancel the empanelment.

9. (a) The empanelled laboratories shall report the acknowledgement of receipt of sample from DDA on same day via e-mail id at official email ID of concerned office of

(b) Soft copy of test report shall be sent to the official email ID of concerned office of DDA on the date of issue of test report as well as the hard copy to the concerned office of DDA. The empanelled lab shall give undertaking in this regard.

10. The empanelled laboratories shall be liable to indemnify DDA for amount of Rs. One Lakh for any loss of samples/litigation or any other financial loss in the process of testing of materials as Indemnity Bond submitted by labs.

11. NABL accreditation should be valid for the period of empanelment or extended period, whichever is later.

12. These rates as consented by selected labs shall be applicable for two years from the date of issue of this letter and service Tax/GST shall be paid extra as applicable.

13. The Indemnity Bond submitted shall be applicable for the period of empanelment or extended period whichever is later.

(d) Action required by concerned CES:-

a) All Chief Engineer/DDA to ensure that the proportionate distribution of samples is maintained among the empanelled private labs, for more transparency & to avoid monopoly of some particular Labs. This supersedes the QAC circular No. 228 issued F73(175)2021/CE(QAC)/Pt.-III/DDA/145 dated 18.05.2022 which was further extended up to 31.10.2025.

b) Performance Review of the labs shall be sent quarterly to the QAC, DDA.
