G.S.R. 155(1).— In exercise of the powers conferred by Section 57 of the Delhi Development Act, 1957 (61 of 1957), read with sub-rule (1) of rule 3 of the Delhi Development (Miscellaneous) Rules 1959, the Delhi Development Authority, hereby makes, with the previous approval of the Central Government, the following Regulations relating to the methods of recruitment to the posts of Librarian/Asst. Librarian which may be read as under :

Recruitment Regulations for the post of Librarian in DDA

(v) Diploma in Public Relations/Journalism.
Desirable :
(i) Proficiency in a language other than the one at graduation level.
(ii) For departmental candidates the post will be regularised only when Diploma in Journalism/PR is acquired by the promotee. |
| 8. Period of probation, if any. | 2 years |
| 9. Method of recruitment whether by direct recruitment or by promotion or transfer. | (1) Promotion : Asst. Librarian with 5 years regular service in the grade falling which by Direct Recruitment |
| 10. If a DPC exists what is its composition. | St. Level DPC |
| 11. Whether age and qualifications prescribed for direct recruits will apply in the case of promotion. | Not applicable |
| 12. Savings. | Nothing in these regulations shall effect reservations, relaxation of age limit and other concessions required to be provided for the SC/ST, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Govt./DDA from time to time. |
| 13. Disqualification | (i) Who has entered into or contracted marriage with a person having a spouse living or |

14. Powers to relax

(b) Who having a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post.

Provided that the Central Govt./DDA may, satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for so doing exempt any person from the operation of this regulation.

Where the Chairman/Authority is of the opinion that it is necessary or expedient so to do, it may be order for reason to be recorded in writing relax any of the provisions of these regulations in respect of any class or category of persons or post.

RECRUITMENT REGULATIONS FOR THE POST OF ASSISTANT LIBRARIAN

- 1. Name of post : Assistant Librarian
- 2. No. of posts : 2
- 3. Classification : Group 'C'
- 4. Scale of pay : Rs. 4500-7000
- 5. Educational & other qualifications required for direct recruits. : Degree from a recognised University or equivalent with English or Hindi as a subject.
 - (i) Proficiency in a language other than the one at graduation level.
 - (ii) Diploma in Lib. Science.
 - Desirable : Experience of public relation/journalism or mass communications will be preferred.
- 6. Period of probation if any. : Two years
- 7. Method of Recruitment whether by direct recruitment or by promotion or transfer or by deputation and percentage of the vacancies to be filled by various methods. : By promotion falling which by direct recruitment.
- 8. In case of recruitment by promotion/transfer/deputation grades from which promotion/transfer/deputation is to be made. : By promotion from amongst Graduate FDC's & UDCs with 6 years service in the grade & possessing qualification of diploma in Library Science. Age limit will be 40 years.
- 9. If a DPC exists what is its composition. : As for Group 'C'.
- 10. Saving. : Nothing in these regulations shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Caste, Scheduled Tribes, Ex-Serviceman and other special categories or persons in accordance with the order issued by the Central Govt./Delhi Development Authority from time to time in this regard.
- 11. Disqualification : No person
 - (a) Who has entered into or contracted marriage with a person having a spouse living or;
 - (b) Who having a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post.
