F&E Circular No. 2/2021

Vide F&E Circular No. 28/2013 dated 18.12.2013 and No. 8-A/2015 dated 05.05.2015, financial powers for sanction of honorarium have been delegated to the Officers of DDA as under:-

| 5. | Commissioner-cum- Secy./Commissioners/C.L.A. | Full powers upto Rs. 2000/- in each case in a financial year. | | |
| 6. | Chief Vigilance Officer | Full powers upto Rs. 3000/- in each case in a financial year. | | |

- 2. It has been observed that honorarium to the DDA employees is being sanctioned in routine manner by some of the HODs without giving due consideration to the basic provisions enumerated under FR11, FR-46 (b) and Instructions/Orders issued by the Government of India from time to time.
- 3. Accordingly, the Competent Authority has decided to issue the following instructions which may be kept in view by the HODs while recommending/sanctioning honorarium to the employees of DDA. It has been further decided that sanction for honorarium for the financial year shall be submitted in the prescribed proforma accompanied by a certificate prescribed in this Circular.

- a) The recommendation/sanction of honorarium should be in conformity with provisions of FR -11, FR-46 (b) and other instructions on the subject issued from time to time including DoP&T's OMs dated 17.07.1998 and 29.03.2001.
- b) The basic criteria for recommending the Honorarium should be for laborious/exceptional/meritorious work of occasional/intermittent character.
- c) Name of such persons who have been charge-sheeted or on whom any penalty/warning has been imposed/issued should not be included in the list.
- d) The names of only those persons, who have worked at least 6 months in relevant financial year in the concerned Division/Office and have not been on any kind of leave exceeding two months, should be recommended.
- e) Honorarium may be recommended to officers of the pay level-11 and below (i.e. equivalent or below to the level of Dy. Director/Dy.CAO).
- f) The recommending authority should certify that honorarium has not been recommended for any items of work for which payment of honorarium is already prohibited in terms of DOPT's OM No. 17011/3/97-Estt.(Allowances) dated 17th July 1998.
- 4. The proposal for payment of honorarium shall be accompanied by a Certificate in the prescribed proforma (attached with this Circular) from the respective HODs/Sanctioning Authority.
