DDA: Torchbearer of Delhi's Legacy

Taking care of Delhi, one of the oldest continuously inhabited cities of the world is an undertaking that fills us with pride. But, while it is an enviable duty, it is also an onerous responsibility demanding total dedication. Managing thousands of years of the past with an eye on the future, and, at the same time, fulfilling contemporary expectations, DDA has geared up with time to look after the evolving needs of the timeless city.

The story of Delhi starts with Indraprastha when it emerged as one of the five villages contested between the Pandavas and the Kauravas. Later Delhi went on to become an important centre under Raja Surajmal and a stronghold under Prithviraj Chauhan. A succession of emperors and empires from the Slave Dynasty to the Khiljis and the Tughlaqs to the Mughals went on to establish Delhi as the principal city in India's medieval history. The city came under the British Empire when they shifted their capital from Calcutta to Delhi in 1911. The prestige it earned then continues till date as Delhi remains the celebrated capital of independent India. Initially, the Northern Ridge was proposed as the capital of Delhi but was later changed to the location around Raisina Hills. Edward Lutyens and Herbert Baker, renowned British town planners, gave Delhi its unique character and grandeur as a metropolis when they drew the blueprint of New Delhi in 1912.

In 1922 a tiny Nazul office, consisting of 10 to 12 officials, was set up in the Collectorate of Delhi, the first Authority to regulate the planned development of the city. In 1937, the Nazul office was upgraded to an Improvement Trust, constituted under the provisions of the United Provinces Improvement Act, 1911, to control building operations and regulate land usage. In 1947, when India gained its independence, Delhi witnessed a vast inflow of migrants. Its population shot up from 7 lakhs to 17 lakhs leading to critical shortage of urban infrastructure and a virtual collapse of civic services. A large number of migrants were forced to occupy open spaces. This paved a new direction and need for the planned development of the city.

Delhi Improvement Trust and Municipal Body, the two local bodies at the time, were not quite equipped to cope with the changing scenario. In 1950, the Central Government appointed a Committee under the chairmanship of G. D. Birla to plan and check Delhi's rapid and haphazard

growth. This Committee recommended a single planning and controlling Authority for all urban areas of Delhi. Consequently, the Delhi Development (Provisional) Authority (DDPA) was constituted by promulgating the Delhi (Control of Building Operations) Ordinance, 1955 (replaced by the Delhi Development Act, 1957) with the primary objective of ensuring the development of Delhi in accordance with a plan. Thereafter, on 27th December, 1957, Delhi Development Authority acquired its present name and assumed its historic responsibility as the 9th builder of Delhi.

At its inception, DDA had no yardsticks or plans to follow. Thereafter, it formulated the Master Plan for Delhi in 1962 with perspective up to 1982, for an organised and structured growth of the city. Later, this Master Plan became the benchmark and blueprint for other cities to follow. The key features of this Master Plan envisaged identifying land that could be developed into residential areas and create self contained colonies by providing ample space and support infrastructure for commercial use as well. This Master Plan was extensively revised with perspective up to 2001 and was adopted in 1990. It was further modified extensively keeping in mind vision and policy guidelines for the perspective period up to 2021 and was notified on 7th February, 2007. Currently, the work on MPD-2041 is in progress in association with National Institute of Urban Affairs (NIUA).

With its team of world class town planners, DDA gradually transformed Delhi into a global metropolis. Besides introducing the Master Plan, DDA also pioneered several landmark initiatives that today serve as benchmarks in India's urban development. DDA also formulates zonal plans, action area plans and urban extension projects. The spheres covered include housing schemes, commercial complexes, office spaces, land development, transportation, infrastructure, recognition and preservation of heritage sites in Delhi, sports complexes, play grounds, golf courses, sustaining the environment, retaining green belts and forests, etc. DDA's thoughtful initiatives and efforts have led to Delhi being recognized as one of the greenest capitals of the world. With approximately **783 parks and 7 Biodiversity parks** in its jurisdiction, DDA has kept its commitment of upgradation and maintenance of green areas. Besides it has developed **15 sports complexes, 3 mini sports complexes and 2 golf courses.**

In addition to the creation of verdant green belts, DDA has also stepped forward to nurture the future of natural resources and greenery of the city by setting up the Delhi Biodiversity Foundation. A key objective of the Foundation is to retain the rich ecological and natural biodiversity of the National Capital Territory of Delhi.

This Foundation has set up the first of its kind biodiversity parks, 6 of which will eventually be developed by DDA with technical inputs by a team of scientists who have specialised in the areas of biology, ecology and wildlife.

To lend Delhi its global character, DDA has gone well beyond its mandate of urban infrastructure development to address problems related to transportation and daily commuting of citizens. DDA has set up the Unified Traffic and Transport Infrastructure Planning and Engineering Centre (UTTIPEC) for planning roads, highways and related infrastructure to reduce congestion and enhance mobility of Delhi's burgeoning traffic. DDA has also modernised its logistics to introduce online services in order to facilitate better services, quicker turnaround time and transparent operations across services rendered to the public.

The cumulative efforts of DDA's initiatives and achievements have visibly transformed the city into a dynamic, vibrant, global metropolitan city that's seamlessly changing, adapting, growing and glowing as the pride of India. Aligning itself with the changing times, DDA has also become an undisputed leader in the development of sports facilities and in promoting greenery in the process, touching and transforming life in every conceivable manner.

Shri Baijal has also held charge of Secretary (Urban Development), Government of India, Vice Chairman, DDA, Chief Secretary, Andaman & Nicobar Islands and CEO of Prasar Bharti amongst other assignments. Shri Baijal has also served in the executive councils of think tanks and multiple corporate boards apart from being an advisor on National e-governance Advisory Group (NAG), Advisory Group for Integrated Development of Power, Coal and Renewable Energy and Committee on implementation of Corporate Social Responsibility.  - A total of six Core Group Meetings were held under the chairmanship of Commissioner (Plg.)
 - Five Working Group - IIB Meetings were held under the chairmanship of Pr. Secretary, PWD, GNCTD.
 - One Governing Body Meeting was held under the Chairmanship of Hon'ble L.G. at Raj Niwas.

Registration of land parcels through Web Portal for Willingness to Participate

4.1.5 MPMR & NCR UNIT

Master Plan for Delhi - 2041

In adherence to the Memorandum of Understanding with NIUA for "Collaboration for Preparation of Master Plan For Delhi- 2041 as an Enabling Strategic Plan and Other Related Policies/Plans", sixteen Action Committees under the chairmanship of Commissioner (Plg.) and six (6) Review Committees under the Chairmanship of VC, four (04) meetings under the chairmanship of Hon'ble LG, Delhi were successfully organised during this period to monitor progress of the preparation for MPD-2041.

DDA website for MPD-2041 started for dissemination of information

A robust citizen consultation mechanism through interactive website is under process at DDA. A portal has been put up on DDA website (dda.org.in) for inviting queries/observations and suggestions for MPD 2041.

GIS based mapping for Delhi

As part of the process of preparation for the next Master Plan, DDA intends to undertake a detailed aircraft/UAV (Drone) captured LiDAR/ortho image based GIS mapping of existing land use and building use in the city. The RFP for the same has been uploaded on DDA's website

Memorandum of Understanding with IIT Roorkee:

MoU with IIT Roorkee regarding Drone Survey and Field Survey for Zone N (excluding aerial mapping), Zone-J, Zone-P-I & Zone P-II and Master Consultant on GIS technology and capacity building. MoU regarding drone survey and capacity building was signed on 08/02/2020. Award Letter has been issued to IIT-Roorkee.

4.3 LANDSCAPE AND ENVIRONMENT PLANNING DEPARTMENT

Delhi, spread over an area of 1497 sq. km, is one of the greenest metros in the country. The city has experienced tremendous growth in recent times, with increased pressure on its open spaces. Delhi Development Authority (DDA), the first Urban Development Authority in India, has played a key role in overall development and management of its green spaces, with conscious efforts towards the development of open spaces as Regional parks, Biodiversity Parks, District parks, green belts, Neighborhood greens, etc. Currently, DDA has more than 783 parks, 7 Biodiversity Parks and some forests areas. DDA has categorized parks into a, b and c categories. The category ‘a’ parks are comparable with the best in the world.

DDA has taken up construction of community halls in a big way for the benefit of public.

Further, to facilitate the optimal utilization of community halls and to make them more useful for public, a number of permitted activities are added within the community hall space like gym facility with equipment and cafeteria/dining with an attached kitchen by allowing a portion of community hall to private entities. The RWAs are encouraged to take over community halls and run them and provide various kind of activities as envisaged in the policy.

Refurbishment of Existing Commercial Centres

Three commercial centres- Nehru Place, Bhikaji Cama Place and Basant Lok community centres have been identified for retrofitting. The project envisages upgrading and improving the facilities for markets, piazzas and other amenities. It is also planned to provide multilevel parking facilities at Nehru Place and Bhikhaji Cama Place as part of refurbishment. Additionally, another commercial centre at Rajendra Place has been taken up by the architecture wing to study the feasibility and suggest alternative for refurbishment.

All the vacant plots of DDA are fenced/ boundary wall constructed and signages installed indicating that the land belongs to DDA. Executive Engineer QRTs, who are head of Special Task force (STF) in each zone, are also working in coordination with Assistant Engineers (QRTs) to identify encroachment and their timely removal. The status of all vacant lands is also uploaded on DDA's website www.dda.org.in, regularly.

Accessible India Campaign

Accessible India Campaign is the nationwide flagship campaign of the Department of Empowerment of Persons with Disabilities, Ministry of Social Justice and Empowerment, Government of India. All public buildings are to be made barrier free to provide conducive environment for divyangans all over the country.

Aravali Biodiversity Park, North of Vasant Vihar :

DDA has planned to develop a second Bio-diversity park over the ruminants of ridge area and rocky outcrop in South Delhi. Large area near Vasant Vihar popularly called Muradabad Pahari and Kusumpur Pahari chosen for developing Aravali Biodiversity Park in consultation with Delhi University.

The Aravali Biodiversity Park is presently spread over an area of around 690 acres (277 hectares) between Vasant Vihar and Vasant Kunj. There is vast rocky outcrop extending from the core of the site. The site is undulating and uneven, full of kikar plantation and scrub vegetation of the ridge area.

Some of the development works have been completed. The work of development of Nature Interpretation Centre will be taken up after clearance/NOC from Ridge Management Board.

Sultangarhi Tomb Conservation Complex, Vasant Kunj.

Sultangarhi Tomb, the mazaar of Sultan Nasiruddin Mehmood, was built in the year 1236 AD in Rangpuri Pahari area on Mehrauli-Mahipalpur Road. It has been decided to develop 25 hectares (62 acres) area surrounding the monument. Sultangarhi Tomb comes under the Heritage Zone and so it is presently maintained by Archaeological Survey of India. Development Plan is being prepared by Architecture Wing and the work will be taken up after the receipt of development plans duly approved by Screening Committee.

Land Management and Land Disposal Department

7.1 Land Management Department

Delhi Development Authority has vast area of land of different categories under its jurisdiction. Besides looking after Nazul-I land, which was inherited by DDA from the erstwhile Development Improvement Trust, it also manages and takes care of Nazul-II land acquired by DDA after 1957. DDA also has some land which was taken over from the erstwhile Ministry of Rehabilitation under a package deal. In addition to the above, some land of Land and Development Office, Ministry of Housing and Urban Affairs is also with DDA for care and maintenance. Main functions of the Land Management Department are:-

- i) Acquisition of land
- ii) Management of land
- iii) Assisting the land user departments
- iv) Coordination with various departments and outside agencies for land management matters
- v) Planning and execution of demolition programmes for encroachment removal
- vi) Action against unauthorized construction in the Development Areas of DDA

The Damages Branch of Land Management is entrusted with the work of eviction, assessment and recovery of damages from unauthorized occupants squatting on govt. land under the control and management of DDA. There is an Estate Officer who has been delegated powers under the P.P.Act to discharge duties of assessment of damages and eviction.

The following measures have been taken to improve the functioning of Land Management Department of DDA:-

Inventorization of vacant DDA plots.

I. A comprehensive list of all vacant plots under the various land owning departments viz, Land Management, Engineering and Horticulture has been prepared and uploaded on DDA website.

II. Principal Commissioner (LM) is the nodal officer for monitoring and supervision of encroachment, removal and protection of DDA land under the new dispensation and is assisted by the monitoring unit under the Superintending Engineers (SE) for the respective circles of the Engineering Wing.

- Practice of uploading of photographs of vacant land on monthly basis has been started to ensure timely detection of encroachment.

- Directions have been issued to all the Chief Engineers to carry out work of construction of boundary walls/fencing on vacant land of DDA for their proper protection. Work of erecting signboards on vacant land has also been started.
- Land falling in Yamuna River Bed, which was found to be prone to temporary encroachment, illegal cultivation, etc., has been transferred from LM department to Horticulture department for its utilization as 'green' as per the Master Plan.
- Revised instructions have been issued on implementations of the directions of Hon'ble LG w.r.t. protection of DDA land and to take prompt action for prevention and removal of encroachment.
- A policy circular for award of prize to the officers of DDA who are involved in removal of encroachment and protection of DDA land has been issued with the approval of Vice Chairman, DDA.
- Suitable directions have been issued vide order dated 27.09.2018, to the field staff to maintain proper diaries, etc., for recording details of encroachment found during their field visits. SE, have been directed to inspect the diaries maintained by the field staff on monthly basis. It is submitted that field staff record details of encroachment in their beat diaries specifying nature of encroachment location, etc., thus, it is possible to identify the land under encroachment from the details given in the beat diaries.
- Problem of recurrence of encroachment will be tackled by fencing of reclaimed land after conducting demolition programmes.

Development of mobile phone based application for monitoring of encroachment on DDA land.

i) The field staff responsible for inspecting DDA lands have been provided android based mobile phones and application has been developed for uploading photographs of sites which will also indicate the longitude and latitude with date of photographs. The officer inspecting the site is also required to upload a selfie at site. All these photographs are required to be posted on the application.

ii) The Standing Committee of Parliament of Urban Development had appreciated the efforts made by DDA with respect to development of mobile based application and inventorization of its vacant plots for monitoring encroachment of DDA lands.



Transfer of vacant lands to Engineering/ Horticulture Department.

i) It has been decided that all vacant lands lying with the Land Management Department would be handed over to the Engineering/ Horticulture Department after proper demarcation at site in a time bound manner. Details of khasra nos, longitude and latitude of sites, etc., would be clearly mentioned in the handing/ taking over records.

Land Pooling Policy.

The Development Area of 95 notified villages under Land Pooling Policy is being examined. However, any action on unauthorized construction is being dealt as per the guidelines issued by the competent authority and circulated time to time.

Handing/Taking over of Gram Sabha Land.

Vide Gazette notification dated 28.01.2019 issued by the Government of India, 89 villages have been notified as urban. Land Management Department is carrying out the exercise of handing/taking over of Gram Sabha Land of these 89 villages.

PM-UDAY Cell.

The PM-UDAY Cell (Unauthorized Colonies Cell) have been set up in view of Cabinet's decision dated 23.10.2019 for conferring/recognizing ownership or mortgage/transfer rights to the residents of unauthorized colonies (UCs) in Delhi. This is one the most ambitious projects of the Government of India which is set to benefit 40 lakh residents of unauthorised colonies in Delhi. Delhi Development Authority has notified the Regulations for UCs on 29.10.2019.

Land Disposal (LD) Department

LD Department deals with disposal and lease administration of properties of various uses such as residential, commercial, Institutional, Industrial, commercial estate (built up shops/offices) & license properties by auction or allotment. The Delhi Development Authority (Disposal of Developed Nazul Land) Rules, 1981 {Nazul Rules} provide for the manner of dealing with Nazul land developed by or under the control and supervision of the Delhi Development Authority.

Measures to improve the functioning of LD department

- Data capturing of institutional and industrial properties and e-mutation was successfully implemented under the project IDLI (Interactive Disposal of Land Information) system. This will bring greater transparency and accountability in the system. DDA is not charging any processing fees from applicants. More citizen centric services like e-conversion, e-EOT etc. are scheduled to be launched by June-July 2020.
- E-Auction cell has been created in LD department for coordination amongst various branches to facilitate timely completion of auction process.
- LAB (Rohini) and LSB (Rohini) was merged as both the branches are dealing with Rohini Residential Scheme 1981 to bring in transparency and faster processing.
- Simplified the policy for booking of open spaces/ community halls for religious, social function, etc.

Other achievements of the department during 2019-20:

- Six mega e-auctions of various types of properties were conducted during F.Y. 2019-20. 945 nos. of properties of various types and bid worth approx Rs 2428 crore has been accepted by DDA and will be realised subject to payment from bidders within the stipulated time.
- MoU has been signed for project on conversion of plastic waste to petrol in collaboration with CSIR and local bodies.
- Delhi Apartment Ownership Act was implemented.



Housing Department

Housing activity has been taken up by Delhi Development Authority since 1967-68. In a quest to provide better public service, increased transparency and enhanced accountability, DDA has taken a slew of measures in the past and since this is a continuous process, more measures would be taken in future. Besides, for the first time in DDA's history, the concept of Sample Flat was introduced. This concept helped the applicants visit and inspect the flat and satisfy themselves with regard to location, size and cost before applying for flats.

1. Housing Scheme-2019:-

DDA launched Housing Scheme-2019 for about 17,922 flats of various categories in different localities w.e.f 25.03.2019 and draw for the same was held on 23.07.2019. 8,438 flats of various categories have been allotted to general public.

2. Online Housing Scheme for SC/ST

DDA launched online scheme for SC/ST on 05.09.2019 for disposal of 269 flats at various locations like Jasola, Rohini, Dwarka, etc. Draw for the scheme was held on 23.12.2019.

3. Online Housing Scheme for EWS flats at Narela

DDA launched online scheme for EWS flats on 30.08.2019 and last date to apply was 30.11.2019 for disposal of 6273 flats at Narela. Draw for the scheme was held on 23.12.2019.

4. Online Running Scheme for disposal of LIG flats at Narela "As-Pair" with permission to amalgamate two adjacent flats into one bigger unit

DDA launched Online Running Scheme 2019 w.e.f

06.12.2019 for disposal of LIG flats at Narela 'As-Pair' with permission to amalgamate two adjacent flats into one bigger flat. The buyer will, however, have the choice not to amalgamate also.

5. Online Running Scheme for Gallantry Award Winners

DDA has launched online scheme for gallantry awardees/ war widows on first come first serve basis. Approx. 1000 flats of LIG/ one bedroom category have been included in the scheme for disposal.

6. Kathputli colony in-situ development project, the first in-situ slum redevelopment project on PPP mode taken up by DDA

There are 3348 eligible dwellers in the project. 2800 JJ dwellers will be allotted flats on developed Kathputli colony site while remaining have been allotted built up EWS flats at Narela. The construction of 2800 EWS flats is likely to be completed by December, 2020.

DDA has also issued guidelines for maintenance of DDA colonies and has appointed link officer for every DDA colony. Several meetings have also been held with RWAs and link officers to spread awareness about the Scheme Guidelines. RWAs of DDA colonies will be motivated and supported so that these colonies are well maintained.

Implementation of e-office in Housing Department

E-office was successfully implemented in all branches of Housing Department and currently all the new files are created and dealt electronically.

Digital storage of older files

Around 46,000 files has been digitally processed in Compacter System.

Systems Department

IT / E-GOVERNANCE Initiatives taken for online service delivery to public and for transparency in DDA's working.

- **IMPLEMENTATION OF E-OFFICE:** E-office has been made operational in Housing, Land Disposal, Land Management, Systems, Accounts, Sports, Engineering, Horticulture, Personnel, Public Relations, Planning, Architecture, Landscape and all other departments during 2019-20. Most of the files now move in electronic form in DDA which saves a lot of time in service delivery to the public. About 4000 live files are now in movement on e-office in DDA.

- **ONLINE HOUSING SCHEMES:** All Housing Schemes for flats and auction of properties have been made online.

- **MOBILE APPLICATION FOR PUBLIC GRIEVANCE REDRESSAL AND PORTAL FOR SPECIAL TASK FORCE COMPLAINTS MANAGEMENT MADE OPERATIONAL**

- A web enabled portal and the mobile app is operational for grievance redressal of general public.

- The grievances are replied online, and if need be, the appointments can also be sought online from the concerned officers.

- **ONLINE RECORDS ROOM MANAGEMENT:**

- Record Management Application has been made operational in record rooms. Initially 40000 files have been fed to Record Management System and the record keepers are continuously feeding files in this system. Movement of files can be tracked through this application.

- **ONLINE ALLOTMENT OF STAFF QUARTERS:**

- All applications for staff quarters made online.

- **Online Pro-Vakil Application for Court Case Monitoring:**

- About 24000 pending court cases uploaded for day to day legal proceeding monitoring.

- Real time status of court cases in Supreme Court, High Court and District Court can be checked.

- Provision of automatic alerts through SMS, emails, etc.

- **COMPUTERISED CALL CENTRE:**

- Setting up Computerised Call Centre. Public queries data base is being created.

- **MEASURES FOR EASE OF DOING BUSINESS:**

- Almost 100 % payments are received online.

- Application for online mutation of properties started in August, 2019.

- Module for online calculation of dues for Rohini plots and ground rent for Group Housing started in October, 2019.

- Online Building Plan Sanction System having the integration with 10 other deptts. like Fire, AAI, Archaeology, Municipal Corporations, Urban Arts Commission, etc.

- Online system for deeds for Delhi Apartments

- Online System for damage collection from damage properties

- PMAY projects work monitoring application developed and made operational

- Vigilance Deptt. has been strengthened through online application and e-office implementation

- Computerised processing centres for issuing conveyance deeds established.

- Design, development and implementation of mobile applications for online filling of Measurements Books of Engineering Projects:- User friendly mobile and web based application is operational for filling the Measurement Books (MB) by the contractors and engineers online. This will help in timely completion of projects.

- **FILE TRACKING:**

- File tracking application has been made operational throughout DDA. More than 2 lacs files are ported on it.

- **AUTOMATION OF VICE CHAIRMAN'S OFFICE:**

- Application for managing VC Public Hearing Online

- VIP References Monitoring System

- **VISITORS MONITORING THROUGH COMPUTERIZED PHOTO VISITOR PASSES:**

- Visitors are issued Photo Visitor Passes. Their



mobile number and file no related to their property are stored.

• **Network Leased Line Circuit and WIFI network upgraded for fast access of services by public and DDA employees:**

- 150 MBPS lease lines installed in Vikas Sadan and Vikas Minar for seamless internet services
- 100 MBPS WI-FI services made available in Vikas Sadan and Vikas Minar

• **Scanned images of around 535000 files have been made accessible to various departmental users:**

- About 5 lacs old files and 35000 live files are scanned and uploaded on server
- DDA user can access the files on intranet
- All hardware procurement is being done through Gem online portal to ensure transparency.

• **Mobile application for protection of land by uploading periodic photographs:** This mobile application has been designed and developed through which DDA officials can upload photographs of vacant lands periodically. In this process, the latitude and longitude of the locations are also captured through these photographs and thus one can easily detect encroachments and timely action for removing them can be taken.

• **Monitoring the services in DDA parks through mobile apps:** The mobile based and web enabled application has been designed and developed to receive public feedback of DDA parks.

• **Online booking of DDA's parks, Community Halls and open spaces:** During the year 2019-20, thousands of bookings have been made online. The details are as under:-

• **Online Samasya Nidaan Sewa:** A web enabled online application known as Online Samasya Nidaan Sewa is operational on DDA's website to resolve the grievances of the general public.

• **BHOOMI & Online Services for Rohini Residential Scheme 1981:** Online application has been developed

for online printing of demand letters by allottees and for viewing payment details by the allottees for Rohini Residential Scheme-1981. Allottees can also make the payments online.

• **Vigilance Complaints Management System:** A web enabled software for monitoring vigilance complaints at various levels has been designed, developed and made operational.

• Software **"Monitoring System for Allotment of Land to Govt. / Semi Govt. Agency"** has been designed and developed for entering application details by the applicant online.

• Mobile App **"Garbage & Malba maintenance of DDA Community Hall/ Parks/District Center"** has been developed for submitting complaint by the applicant and web based software has also been developed for monitoring and taking necessary action on complaints submitted by the applicant through mobile app.

• A Web Based Software **"Building Plans/Permits Monitoring System For High Power Committee DDA"** has been developed for tracking references sent to external agencies for seeking NOC regarding Building Plans Permit.

• A web enabled software **Interactive Disposal of Land Management (IDLI)** has been designed and developed for data capturing and retrieval of institutional properties. Various MIS reports have also been developed. Some others features like barcode generation, barcode reading, file location and dashboard have also been developed. The software has been published and made live.

Sports Department

10.1 INTRODUCTION

As per the provision of MPD-2001, DDA embarked upon developing sports complexes in all the zones of Delhi. The first sports complex was opened at Siri Fort in 1989 and thereafter fourteen other complexes and two golf courses have been developed.

For the Commonwealth Games 2010, DDA developed stadia at Siri Fort for squash and badminton and at Yamuna Sports Complex for archery and table tennis. Both these stadia are being utilized for holding regional, national and international level tournaments and are also available for utilisation by the public.

Although these sports complexes are membership oriented having playing rights only, any member of the public can utilise the facilities on payment of the prescribed charges. Special concessions are available for students, senior citizens, schools, sports federations and associations.

Sports complexes are exclusively devoted to sports related activities and facilities for over 20 sports disciplines have been provided.

A Sports Gala to promote participation in sports for members and their dependents is an annual feature at all complexes. Tournaments in individual sports such as tennis, squash, badminton, table tennis, billiards, etc., for all age groups are conducted.

10.6 COACHING

Regular coaching at all the sports complexes in various sports disciplines such as cricket, tennis, badminton, skating, aerobics, taekwondo, etc., were organized. 163 individual coaching schemes are being run by professional coaches and approximately 4520 trainees attended training. Approximately 870 talented trainees from weaker sections of society are being provided free coaching in various disciplines.

Summer Coaching- Special summer coaching camps were also organized at all the sports complexes during the summer vacations of the schools/ colleges.

10.7 PROMOTION OF GOLF

Qutab Golf Course at Lado Sarai, India's first public golf course has gained immense popularity with around 300 rounds being played during weekends in peak season. The 9 hole public golf course at Bhalswa has made the

game of golf easily accessible to the residents of North, West and East Delhi.

The mini golf course constructed at Siri Fort Sports Complex is also popular and extensively used.

The golf driving range at Siri Fort, Qutab and Bhalswa golf courses are used extensively by beginners, amateurs and professionals to improve their game.

10.8 GOLF COACHING

A coaching camp was organised during the year by Qutab Golf Course.

10.9 GOLF TOURNAMENTS

The Qutab and Bhalswa golf courses host several invitational golf tournaments sponsored by corporates. Qutab Golf Course conducts two such tournaments every month during the golfing season. The prestigious LG Cup is held every year in February at Qutab Golf Course.

10.10 SPORTS PROMOTION SCHEMES

DDA is conducting four sports promotion schemes in athletics, football, gymnastics and archery to promote these sports at the grass-root level. The schemes are fully supported by DDA and are run under the guidance of expert advisors and experienced coaches.

10.11 ATHLETICS PROMOTION SCHEME (APS)

It is successfully running since 2001. Currently 29 athletes (15 boys and 14 girls) in the age groups of U-16, U-19 and U-20 years, are receiving coaching in their respective events. Trainees from the scheme participated in various state, zonal and national athletics meets and won laurels for DDA. A few achievements are highlighted below:-

- Annual Delhi State Athletics Championship held at Nehru Stadium from 02.08.2019 to 05.08.2019, DDA athletes won 14 gold, 17 silver and 09 bronze medals.
- Summer Athletics Meet for all Delhi schools held at Chhatrashal Stadium from 21.08.2019 to 24.08.2019. DDA athletes won 7 gold, 4 silver and 6 bronze medals.
- North Zone Jr. Athletics Championship held at Sangrur, Punjab from 14.09.2019 to 15.09.2019. DDA athletes won 7 gold and 1 silver medals.
- Jr. Delhi State Athletics Championship held at Nehru Stadium from 05.10.2019 to 06.10.2019. DDA athletes won 12 gold, 9 silver and 2 bronze medals.
- National Jr. Athletics Championship held at Vijaywada from 02.11.2019 to 06.11.2019. DDA athletes won 2 gold, 1 silver and 1 bronze medals.
- Inter Zonal for all Delhi schools held at Chhatrashal Stadium from 11.11.2019 to 16.11.2019. DDA athletes won 12 gold, 8 silver and 7 bronze medals.



- CBSE National Athletics Championship held at Raipur, Chhattisgarh from 26.11.2019 to 30.11.2019. DDA athletes won 2 gold and 2 silver medals.
- National Schools Athletics for U-17 Boys & Girls held at Sangrur, Punjab from 04.12.2019 to 8.12.2019. DDA athletes won 2 gold and 2 silver medals.
- National Schools Athletics for U-19 Boys & Girls held at Sangrur, Punjab from 22.01.2020 to 26.01.2020, DDA athletes won 1 gold medal.
- Khelo India University Games held at Bhubaneswar from 28.01.2020 to 31.01.2020. DDA athletes won 1 bronze medal.

Note :- In addition to the above, a DDA athlete, created a new National Record in Hammer Throw and was ranked Asia No. 1 in age category as per ranking declared by IAAF for the year 2019.

10.12 FOOTBALL PROMOTION SCHEME (FPS)

It is successfully running since 2002. Open selection trials for new trainees were held on 11th & 12th January, 2020 at Siri Fort Sports Complex and 1st & 2nd February, 2020 at Yamuna Sports Complex. Total 66 trainees were selected, including reserve and 44 old trainees were retained. 45 trainees are receiving coaching at SFSC and 32 trainees are receiving coaching at YSC.

Major achievements of the trainees under the Scheme are as under:-

- In the Amateur league held at Delhi from 10.01.2019 to 5.07.2019, DDA FPS won gold medal.
- DSA "A" Division League (final round) held at Delhi from 03.04.2019 to 28.04.2019. DDA FPS won silver medal and also qualified for Sr. Division League.

The training of gymnasts, boys and girls in MAG/WAG under DDA Gymnastics Promotion Scheme commenced w.e.f. 5th December 2014 at indoor gymnastics hall, YSC. Currently 32 trainees are receiving coaching at YSC.

Major achievements of the trainees under the Scheme are as under:-

- 32nd National Sports Gymnastics Competition 2019 held at Allahabad, UP from 02.10.2019 to 03.10.2019. DDA trainees won 3 gold & 2 Silver medals.
- Delhi State Inter Zonal Gymnastics 2019 held at Subhash Nagar, Delhi from 18.10.2019 to 24.10.2019. DDA trainees won 03 gold, 03 silver and 1 bronze medals.
- 59th Delhi State Gymnastics Championship held at I.G. Stadium, Delhi from 10.12.2019 to 15.12.2019. DDA trainees won 8 gold, 7 silver and 10 bronze medals and, GPS gymnasts won the Team Championship in Boys under 17 yrs.

10.14 ARCHERY PROMOTION SCHEME

DDA Archery Promotion Scheme commenced w.e.f. July 2015. Currently 16 trainees are receiving training at YSC.

- 3rd Khelo India Youth Games held at Guwahati, Assam from 04.01.2020 to 10.01.2020. A DDA trainee won gold medal and three DDA trainees participated out of whom one trainee secured 4th position.
- 1st Khelo India University Games held at Bhubaneswar from 22.02.2020 to 26.02.2020. A DDA trainee won bronze medal in compound archery.
- Assessment Selection trial for World Cup stage 1, 2 for 2020 held at Guwahati, Assam. A DDA trainee was selected but World Cup was cancelled due to Covid 19 pandemic.

10.15 SCHOOL CHILDREN TOURNAMENTS

Since sports facilities in DDA sports complexes remain mostly underutilised during non-peak hours, it was decided by the Sports Management Board that school level tournaments be held throughout the year for optimal utilization of these facilities. Accordingly, school level tournaments are being conducted at sports complexes.

10.16 DEVELOPMENT WORKS

Maintenance and upkeep is an ongoing process at all complexes to ensure that the facilities are kept in good shape. In addition, major up-gradation works of capital nature were also carried out at all the sports complexes and golf Courses.

Finance and Accounts Department

1. ACCOUNTS (MAIN)

The accounts section of the headquarter is mainly responsible for the compilation of the annual accounts of the Authority which comprises of receipts and payments under the various Heads of Accounts as under: -

A. Nazul Accounts – I

It incorporates transactions relating to the Old Nazul Estates taken over from the erstwhile Delhi Improvement Trust by DDA in 1957. The annual accounts comprises of Receipts and Payments Account, Income and Expenditure Account and Balance Sheet.

B. Nazul Accounts – II

It incorporates transactions relating to the schemes of large scale acquisition, development and disposal of land in Delhi. Only Receipts and Payments Account is being prepared for Nazul Account-II.

C. General Development Account (GDA)

This is the main account of the Authority which incorporates the transactions relating to all the properties such as housing for weaker sections, LIG, MIG, commercial activities like district centers, etc., and lands vested in the

Authority and are paid for out of the revenues of this account. The annual accounts comprises of Receipts and Payments Account, Income and Expenditure Account and Balance Sheet.

D. DDA Pension Fund Trust and Gratuity Fund Trust

In addition to the above, financial statements, i.e. Receipts and Payment Account, Income and Expenditure Account and Balance Sheet are being prepared separately for these two trusts.

Besides, compilation of annual accounts of Authority as stated above, the accounts section also deals with the short term investment of funds under General Development Fund, Nazul A/c-II, UDF, etc. on the recommendations of investment Committee headed by CAO, DDA.

Further, annual accounts for the year 2018-19 have been audited by the C&AG and “true and fair” certificate from the C&AG has been obtained. The audited Annual Accounts of DDA for the year 2018-19 have been sent to the Ministry on 31.01.2020 for laying the same before the Parliament. Monthly accounts up to March, 2020 have been compiled and on the basis of the same, Receipts and Payments upto 31.03.2020 are given as under:-

4. WORKS AUDIT CELL

The Works Audit Cell deals with post audit of vouchers submitted with monthly accounts of all the 07 Zones. Financial concurrence to Preliminary Estimates for AA & ES & scrutiny of WAB agenda items. UDF and pre audit of Pension/Family Pension cases.

During the financial year 2019-20, 77 arbitration/court cases, 17 WAB items/tender cases, 56 PE/RPE, 6679 pension & 237 other misc. cases referred by higher authorities have been processed.

5. PENSION CELL OF DDA

The Pension Cell deals with the cases of Pension, Family Pension and other retirement benefits, etc., as under:

- Calculation of pension in respect of retirees has been fully computerized. Software to work out pensionary benefits on the basis of recommendations of 7th CPC has been modified and is in operation.
- 100 % Computerized calculation of pensionary benefits, issuance of Computerized PPOs and bank advice have been achieved at HQ
- At Zonal Level around 100% computerization is in operation for pension.
- Revision of pension family pension in terms of OM dated 12.05.2017 is in progress. About 7000 cases have been reviewed and revised bank advices, wherever necessary, have been issued

8. LAND COSTING WING:

The important function of Land Costing wing includes fixing the yearly Pre-Determined Rates (PDRs) for allotment of residential plots/flats in developing/developed areas, fixation of damage charges, land rates for calculation of misuse charges, besides providing financial inputs for fixation of license fee in respect of petrol pumps and for the implementation of various policies formulated by the planning/management wing. The achievements for the financial year 2019-20 are as under:-

- Fixation of Pre-determined rates (PDRs) in respect of Narela, Rohini, and Plastic Bazaar-Tikri Kalan.
- Fixation of land rates for computation of Misuse Charges.
- Revision of rates for damage leviable under the Public Premises (Eviction of Unauthorized Occupants) Act, 1971.
- Fixation of charges for redevelopment of godown clusters in non-conforming areas for implementation of policy
- Revision of External Development Charges (EDC) leviable for Godowns/ Godown Clusters in Narela.
- Conversion fee for setting up of fuel stations on privately owned lands in National Capital Territory of Delhi.
- Rationalization of the rates of use conversion charges for shop-cum-residence plots/complexes/shop plots later designated as LSCs.



- viii. Rationalization of the rates for addl. ,FAR charges for CSCs/LSCs and shop-cum-residential plots/shops plots
- ix. Revision of rates of interest for belated payment of ground rent applicable in DDA in respect of allotment of flats, built up shops and plots.

9. HOUSING FINANCE WING:

The Housing Accounts wing is mainly concerned with the following activities with regard to allotment of flats/built up shops: -

1. Examination of Preliminary Estimates/Revised Preliminary Estimates for construction of flats/built up-shops for financial concurrence.
2. Fixation of Plinth Area Rate (PAR) to be applied for different categories of flats.
3. Individual cases for costing of flats are processed on the basis of approved PAR and PDR (Pre-Determined Rates) for land.
4. Maintenance of the accounts of receipts in respect of flats and built up shops and recovery thereof.

MAIN ACTIVITIES DURING THE YEAR 2019-20:-

A. Examination of Preliminary Estimates/Revised Preliminary Estimates

Financial concurrence of preliminary/revised preliminary estimates for construction of houses including internal development, electrification, firefighting and lift of DDA flats amounting to Rs. 768.80 crores was accorded during the year ending March, 2020.

B. Costing:

- i. Housing Finance Wing prepares and submits agenda for consideration of the Authority for approval of Plinth Area Rates to be adopted for working out the cost of flats under different categories.
- ii. Costing of 20,700 nos. of flats, 500 shops and 2130 scooter & car garages were finalized

C. Other Achievements

- i. All 110 cases received by the Housing Accounts Wing under RTI Act, 2005, were disposed of by giving replies to the public.

Vigilance Department

14.1 Vigilance department is responsible for implementation of anti-corruption measures and checks on integrity in service, as per the instructions issued by the Central Vigilance Commission, Department of Personnel & Training, Government of India and the Ministry of Housing and Urban Affairs from time to time.

14.2 In DDA, the Vigilance Department receives, scrutinizes and conducts in – depth investigation of complaints received from various sources and frames charge sheets in consultation with the CVC, wherever required. It also analyses inquiry reports and gives its comments for consideration of the disciplinary authorities. Further, appeals, review petitions, suspension and its review and regularization of suspension period are also dealt by it. Finally, Vigilance department suggests systemic improvements based on observations while examining complaints, etc., which helps in preventive vigilance.

5. SYSTEMIC IMPROVEMENT UNDERTAKEN/ PREVENTIVE VIGILANCE MEASURES:-

Consequent upon the CVC’s directions, DDA and its various offices located throughout Delhi observed Vigilance Awareness Week

from 28.10.2019 to 01.11.2019 with the theme “Integrity –A WAY OF LIFE”

15.3 Official Language Department

For effective implementation of Government of India's Official Language Policy, during the period 01.04.2019 to 31.03.2020, four meetings of Official Language Implementation Committee were organised. With the purpose to train employees in Hindi noting and drafting, 06 Hindi workshops were organized, through which training was imparted to 74 officers and 90 officials to work in Hindi.

In September, 2019 "Hindi Pakhvara" was organised in which Hindi debate, Hindi noting drafting, Hindi essay, Hindi general knowledge, Hindi sulekh and Hindi dictation competitions were organised and the winners

were awarded. 382 officers and officials participated in these competitions. During the "Hindi Pakhvara", Hindi workshop was also organised.

Besides the above, in compliance with the Government's Official Language Policy about 1430 pages were translated which included PAC paras, CAG Reports, Standing Committee Report, Annual Report of 2018-19, DDA's audit report, articles of "Vikas Varta", Training Department's booklet and matters pertaining to Standing Committee and Consultative Committee of Parliament . DDA's website content was also translated.

In addition to these forms, standard letters, notifications, press releases, tenders, advertisements, orders, circulars and establishment orders of various departments were also translated.

15.4 Public Relations Department

Public Relations Department of DDA is entrusted with activities relating to image building of the organization through paid and unpaid publicity and to maintain cordial interaction with public using various modes of communication. Its other major functions include formulation of advertisement policy, fixing of advertisement rates, empanelment of advertisement agencies and publication of monthly e-newsletter.

Besides, the department is also responsible for arranging press conferences, press trips, coverage of various functions, issue of press handouts, follow-up and monitoring of grievances expressed through newspapers and liaisoning with various departments.

Quality Assurance Cell

16.1 Delhi Development Authority is committed to provide quality products at reasonable cost to the public, keeping in mind the public is supreme and should be benefited. The quality is therefore drilled not only into activities of various serving sections of DDA but also the quality in engineering and horticulture wings for all construction and development works.

16.2 Quality of construction is supervised and monitored regularly by Junior Engineers, Assistant Engineers and Executive Engineers at field level and checked internally at the level of Superintending and Chief Engineers and externally at the level of Quality Assurance Cell of DDA by conducting periodical inspections of the works to ensure that the works are executed strictly in accordance with contract conditions, specifications and drawings.

16.3 The QA Cell, created in 1982, includes 9 Junior Engineers, 10 Assistant Engineers (8-Civil and 2-Elect.); 7 Executive Engineers (6-Civil and 1-Elect.), one Deputy Director(Hort.) and one Superintending Engineer. The Cell is headed by Chief Engineer. The Cell is playing a vital role in quality assurance, which oversees not only the quality of material and workmanship but also the quality of planning, designing, contract documents, specifications, etc., and issues necessary guidelines, circulars, etc., from time to time. In order to enforce the compliance of observations made by Third Party Quality Assurance Agencies, Circular No. 213 has been issued by QA Cell wherein it has also to monitor inspection reports of TPQA.

For major works a system of third party inspection has been introduced and agencies like CRRI, NCCBM, IIT, RITES, Sriram Institute for Industrial Research, etc., and private agencies have also been engaged as consultants. QAC is also associating itself with the third party while taking 10% of total samples of materials to be used on these works for conducting required tests to ensure quality of materials. Circular No. 223 has been issued for inspections and TPQA engagement.

16.4 Major projects are inspected by QA Cell at least twice, i.e., at foundation stage, super-structure stage and third time with the approval of Engineer Member, DDA or on receipt of any complaint. Due emphasis is given for maintenance of records on procedural, material and workmanship aspects which are duly examined

during quality audit. The deficiencies noticed, if any, are promptly brought to the notice of the concerned officer for suitable and effective administrative/contractual action and remedial measures and a close watch is kept on compliance of the observations. QAC is also being assigned special duties by the Works Advisory Board like carrying out inspection of materials manufactured at different factories for use in major projects of DDA and also to ensure proper recording of levels of earth work in roads works.

16.5 The specifications and technologies adopted are being reviewed regularly and suitably amended to meet the present requirement and environmental considerations. Use of new construction material, new techniques, such as prefab technology in housing projects, use of mix design/RMC, etc., have been encouraged. Control on time and cost over runs without compromising with the quality, functional requirements, aesthetics and structural soundness of the building is being effectively monitored.

16.6 DDA has been striving for continual improvement of services and quality of work. Interaction with the field staff is being conducted during various inspections for bringing out various suggestions for quality improvement. The QAC officers and other engineering staff are regularly sent for refresher courses/ training programmes being conducted for their skill upgradation.

16.7 Emphasis has also been laid to clear the long pending QAC paras and closure of the cases for which a drive was launched by QAC for the cases upto 31.3.2005. The paras having no financial implication were settled and several cases closed. As a result, a good number of cases have reached their conclusion stage. Efforts have been made to delegate the jurisdiction to Zonal Chief Engineers for satisfaction of procedural paras. The QAC has kept only those paras which have financial implications or involve specific technically vital issue. QAC has played an advisory role also indirectly to the field engineers during zonal review meetings and interaction among engineers during inspections.

16.8 Complaints as and when received through Vice Chairman, Engineer Member and Vigilance Cell are also being investigated through QA Unit and vigilance angle involved, if any, is taken care by Vigilance Cell.



16.9 Selection of material for works, collection of representative samples and their testing in reputed and reliable labs is of utmost importance. QA Cell has a well-equipped testing lab manned by two Assistant Engineers and two Junior Engineers located at Asian Games Village Complex. Testing facilities for various materials are available in this lab. Though day to day routine tests are conducted at site by the field staff, the random samples collected by QA team during their inspections are mostly tested in this QA Lab. In order to induce more confidence among the people at large, the present system of testing has been streamlined and revised guidelines issued. In this regard emphasis is laid on testing of at least 10% samples in outside labs.

16.10 DDA QAC has an IS/ISO 9001:2015 license. The Quality Assurance Cell has made concerted efforts to improve quality systems and complied with quality manual in line with Quality Management System of ISO-9001-2015 which emphasizes on organization profile, quality management, quality policy and objectives, quality management system, management responsibility,

resources management, service realization etc. DDA QA Cell got the IS/ISO 9001:2015 licence when all parameters envisaged were fully achieved and Bureau of Indian Standards was satisfied with the quality management system adopted in DDA. The Bureau of Indian Standards, granted Quality Management Systems Certification license CRO/QM/L-8002720.1 for IS/ISO 9001:2000 to DDA in March, 2007. The certification is reviewed every year and renewed after every three years. It was last renewed on 20.12.2019 and is valid upto 29.03.2022, BIS granted QMS Certification Licence CRO/QM/L – 8002720.4 from IS/ISO 9001:2008 to ISO 9001:2015.

16.11 A mobile application for e-measurement of work done was designed and developed in-house by QAC and Systems wings. The app was launched on 01.11.2015. Payments of all works and petty expenses are made through mobile app. The details of measurement of various items of work recorded by field divisions for payment to executing agencies are also being shared on public domain for transparency.
