Subject: Transfer & posting policy for JE's and AE's in Quality Assurance cell (QAC).

Transfer and posting policy for JE's and AE's in Quality Assurance Cell was modified vide office order no. PS/CE(QAC)/Policy/2010/346 dated 13.12.2010 issued by CE(QAC) with the approval of Vice-Chairman, DDA. It was decided that QAC shall not be treated as sensitive department & transfer and posting of JE's & AE's in QAC would be done by a sub-committee comprising of CE(QAC), CE(HQ) and SE(QAC). Tenure of such posting in QAC was decided to be 03 years.

A list of sensitive posts, identified for rotational transfer, has been circulated vide OM No. 7/5/2014-A VII dated 08.03.2017, issued by Dy. Chief Vig. Officer, MoUD and endorsed by Director (Vig.), DDA vide no. F1(62)2016/Vig./AVO(Admn.) Sen.P/2125 dated 29.03.2017. As per this OM, Quality Assurance Cell of DDA is to be treated as sensitive section for rotational transfers.

It is, therefore, decided that aforesaid office order no. PS/CE(QAC)/Policy/ 2010/346 dated 13.12.2010 may be treated as withdrawn with immediate effect. The policy regarding transfer and posting of JE's and AE's, circulated vide no. F7(16)/2000/P&C(P)/207 dated 08.06.2010 by Dy. Dir. (P&C) P with the approval of Competent Authority, shall be applicable for QAC also, with immediate effect.
