# I. WAB AGENDA of CE (Sports)

Name of Work: Development of Golf course at Sector-24, Dwarka, New

Delhi.

Sub-Head: Construction of Golf Course including Drainage, Bunkers,

Green tees, Grass Plantation, cart path, Lakes & irrigation

works etc. at Sector-24, Dwarka.

The case was presented by CE (Sports) before the Board with the recommendation for acceptance of lowest bid of L1 bidder i.e. M/s SGDC India Private Limited i.e. at their quoted amount of Rs. 45,54,35,979.63/- which is 31.33% below

the justified amount i.e. Rs. 66,32,69,614/- and 31.50% below the estimated cost i.e. Rs. 66,48,70,044/- as worked out by CE (Sports) for above work.

The A/A &E/S for "D/o Golf course at Sector-24, Dwarka, New Delhi" was accorded Vide No.EM.6(4)2017/Est./Pt./2096 dated 25.04.2017 for Rs. 7836.50 Lakhs i/c 3% contingencies and 11.25% departmental charges.

Board members raised some issues which was clarified by CE (Sports). The details are as under:

Sr. No.	Issues	Comments of CE(Projects)
1.	Why the 17.16 Acre land not considered below HT Lines.	CE (Sports) apprised the Board that due to the HT Line no building can be constructed on 17.16 Acre land so the area shown as "Area not considered in the revised design due to 400KVA HT Lines" in the Salient Features in PPT However, the land has been utilized to the extent possible while designing the play area of the Golf Course.
2.	What is the status of allied building works and other amenities?	

After due discussion & deliberation, Board agreed with the recommendation of CE (Sports Zone) and approved the lowest tender of M/s SGDC India Private Limited at their quoted amount of Rs. 45,54,35,979.63/- i.e. 31.33% below justified amount and

31.50% below the estimated cost for acceptance. Board instructed that CE (Sports) shall ensure that any deviation in agreement items, extra items / substitute items shall be dealt as per relevant Clauses of the Agreement. He shall also ensure fulfilment of all codal formalities before award of work.
