### ANNEXURE-1 ; TERMS OF REFERENCE

## 1) BACK GROUND

During one of senior officers meetings, it has been discussed that there is need to provide technical support to RWA of DDA developed colonies (New and Old) in order to guide RWAs and wherever required, to supplement their efforts in getting maintenance works executed under the supervision of RWAs in the form of providing a list of experience agencies to look after the respective residential complexes with experience in the areas of Housekeeping, Operation and Maintenance of their plant, equipment, installation, fitting & fixtures Accordingly DDA proposes to in the technically sound manner. empanel the service provider's agencies for providing services of electrician, plumber, lift operators security guard, conservancy staff, Mali etc. The agencies so empanelled shall have initial validity of three years which may be reviewed after depending upon their performance by DDA. RWA can also verify the past performance of such service provider from independent sources. Within the period of 3 years validity of panel, review of individual cases shall also be undertaken depending on any adverse performance reported by R.W.A.

### 2) **FUNDING OF MAINTENANCE OF COLONIES OF DDA**.

Funding for maintenance of colonies of DDA New or Old will be done by RWA's as per their requirement through the funds generated by RWA themselves. The EOI does not entail any commitment on the part of DDA to award or bear the cost of documents and DDA is not responsible for rates, contract amount and other condition deemed fit, signed between service provider & RWA's and any mutual dispute, thereof for redressal.

### 3) HOW TO PARTICIPATE.

i) Interested service provider, all enlisted contractors of DDA, CPWD, MES in Civil Class-V (Civil), Class-IV(Electrical), Class-III (Hort.) and Composite category, Reputed service providing agencies, Companies working in CPWD/other Central Government Complexes, private flats and societies can also apply. However they must submit their experience of working for last 3 years in the field with certificate of satisfactory performance from their respective clients, RWAs, Builders, EEs in-charge of Govt. organization concerned etc.

ii) The proposal shall include, a letter of intent (as per Appendix-1) on the letterhead of the responding agency. The letter of intent shall be duly signed and forwarded by the respective service provider.

iii) Proposal received from service provider must be completed in all respect with form and annexure filled and duly signed. Incomplete proposal shall be liable to be rejected.

## 4) <u>EVALUATION DOCUMENTS</u>.

- i) Performance of work submitted by the service provider for last three years completed/ in progress in CPWD Colonies, Societies, DDA colonies (New or Old).
- ii) Balance sheet certified by CA, for past 2 years at least.
- iii) List of works in hand Proforma.
- iv) Valid electric license in case of electrical work, registration of DJB for plumbing work, valid enlistment of DDA, CPWD & MES.
- v) The applicant should have sufficient T&P machinery, equipment and workshop as required for execution of work.
- vi) The applicant should have qualified technical staff for execution of work.
- vii) No fee will be charged from any of such provider for enlistment.


#### 6) <u>SELECTION PROCESS.</u>

- ii) If required, CRB can ask applicant to provide further documents, field visit as well as original versions of supporting documents included in the proposal for decision making purposes, which are to be made available within one week of such request being made.
- iii) Contractor Registration Board will upload the panel on ddawebsite.
- iv) No empanelled service provider has the right to claim being a Registered Contractor in DDA on the basis of such empanelment.
