Any breach of the condition by the contractor shall render them liable to be removed from the approved list of contractors in the Department.
- The agency/firm/contractor shall be required to deposit earnest money with each tender as per terms and conditions prescribed in the Notice inviting Tenders.

10. Security deposit will be recovered from his bills in accordance with the rules in force from time to time.
