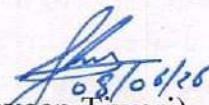

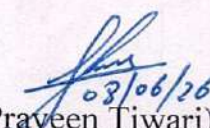

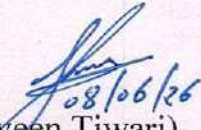

2. The agency/firm/contractor shall be eligible to submit tenders for **Building & Road Category** upto **Rs.40.00 Lakh (Rs. Forty lacs only)** in Delhi Development Authority(DDA).
3. The enlistment notified in this order is **valid for a period of 5 (Five) years from the date of issue of this order.** The contractor will be required to apply for revalidation of their enlistment in the prescribed form along with all required documents so as to reach the enlistment authority at least six months before the date of expiry of the enlistment failing which no renewal shall be done.
4. The agency/firm/contractor shall employ the required technical staff as per terms and conditions of each contract/agreement.
5. The agency/firm/contractor shall abide by the terms and conditions of the NIT/Contract/Agreement/enlistment rules as stand or as may be altered /modified from time to time.
6. The agency/firm/contractor shall not modify the existing partnership or enter into any fresh partnership without prior approval of the enlistment authority. Such proposal, if any, shall be submitted in advance giving full details of the intending partnership/sole proprietorship along with the draft partnership deed/affidavit and documents as required. Any change in status of the contractors as an individual or in constitution of the firm without prior approval of the enlistment authority will render the contractor/firm liable to be removed from approved list of contractors.
7. The agency/firm/contractor shall be issued tender on production of valid ITCC/STCC in the name and style in which they are registered bearing the name/names of sole proprietor/partners as notified in the enlistment order.
8. The agency/firm/contractor shall not be permitted to tender for works in DDA zone responsible for award and execution of contract in which their near relative is posted as Divisional Accountant or as an officer between the grade of Chief Engineer & Junior Engineer (both inclusive). They shall also intimate to the Department, the names of persons who are working with them and who are near relatives of any Gazetted/First Class Officer in DDA. Any breach of the condition by the contractor shall render them liable to be removed from the approved list of contractors in the Department.
9. The agency/firm/contractor shall be required to deposit earnest money with each tender as per terms and conditions prescribed in the Notice inviting Tenders.

10. Security deposit will be recovered from his bills in accordance with the rules in force from time to time.
11. The agency/firm/contractor is required to execute works of appropriate magnitudes required for revalidation as per rules for enlistment of contractor's in DDA. In case, they fail to complete/participate in the tender process of works of specified magnitude during the period of enlistment, the agency/firm/contractor is not liable to be revalidated.
12. The agency/firm/contractor shall also intimate the change in their address (registered/head office) if any, in future. In case, they fail to intimate such changes to DDA, their name shall be liable to be removed from the approved list of contractors.
13. The agency/firm/contractor shall be bound by the enlistment rules of DDA as amended from time to time.
14. The agency/firm/contractor shall be got registered under registration act of GNCTD after issue of enlistment order and a copy of same shall be deposited with Secretary, CRB as early as possible.
15. The agency/firm/contractor is required to deposit annual e-tendering fee as applicable payable to the CRB, DDA in form of online mode (i.e. UPI/NEFT/RTGS etc.) only in the **account of PAO(EW) DDA having A/C No. 1075843312 & IFSC Code: CBIN0281467**. An intimation letter on firm's letter head as per circular No. F.4(8)72/ Misc./2026/CRB/DDA/129 dated 19.02.2026 enclosing the payment proof addressed to "The Assistant Engineer, CRB, Ist Floor, Vikas Minar, DDA, New Delhi shall be submitted. **As per circular issued by competent authority vide F.4(8)72/Misc./2023/CRB/ DDA/e-file-66681/162 dated 24.04.2024 (available on DDA website)**, the e-tendering fee should be deposited separately for each category i.e. Building & Road, Electrical and Horticulture. The e-tendering fee so deposited is non-refundable.
