OFFICE ORDER No. 215/2025

Sub: Debarment for two years from e-procurement/e-tendering in DDA in respect of "M/s Raja Builders, House No. 112, Mangol Pur Khurd, Delhi-110083".

A complaint was made by Sh. Yudhvir Singh proprietor of "**M/s Raja Builders, House No. 112, Mangol Pur Khurd, Delhi-110083**" regarding the work "**Development of Park in Block-B, Sector-29, Rohini (N.O.W.: M/o Scheme under Nazul A/C-II, Rohini Zone)**" which was awarded to the agency. In his complaint Sh. Yudhvir Singh confessed that the agency M/s Raja Builders has not done any work and payment is made to him without any execution of work i.e alleging **fraudulent practices, corrupt conduct, and securing payment without actual work execution;**

Whereas, the site was investigated by the vigilance department based on the statement of Sh. Yudhvir Singh. The findings of vigilance department confirm that work is not executed on the site as per the estimate and bogus payments were made to the contractor, which clearly indicates that Sh. Yudhvir Singh is a person of doubtful integrity.

Accordingly, the matter was placed before the empowered committee on meeting held on 12.09.25, in which it was recommended to serve a show cause notice to the agency as per para no.13 of Rules for Enlistment of the Contractor's in DDA, 2022 to submit his reply within seven (7) days and opportunity was also provided to represent himself.

Whereas a **Show Cause Notice** was issued to the agency vide letter dated 29/09/25 and 07/11/25 respectively based on his confession of the contractor, **Sh. Yudhvir Singh** made to vigilance department on dated: 28.06.2024 that **no actual boundary wall work was executed** as assigned, and that the agency, through collusion, siphoned off public funds by securing payment for the non-executed work.

Whereas the Contractor's Registration Board (CRB), in its meeting held on **17.11.2025**, considered the matter of disciplinary action against the agency since no reply of show cause submitted by the contractor **Sh. Yudhvir Singh** and conclude that the agency and its proprietor are indulge in **fraudulent practices, corrupt conduct** and person of doubtful integrity which is in contravention to the Para no. 13.6(r) of the Rules for Enlistment of Contractors in DDA, 2022

Now therefore, I, **Amit Singh, Secretary (CRB), DDA**, after considering the grave nature of misconduct and the resolution passed by the CRB, hereby order that **M/s Raja Builders, House No. 112, Mangol Pur Khurd, Delhi-110083**, and its Proprietor **Sh. Yudhvir Singh** be **debarred for a period of two years with immediate effect.**

Accordingly, the said agency and its proprietor are hereby **debarred/suspended from participating in e-procurement/e-tendering for all category in DDA for a period of two years** from the date of issue of this order.
