In order to engage Third Party Quality Assurance (TPQA) Consultants for various works of DDA, a policy was framed and circulated vide this office letter of even no. 713 dated 05.03.2018 (copy enclosed). Para no. ii of this circular dated 05.03.2018 has been partially modified as under:

In case the above organizations are not available or refused to do the Third Party Quality control of the work then only TPQA may be engaged from reputed private organization by call of e-tender. For engaging the Consultants from reputed private organizations following criteria may be adopted which is in line with the CPWD Manual 2014 Appendix 20 (page 407). The Consultant should have satisfactory	TPQA work can be assigned to all IITs, all NITs, Central Building Research Institute (CBRI), NCCBM Ballabhgarh and other reputed Govt. Engg. Colleges of Delhi/NCR without call of tenders. In case the above organizations are not available or refuse to do the Third Party Quality control of the work then only TPQA may be engaged from reputed private organization by call of e-tender. For engaging the Consultants from reputed private organizations following criteria may be adopted which is in line with the CPWD Manual 2014 Appendix 20 (page 407). The Consultant should have
	completed the Third Party Quality Assurance for the similar type of project as mentined below during the last 7 years ending previous day of last date of submission of tneder/ quotations. TPQA for three similar completed works costing not less than the amount equal to 40% of the estimated cost put to tender. OR	satisfactorily completed the Third Party Quality Assurance for the similar type of project as mentined below during the last 7 years ending previous day of last date of submission of tneder/ quotations. TPQA for three similar completed works costing not less than the amount equal to 40% of the estimated cost put to tender.
	TPQA for two similar completed works, costing not less than the amount equal to 60% of the estimated cost put to tender. The fees for consultancy for TPQA to these institutaions/organizations shall be made by DDA with the approval of VC/DDA.

It is, therefore, enjoined upon all the Chief Engineers that the policy circulated vide letter dated 05.03.2018 along with modification as mentioned above, be implemented meticulously for engagement of TPQA Consultants for various works of DDA.
