4. Identification slip of three specimen signatures and three photographs giving the name of allottee duly attested by Gazetted Officer both of husband and wife separately.
5. Latest attested copy of Ration Card/Voter I.Card/Passport/Driving Licence/Aadhaar Card duly attested by Gazetted Officer as proof of Identity.
6. Ownership proof i.e. copy of latest Electricity Bill, Water Bill, House Tax Bill of the addressee's residence (in case of residence of Delhi/New Delhi/Delhi Cantt.) duly attested by Gazetted Officer.
7. Pass Book of the Bank Account of the Allottee.
