OFFICE ORDER

From time to time, the delegation of powers has already been made in the Land Disposal Department at various levels. However, with a view to cut delays and improve further the overall efficiency in disposal, the powers, as indicated below are further delegated to the officers of the Land Disposal Department in partial modification of circular No.F.100(118)88-CL dated 13.2.1989:

All the above mentioned officers shall exercise the powers of the Authority, to the extent this has been delegated above to them, respectively subject to the overall control and superintendence of the Vice-Chairman, DDA.

- i) The power for grant of extension of time for construction shall be exercisable subject to the payment of the composition fee and such other conditions, as prescribed by the competent authority from time to time.
- ii) Fixation of draw of lots shall be done subject to the compliance of the codified formalities.
- iii) Reconstruction of file; be allowed by the competent authority after all efforts to trace the same have failed and the circumstances are not such which may warrant any foul play. But responsibility for misplacement of file shall be fixed by Director and the guilty must be punished.
- iv) Refund be allowed only after ensuring that the person concerned is entitled to the claim.
- v) Regularisation of excess area of the plot within the permissible limit of 15% be allowed subject to recovery of the proportionate cost at the rates prescribed by the Authority.
- vi) The extension of time for payment of the premium should not be granted as a matter of routine, but should be granted if the circumstances of a case warrant so, on compassionate grounds or such other grounds as may result in injustice, if not allowed subject to payment of interest etc., as prescribed.
