Sub: Filling up 01 post of Fire Officer (Level-7 in the Pay Matrix as per 7<sup>th</sup> CPC) in DDA on deputation basis.

DDA invites application for filling up one post of Fire Officer in the Pay Band-2, Rs. 9300-34800/-with grade pay of Rs. 4600/-(Pre-revised) (Level - 7 in the Pay Matrix as per 7<sup>th</sup> CPC) by way of deputation. The deputation shall be initially for a period of one year extendable upto three years on the basis of satisfactory performance on year to year basis and will be governed by the normal terms and conditions as prescribed by the Department of Personnel & Training.

The officers dealing with Fire Fighting under the Central/State Govt./Public undertakings/Semi Govt. Autonomous or Statutory Organizations and possessing the following qualifications shall be eligible for deputation:-

(i) Holding analogous posts; or

(ii) Junior Commissioned Officer with 8 years of service of Security Management/Fire

Fighting duties; or

(iii) Officers from Police/Industrial Security Force/Public Sector Undertaking/ Autonomous Bodies (under Govt.) in the rank of Inspector or equivalent with 5 years of regular service. Preference will be given to the candidates possessing experience of Fire Fighting duties in supervisory capacity.

### **General Conditions:**

- (i) Candidates should apply through Cadre Controlling Authority in the parent department in the proforma prescribed by DOP&T vide OM No. F. No AB. 14017/28/2014- Estt. (RR) dated 02.07.2015 along with relevant documents. The Cadre Controlling Authority should also fill up "Certification by the Employer/Cadre Controlling Authority" invariably which is a part of prescribed application format.
- (ii) The application in the prescribed proforma should be forwarded by the concerned Cadre Controlling Authority certifying that the details furnished by the candidate are correct.

(iii) The applications received after the last date of receipt shall not be entertained under any circumstances.

- (iv) The period of deputation shall be initially for one year extendable up to three years on year to year basis, which may, however, be terminated at any time before completion of period/extended period at the discretion of the Delhi Development Authority.
- (v) The Pay and allowances and other conditions of deputation of the officers selected on deputation shall be regulated in accordance with the Department of Personnel & Training's OM No. 6/8/2009-Estt. (Pay-II) dated 17.06.2010 and as amended from to time.
- (vi) The APARs for the last five years duly certified by the Group 'A' Officer in the parent department along with latest vigilance clearance report indicating the pending and settled disciplinary/criminal cases and the details of penalties imposed, if any, should also be furnished.
- (vii) The level of responsibilities and duties of cadre post of the applicants should be comparable to the duties and responsibilities of the ex-cadre post.

Eligible and willing officers should submit their applications on plain paper duly signed, through Proper Channel, in the prescribed format along with last 05 years ACR dossiers and VCR, accompanied with attested copies of certificates and two passport size photographs duly attested from the Appropriate Authority. The applications, complete in all respect, should reach Dy. Director (Personnel)-I, Delhi Development Authority, B-311, Vikas Sadan, INA, New Delhi-110023 by 30.08.2019. Incomplete applications shall not be considered and will be summarily rejected.
