Instructions for Candidates: -

1. The work of the Consultant Doctor will involve providing OPD service at the clinics at Vikas Sadan and Vikas Minar on part time basis in either of the following shifts:-

Consultant Doctor (MBBS)	From 10:00AM to 2:00 PM From 2:00 PM to 6:00 PM
Consultant Doctor (BHMS)Homeopathy	Two Hours for four days in a week i.e. Two days in Vikas Sadan Two days in Vikas Minar

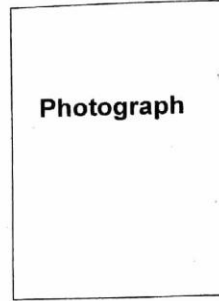
2. The applicant for the post of Consult Doctor (MBBS) would be required to indicate the shift for which he/she will offer his/her service. However, services of the Consultant Doctor can be utilised at any location or any shift by DDA.
3. The Consultant Doctor (MBBS) would be entitled to the payment of Rs.50000/- and *(an amount will also be proportionately deducted in case of absence)* per month for 4 hours shift, in a day and 5 days in a week.
4. The Consultant Doctor (BHMS) Homeopathy would be entitled to the payment of Rs.25000/- per month+Rs.5000/- per month for providing medicines to patients *(An amount will also be proportionately deducted in case of absence)* per month for 2 hours shift, in a day and 4 days in a week.

5. In case of Consultant Doctor (MBBS) emergency medicines will be made available by DDA while any other medicines as per prescription will be required to be purchased by the patient as his/her OPD treatment.
6. The posts are temporary and engagement is purely on contractual basis initially for a period of 06 months which may be extended further depending upon the requirement and satisfactory performance and will confer no right to the candidates for permanent employment against the said posts.
7. Candidates are requested to bring duly filled in Application form (in prescribed format), 02 passport size photographs and all original documents along with one set of self-attested photocopies of the documents in support of the educational qualification and experience, if any, on the date of interview.
8. The candidates are advised to report for walk-in-interview on **10.10.2018** latest by **10:00 AM** at **Commissioner (Personnel)'s Office, DDA, Block E-1, Ground Floor, Vikas Sadan, New Delhi- 110023** Delhi Development Authority, Vikas Sadan, New Delhi-110023, failing which they will not be allowed to appear for interview under any circumstances.
9. The criteria for selection shall include the marks obtained by the candidate in the required essential qualifications for the post, relevant experience along with the marks obtained in interview.
