Sohan Lal**, if he had already been granted benefit of financial upgradation under ACP Scheme in the Pay Band of Rs.9300-34800/- with Grade Pay of Rs. 4800/- (6<sup>th</sup> CPC), if not granted, his pay will be fixed under FR 22(I)(a)(1). He may exercise his option for fixation of pay under the provision of FR 22(I)(a)(1) within 30 days from the date of issue of this order.
