**G.S.R. \_\_\_\_\_** - In exercise of the powers conferred by clause (d) of Sub-section (2) of Section 56 of the Delhi Development Act, 1957 (61 of 1957). The Central Government, after consultation with the Delhi Development Authority, hereby makes the following rules regulating the method of recruitment to the post of **Architectural Assistant, Assistant Director (Architecture), Deputy Director (Architecture), Senior Architect, Additional Chief Architect and Chief Architect** in Delhi Development Authority in supersession of GSR No. dated : namely:-

**1. Short title and commencement.** - (i) These rules may be called the Delhi Development Authority **Architectural Assistant, Assistant Director (Architecture), Deputy Director (Architecture), Senior Architect, Additional Chief Architect and Chief Architect** posts Recruitment Rules, 2026.

(ii) They shall come into force on the date of its publication in the Official Gazette.

**2. Number of Post, classification, level in the pay matrix.** - The number of posts, their classification, level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.

**3. Method of Recruitment, age limit, qualifications, etc:** - The method of recruitment, age limit, qualification and other matters relating thereto shall be as specified in columns (5) to (13) of the Schedule.

**4. Disqualification-No person-**

- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) Who having a spouse living, had entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Competent Authority may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for doing so, exempt any person from the operation of these regulations.

**5. Power to relax.** – Where the Chairman, DDA is of the opinion that it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these regulations with respect to any class or category of persons.

**6. Savings.** - Nothing in these regulations shall affect reservations, relaxation of age limit and other concessions required to be provided for the Schedule Castes, the Scheduled Tribes, other backward classes, Ex-serviceman and other special categories of persons in accordance with the orders issued by the Central Govt. from time to time in this regard.
