G.S.R _____ - In exercise of the power conferred by Section 57 of the Delhi Development Act, 1957 (61 of 1957) read with the Sub-Rule (4) of rule 3 of the Delhi Development (Miscellaneous) Rules, 1959, the Central Government, after consultation with the Delhi Development Authority and in supersession of the Recruitment Regulation notified vide notification No. GSR No. 706 (E) dated 07.10.1999 and its corrigendum No. GSR 50 (E) dated 13.01.2000 and notification No. GSR 681 (E) dated 22.11.2005, GSR.685 (E) dated 15.09.2011, hereby makes the following Rules regulating the method of recruitment to the post of **Commissioner (Landscape), Director (Landscape), Deputy Director (Landscape), Assistant Director (Landscape), Architectural Assistant (Landscape)** in Delhi Development Authority as under:-

1. Short title and commencement.- (1) These rules may be called the Delhi Development Authority **Commissioner (Landscape), Director (Landscape), Deputy Director (Landscape), Assistant Director (Landscape) Architectural Assistant (Landscape)** Post Recruitment Rules, 2026.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Number of Post, classification, level in the pay matrix.- The number of posts, their classification, level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the said Schedule annexed to these rules.

3. Method of Recruitment, age limit, qualification, etc.- The method of recruitment, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (12) of the Schedule.

4. Disqualification-No person,-

- (a) Who has entered into or contracted a marriage with a person having a spouse living; or
- (b) Who having a spouse living, had entered into or contracted a marriage with any person, shall be eligible for appointment to the said post;

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for doing so, exempt any person from the operation of this rule.

5. Power to relax. – Where the Chairman, DDA is of the opinion that it is necessary or expedient to do so, it may, by an order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect of any class or category or persons.

6. Savings:- Nothing in these Rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the other Backward Classes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
