The sanctioned strength of SO (Hort.) is 187. Direct recruitment is 75% of 187=140 and rest 25% i.e. 47 seats are for promotion. As per the RRs, the promotion quota seats have to be filled by promotion failing which by Director Recruitment. As there is no promotion in near future from the feeder cadre, therefore, a proposal to fill up the promotional vacancies of SO (Hort.) by Direct Recruitment is under consideration with the Competent Authority. Hence, 47 promotional vacancies have been considered under Direct Recruitment and hence mentioned in DR quota above.
