

3. No financial benefit shall be allowed to Smt. Varsha Jain Sharma, if she had already been granted benefit of financial upgradation under ACP/MACP Scheme in the Pay Band of Rs. 9300-34800/- with Grade Pay of Rs. 4600/- (6<sup>th</sup> CPC), if not granted, her pay will be fixed under FR 22(I)(a)(1). She may exercise her option for fixation of pay under the provision of FR 22(I)(a)(1) within 30 days from the date of issue of this order.

4. This promotion is provisional and subject to the outcome of pending Contempt Petition No. 314/2016 and SLP (C) No. 4831/2012 before Hon'ble Supreme Court.

5. The promotion shall be on probation for a period of 02 years. All the terms and conditions related to probation will also apply.

6. Consequent upon her promotion to the post of Assistant Section Officer, the Competent Authority has directed to submit her joining report to Dy. Director (PB)-3 for further posting.


