## LAND POOLING PORTAL RE OPENS: INVITING EXPRESSION OF WILLINGNESS TO PARTICIPATE TILL 14.11.2020

The Land Policy is a new paradigm for expanding the urban development of Delhi wherein the private sector is going to play active role in assembling land and develop physical and social infrastructure. Under the Land Policy, the landowners/group of landowners will pool the land parcels for the development as per the prescribed norms and guidelines, making them the partners in the development process. It is expected that the planned development will increase the value of land in a sector through provision of infrastructure and public facilities.

The Land Policy was notified on 11.10.2018 and the DDA's Land Pooling Web-Portal was launched on 05.02.2019. There has been an overwhelming response from land owners for participating in the Land pooling scheme and so far 6575 Ha of land has been pooled for partnering in development process. Few sectors are nearing the eligibility criteria for the next step of making an application to DDA as Consortium for further taking up the development of the sector.

The window for registration of land under the Land Policy is opened again for the land owners who had earlier missed the opportunity and get associated in the city development and enhancement of value of their land. The DDA's web-portal will be opened for all the land pooling villages falling in the urban extension areas of the city (Zone J, K-I, L, N & P-II) from 19.09.2020 to 14.11.2020.

## MPD-2041: ONLINE PUBLIC CONSULTATION MEETING WITH RESIDENTS AND RWAS FROM UNAUTHORISED COLONIES IN DELHI

Delhi Development Authority (DDA) and National Institute of Urban Affairs (NIUA), organised a day-long public consultation with residents and RWAs of unauthorised colonies of Delhi on 02.09.2020. The meeting was held on WebEx online platform in three batches from 11.00 a. m. onwards. Around 120 people and RWAs registered through e-mail and the meetings were attended by senior officers of DDA and NIUA.

The meetings were chaired by Ms. Leenu Sehgal, Commissioner (Planning), and Sh. Neeraj Bharti, Commisioner (Land Pooling) from DDA. The officers shared details of the PM-UDAY Scheme and the application process to be followed by property owners in unauthorised colonies of Delhi. The participants were requested to share their suggestions towards the registration process as well as give ideas towards area improvement and redevelopment of unauthorised colonies.

The concerns highlighted by participants were mainly about lack of access to basic services of water and sanitation and other facilities in their locality. Other issues raised by the participants included legality of their properties, narrow access roads, congestion, conflicts between commercial and residential uses, quality of drinking water, water logging etc. A common concern expressed by most participants was regarding the vulnerability and risks related to disasters such as fire, earthquakes etc. All the participants expressed their readiness to cooperate with the government agencies to improvise and regularise their colonies. They appreciated DDA's initiative to seek people's views and understand their issues at the stage of preparation of MPD 2041.

### MPD-2041: ONLINE PUBLIC CONSULTATION WITH YOUTH IN DELHI

Delhi Development Authority (DDA) is preparing the Master Plan of Delhi- 2041 (MPD-2041) with the support of the National Institute of Urban Affairs (NIUA). As part of the process, a series of discussions and consultations have been carried out with various stakeholders/RWAs and civil society groups to seek inputs from the people of Delhi that will help drive the agenda for the Master Plan. Young citizens, who constitute a sizeable proportion od Delhi's population are important stakeholders in the development of the city. To get insights from the youth of Delhi, a series of Youth Sabhas are being organised. The objective of these meetings is to understand the issues faced by the youth (aged between 18-30 years) in the city and discuss possible planning solutions.



### MPD 2041: YOUTH SABHA MEETING ON 'DELHI AS A CITY OF LEARNING'

Delhi Development Authority (DDA) and National Institute of Urban Affairs (NIUA), organised a public Online Youth Sabha with the Youth of Delhi aged 15 to 30 years of age on 24.09.2020. Approximately 805 participants registered for the entire youth event and 450 participated in the first Youth Sabha, through an online registration form. The meeting was attended by senior officers from DDA and NIUA, along with the facilitators from the supporting organization- PRIA and IGSSS.

The objective of this consultation was to take the views from the youth of Delhi, what more can be provided to existing facilities to ensure quality education and living that is accessible to all. The dialogue aimed to focus on the access to associated amenities like housing, connectivity to institutions etc. To capture the kind of skills young people, want to the consultation aimed at capturing the skills of the young aspirants and facilitate employability across all sections of the society.

One of the primary concerns for most of the youth was the lack of institutions that could help them acquire gainful employment within Delhi. They are of the opinion that even if they do somehow educate themselves in reasonably good schools/ colleges and perform to the best of their abilities, they don't necessarily get employed. There was a need felt for equitably distributed skill enhancement institutions that would help them hone their employability skills and make them ready for the job market. The gap between job seekers and actual availablility of intead of available jobs is vast and some concrete steps need to be taken to bridge that gap, in order to prevent the youth from taking up antisocial activities to sustain themselves in the city. Such centres not only need to motivate and condition the youth, but also show them the right direction to focus their energies into.

There is a need for motivational and higher education oriented classes that need to be conducted from the middle school onwards, so that the children are not aimless when they pass out from schools, instead they know the way forward in their respective lives. Children are primarily looking for eductional reforms, a transtion from traditional education to professional eduction.

Lack of proper housing for students/ youth was expressed by most of the youth on this forum. They elaborated on how good housing was unaffordable and unsafe and the ones that they could afford (near the institution) were plagued with antisocial elements. This has made it impossible for students to find a suitable place to live and study. This was cited by civil services aspirants living in areas such as Mukherjee Nagar. There is no upper limit on the number of students lodged in a single room at a PG, no proper facilities within them as well. Seeing the apathy, it makes it doubly tough for female aspirants to stay in these areas. They also felt that such uncomfortable and negative environment the breeds suicidal tendency among aspirants who end up being social out castes.

The lack of accessible educational institutions for some city residents is of grave concern. For some of the youth, there are no colleges for up to 10 km.

radius. Metro and buses aren't affordable for them on a daily basis to perform this commute as well. Lack of libraries in most of the districts also hampers fresh graduates students, especially girls as they are not able to travel long distances because of societal pressures. Need for Neighbour hood level community/ libraries, skill such amenities as employment development centres, expressed assistant centres was unanimously. Another valid point made by the was is that online







classes are not as well received as they should be. With illiteracy among parents, low income, non-availability of smart devices, one cannot expect a student to navigate through an online class hub where less fortunate students are encouraged to come and gain knowledge.

Accessibility to social infrastructure such as schools, colleges was another concern that was shared by most of the youth participants. A youth from Najafgarh mentioned how the nearest college is 25 kms away, taking travel time of 1 hour one way to traverse that distance. Others also mentioned that most of the youth staying in the peripheral areas of Delhi end up travelling 25-40 kms one way to reach their schools/ colleges. This is not only time consuming, but also unsafe for young women as they don't always get to travel by appropriate means of commute. It is only recently that Delhi Metro's grey line is operational, which helps them to commute to other parts of Delhi, but due to COVID-19 that too was stopped for several months. In short, accessibility to these education imparting institutions has become very cumbersome, pushing the youth to drop out well before completing their courses.


The youth feel there should be an agency that deals with their mental, physical health and their status of employment post school/ college graduation. An agency that physically or remotely monitors their growth as an individual to make sure they don't fall prey to vices. According to them, after completing their academic courses, they lack goal, motivation and guidance of how to proceed while seeking gainful employment. A pressing issue for the youth is the non-availability of seats for average performing students in Delhi colleges. According to them, only 2-3 per cent are able to score high enough to clear entrance exams or qualify for seats in renowned institutes in Delhi. Their concern was for the remainder average (above and below) performing youth who then are unable to secure a seat in a decent institution within Delhi and thus remain in limbo.





Not all youth have the money nor the opportunity to go out of Delhi to study. Most of them then settle for the option of enrolling in open universities and working side by side to sustain their home/ family. Finally, all the participants were encouraged to fill a two part survey proforma which would enable them to put in words their expectations from the upcoming Master Plan for Delhi 2041 and what according to them should be the core areas for policy making that they associate with, the most.

Every youth that was a part of the forum was extremely delighted to be a part of this Youth Sabha and were more than elated that finally there was a platform for them to express their opinions, needs and desires. The youth expressed their itching need to be involved in more city/community/ neighbourhood level activities, they were longing for responsibility in helping Delhi become an inclusive, resilient and future-ready city.

The 52<sup>nd</sup> meeting of STF was held on 11.09.2020 wherein officers from all the local bodies and other concerned agencies were present. The progress of the complaints received upto 31<sup>st</sup> August was reviewed. In total 57,459 complaints have been received in STF till 31st August 2020 and action on 51,989 complaints has been initiated. 2039 ATR were received during the period from 16.08.2020 to 31.08.2020.

ULBs have taken extensive action on removal of encroachments along the roadside and footpaths. In total approximately 297 km road length has been cleared by ULBs between 16th August and 31st August 2020. North DMC has cleared 74.3 km and SDMC has cleared 87.2 km. EDMC has cleared 113.2 km and NDMC has cleared 23 km.

Temporary structures have been removed by NDMC from road stretches in various places including Connaught Place, Gole market, Janpath and Safdarjung. Temporary structures have been removed by SDMC from road stretches in various places including Azad Apartment in Hauz Khas, Saidulazaib and RK Puram, Munirka.

In case of unauthorised constructions on public land and in violation of Master Plan and Building Bye Laws, show causes notices have been issued and sealing was carried out. EDMC reported that demolition was executed in certain properties of Laxmi Nagar, New Ashok Nagar, Jaipur Bhawan, Guru Ram Das Nagari and Mandawali Extn. Properties were sealed at Ganesh Nagar and Timber Market Dallupura.

SDMC has also taken demolition program on unauthorised construction in AG-1, Vikas Puri. Adequate surveillance is being maintained for any illegal and unauthorised construction in Govt. Land on Yamuna Flood Plain. Since 01.01.2019 280 properties were booked, 198 sealing orders were passed; Demolition action is being executed with the assistance of Police Force.

Chairman, STF re-iterated that close co-ordinated efforts needs to be continued by the ULBs & Govt. Agencies to take actions for removal of encroachment in accordance with the law. Jt. CP, Traffic Police assured that all support shall be provided to remove the encroachment from roads and take action on unauthorized construction effectively.





The 53<sup>rd</sup> meeting of STF was held on 25.09.2020 wherein officers from all the local bodies and other concerned agencies were present. The progress of the complaints received up to 15<sup>th</sup> September was reviewed.

In total 59,484 complaints have been received in STF till 15<sup>th</sup> September 2020 and action on 53,721 complaints has been initiated. 1732 ATR were received during the period from 01.09.2020 to 15.09.2020.

There is a pendency of 5763. Chairman, STF directed the ULBs to take the matter seriously and expedite the action on the pending cases. DDA has carried out removal of encroachment in the flood plain at Madanpur Khadar on 15.9.2020 and repossessed about 30 Acres land. The encroachment at Azadpur Subzi mandi Transport Centre has been cleared on 10.9.2020.

Demolition of Unauthorized construction has been carried out at various locations in Burari by Revenue Department. Temporary structures have been removed by NDMC in their anti-encroachment drive from road stretches at Khan Market, Lodhi Road, Sarojini Nagar and Chanakyapuri, Gole market, Janpath, Shanker Market and Regal Rivoli and Safdarjung.

Temporary structures have been removed by SDMC from road stretches in various locations at R.K.Puram, Malviya Nagar, Vasant Vihar, Vasant kunj, Munirka and Yusuf Sarai market. Unauthorized encroachment has been removed by North DMC from various road stretches and demolition actions were taken at Burari, Wazirabad, Pitampura and Rohini areas along with sealing actions at Burari.

About 425 sqm of area of 66 futa PWD road was cleared by NorthDMC in the joint encroachment removal programme on 23.09.2020, at village Siraspur. Anti-encroachment drives have also been initiated on approximately 232 km road length by ULBs between 1stSeptember and 15<sup>th</sup> September 2020. North DMC has cleared 60 km and SDMC has cleared 102.7 km. EDMC has cleared 44km and NDMC has cleared 25.3 km.

Chairman, STF re-iterated that close co-ordinated efforts needs to be continued by the ULBs & Govt. Agencies to take actions for removal of encroachment in accordance with the law. Jt. CP, Traffic Police assured that all support shall be provided to remove the encroachment from roads and take action on unauthorized construction effectively.

## DDA ENGAGES COMMON SERVICES CENTRES (CSC) FOR PM-UDAY SCHEME

Delhi Development Authority has activated the Common Service Centres (CSC) in its efforts towards providing more and better services to the residents of unauthorised colonies for filing their applications for grant of ownership rights.

Four DDA Processing Centres have been operational for the scheme, viz., Pitampura, Dwarka, Hauz-Khas and Lakshmi Nagar. A new processing Centre at Rohini has now been made operational. Three new processing Centres, at Pitampura, Dwarka and Lakshmi Nagar will be made operational in the next 15 days to speed up the process.

So far 26,705 applicants have filed applications on DDA's online portal, and 1348 residents have been issued the ownership rights. In 11188 cases, GIS survey work has been done and 4131 applicants have been issued online deficiencies, to which they can file online replies. A total of 1342 applications have been rejected for not conforming to PM-UDAY regulations.

In addition to DDA's 28 help desks, residents of unauthorised colonies in Delhi can now also walk into their nearest Common Services Centres (CSC) to apply for ownership rights to their property, or to file replies to the Deficiency Memos issued. Necessary training to the CSC personnel has been provided by DDA to enable them to effectively support the citizens in availing the benefits of the scheme. Almost 1400 Common Service Centres (CSCs) have been integrated by the DDA with PM-UDAY scheme. The locations of the helpdesks and CSCs are available on DDA's website for information of the public.

Although the residents can register on the portal by themselves, CSC can also help the resident to register under the scheme. Once registered, the CSC will provide the printout of the Acknowledgement Receipt to the resident.

The receipt will contain the unique Registration Number and details of the Empanelled GIS Agencies for fixing geo-coordinates of the property. Once the empanelled GIS Agency visits the property and uploads the geo-coordinates on the DDA portal, the resident will receive a unique "GIS ID" on the registered mobile number and e-mail ID.

The resident can then fill the detailed application form through PM-UDAY portal. Along with the filling of the form, the scanned copies of documents like the General Power of Attorney (GPA), Sale Deed, Will, Payment Receipt, Proof of Construction, Electricity Bill, Property Tax Mutation, Affidavits, etc. will also be uploaded. Once the form is submitted and payment made, the CSC will provide a printout of the final submitted application with the Unique Case ID to the resident. This service can also be availed by visiting the CSC or DDA helpdesk for filing the application form.

In case any Deficiency memo is issued by the DDA, intimation for the same will be received by the applicant through sms and e-mail. The Applicant can then again login to the DDA portal, or visit the nearest CSC or DDA helpdesk and file online reply / upload additional documents to meet the DDA's observations in the Deficiency Memo.

DDA survey team thereafter visits the site to verify the details submitted by the applicant. Once everything is verified, the Authority will intimate the charges to be paid (through portal & mail) and activate the payment link through which online payment can be made by the applicant. After the payment is made, the concerned Authority fixes the date on which the applicant has to visit the processing centre with original documents where original documents are verified, and the Conveyance deed or Authorisation slip is executed on the same day.







### WATER BILL PAYMENT MADE ONLINE

For the benefit of public and to promote digital payment, Delhi Development Authority has fully automated the process of payment of water bills. Now, public availing DDA's water services can deposit their bills online.

Maximum number of public availing DDA's services are from Dwarka and Rohini and so this process will benefit them the most. The bills are uploaded by DDA in the system periodically and the general public can print the copy of water bills also from the same. For making online payment, a customer may have account in any bank. Online payment of water bill can be made through debit card, credit card and net banking etc.

Besides, the water bills can also be paid through Bharat Bill Pay system as well. The URL of water bill system is https://online.dda.org.in/waterbill online and Its link also exists on DDA's website www.dda.org.in Online system is one of the priority areas of Vice Chairman DDA Shri Anurag Jain so that public can avail the benefits of various services offered by DDA from the comfort of their homes. The water bill payment system has been developed in-house by DDA.
