The case has been examined by LM Deptt of DDA and CLM DDA has suggested to place the case in the STF meeting. Meanwhile the complaint from sh. Mehra has been forwarded to DDA by Central Vigilance Commission. The area falls under jurisdiction of North MCD
- ii. A three member committee comprising Ms Manju Paul, Addl. Comm.(Plg)I, SE, SDMC, Mr. Rajeev Shukla, Director, LM was constituted to examine the complaint of Dr. Manjula Krippendorf . **16. Web portal issue:** The discrepancy between the count of pendency and ATR in Mobile Apps and web portal still continues giving wrong reports. The complaints marked as resolved in the mobile apps is still reflecting as pending in web portal. Further, few complaints resolved by DDA is shown as pending in SDMC account. The cases have been informed to System Deptt. DDA repeatedly which needs to be resolved urgently.
