Sub: Minutes of 45th meeting of the Special Task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions of MPD-2021.

The 45th meeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 27.02.2020. List of the officers attended the meeting, is annexed.

During the meeting, the following were deliberated and decided: -

1. Since no observations were received from the members, the minutes of the 44th meeting of STF were confirmed.

2. The status report on removal of encroachment on roads as per the monthly

The above report is for the period of 15 days. Chairman (STF), pointed out that the achievement made by the ULBs during last 15 days are very less and directed ULBs to adhere to the achievements of the targets assigned to them during the next 15 days. PWD was again directed to take action on the target fixed by STF and removal of encroachments from major traffic corridors.

3. Regular Monitored Case: Removal of encroachment on govt. land in number of residential colonies in cases where land has been encroached by the owners of ground floor on the areas meant for Tot lots / parking / open space. EDMC has started the work to provide access to the public to these tot lots. As informed by EDMC, on 15.01.2020, the brick work has been completed in 30 Tot-lots on which iron grills shall be fixed. Iron grills have been fixed 10 tot lots. The work will be completed in 2 months time.

Agency, 32 updated ATR are awaited and 20 cases are pending in which no Action Taken Report (ATR) have been submitted till date. The ULBs and Govt Agencies were directed to take action on these cases which have been heard by Chairman, STF.

- 8. ATR on the orders of Hon'ble High Court: 555 Hon'ble court orders received in STF have been forwarded to concerned ULBs and Govt. agencies and uploaded on the STF portal. ATR on 431 complaints in excel format have been forwarded to the ULBs / govt. agencies to provide latest status of the case one month ago. Nodal/Grid officers were directed to review the court matters seriously and take action based on the content of writ petition/court direction.
- 9. ATR on Complaints forwarded by the Monitoring Committee: 1373 complaints have already been forwarded to the ULBs/Govt. Agencies and uploaded on the STF portal. ATR on 1047 complaints have been uploaded on the web portal and the pendency is 23.74%. Chairman, STF pointed out that the pendency in disposal of Monitoring Committee complaints is highest in North DMC followed by DDA and SDMC. This requires review by HODs to reduce the pendency. All concerned agencies to take action on pending cases expeditiously.
- 10.ATR on the Complaints more than 6 months old: At present 1625 complaints received from hard copy are pending for more than 6 months. Chairman, STF directed that action on pending complaints be taken at the earliest and the ATR be uploaded the same on the web-portal.
- 11.ATR on the Complaints regarding On-going unauthorized construction: The action on ongoing unauthorized construction has not been taken seriously by the local bodies. Again, and again it has been reiterated in the meeting that zero tolerance to be adopted in these cases which has not been maintained by ULBs. ATR with property detail and photograph to be submitted and uploaded. It was directed that CE(Design) to hold meeting with Nodal and Grid officers of DDA to review the pendency related to DDA. I
- 12.ATR on the Complaints against Erring Officials/Officers: Till 15th February 2020, 645 complaints against Erring Officials / Officers have been forwarded to STF out of which ATR on the U/C have been uploaded on 503 complaints. Chairman STF sought a report on the action taken by the ULBs and Govt Agencies on the matter related to the complaints filed against the erring officials in the next meeting.
