

Split up of ATR







Age wise analysis of pendency




6 months old pendency-ULB wise split up





A total of 6716 properties were sealed so far. 2224 applications have been received for de-sealing properties. During the fortnight no property was sealed, no application for de-sealing was received and no de-sealing case has been approved by Monitoring Committee. All ULBs and Govt agencies to submit the status of de-sealing of properties, sealed at the instance of Monitoring Committee, after the Hon'ble Supreme Court order dated 14.8.2020.

7. Regular Monitored Case: Removal of encroachment on govt. land by the owners of ground floor on the areas meant for Tot lots / parking / open space: EDMC has informed that as per the court direction, gates are remodelled with ramps to provide access to differently abled persons. In the court matter WP(C) no 14004/2019 A.K.Roy & Others vs Union of India and others, Hon'ble High Court vide order dated 14.1.2021 has noted that lot of work needs to be done for developing the park. Corporation is accordingly directed to ensure that adequate horticulture work is carried out in the park for its development. The next date of hearing is 18.3.2021. 




The pendency in the court matter is 7.73%. North DMC has a high pendency count of 18 (percentage- 9.52%) followed by SDMC having a pendency of 11.





Zero toleranceto be adopted towards ongoing unauthorised construction. The overall pendency has increased from 787 to 880 (increased by 93). North DMC has the highest pendency of 421(10.68%) followed by SDMC having 231(3.85%), DDA having 113(28.03%) and EDMC having 104(6.87%).

14. Major demolition actions/ encroachment removal actions executed by ULBs during the period from 15.01.2021 to 31.01.2021

- a. Encroachment Removal Action by **SDMC** at areas including RK Puram Sector-5, Car Market, Sector-07, Sector-08 and Sector-09, Mohan Singh Market and surrounding area on 20.01.2021 and Guru Ravi Dass Marg, DDA Flats Kalkaji, S-Block GK-II and S-Block Main Road Near Chandan Market on 25.01.2021
- b. Encroachment Removal Action from Govt. land taken by **Revenue Deptt.**, **SDMC, PWD** and **Delhi Police** at areas at MB road on 22.01.2021, approximately 3000 sqm and handed over to PWD
- c. Anti-Encroachment drive was carried out by **NDMC** in areas including Connaught Place and Palika Bazar, Gole market, Janpath, Regal Rivoli and Shanker market, Safdarjung, AIIMS, LBN market, INA, Sarojini Nagar and Chanakyapuri and VIP area

15. Additional Issues

A. De-sealing of 240 commercial establishments sealed on 02.08.2007 on account of misuse and 72 properties(Commercial at Ground floor) on 11.12.2018 at the direction of Monitoring Committee at Sanjay Nagar:

- i. Director(LM), DDA vide letter dated 31.12.20 requested Chairman, Monitoring Committee for the de-sealing of premises/Houses sealed on account of misuse in Sanjay Nagar as several representations have been received from the residents. It was also intimated that the land was allotted to the residents of Sanjay Nagar under 20 point programme by Director, Panchayat Secy. GNCTD in 1974.
- ii. Member, Monitoring Committee in reply to the above letter has forwarded a note to VC, DDA informing that it is an established fact that the appellants have encroached on the Govt. Land and had constructed unauthorized structures on the encroached Govt. Land which is liable to be removed. The Sanjay Nagar does not figure in the list of unauthorised colonies and not covered under Delhi laws(Special Provision Act 2011). Chairperson STF was requested to take action as per the direction of Hon'ble Supreme Court Order dated 08.05.2018. Director(LM), DDA has forwarded a note on the issues related to de-sealing of the properties in Sanjay Nagar.
- iii. Director(LM), DDA has forwarded a note on the issues related to de-sealing of the properties in Sanjay Nagar. The following have been submitted:
 - a. The land bearing Khasra No. 28//1, 28//2, 3/1, 3/2, 4/1, 4/2, 5, 6/2, 7, 8, 15/2 & 27//1/1, ½, 2, 9 & 10 of Village Mangolpur Kalan, was acquired by DDA vide Award No. 18/80-81 &possession of land was handed over to DDA by LAC/ L&B Deptt. on 01.05.1980 except Khasra No. 28//1, 2 Min(0-06), 3/2min (0-02), 8min(0-02).

- b. The land in question in Sanjay Nagar as verified by revenue staff of LM Deptt. from the original records from GNCTD, it was found that it was actually part of 20-Point Programme of Govt. of GNCTD and were **allotted by Director**, **Panchayat Secy. GNCTD in 1974**
- c. Hon'ble LG had granted perpetual lease rights to allottees of residential plots under 20-Point Programme. Also for those allottees who are using the sites for purposes other than residential, the lease could be granted to them on payment of current conversion charges as per DDA norms. Further vide order dt. 2011 also LG had granted perpetual lease to the allottees under 20-Point Programme on "as is where is basis" on certain conditions.
- d. Various representations of RWA, Sanjay Nagar had been received along with affidavits to abide by rules and pay conversion charges wherever applicable. As it is STF matter since long and it needs to be resolved as the matter has been referred back by the Monitoring Committee to the STF for examination, the same may be placed on STF Agenda for discussion.
- **B. Reference received from Sh. O.P. Sharma, Authority Member** regarding removal of encroachment on the road leading to Blind school between Shanti Mukund Hospital and Deepak Memorial Hospital at Dayanand Vihar to provide hindrance free movement to the Blind School. EDMC to submit the ATR
