Split up of ATR

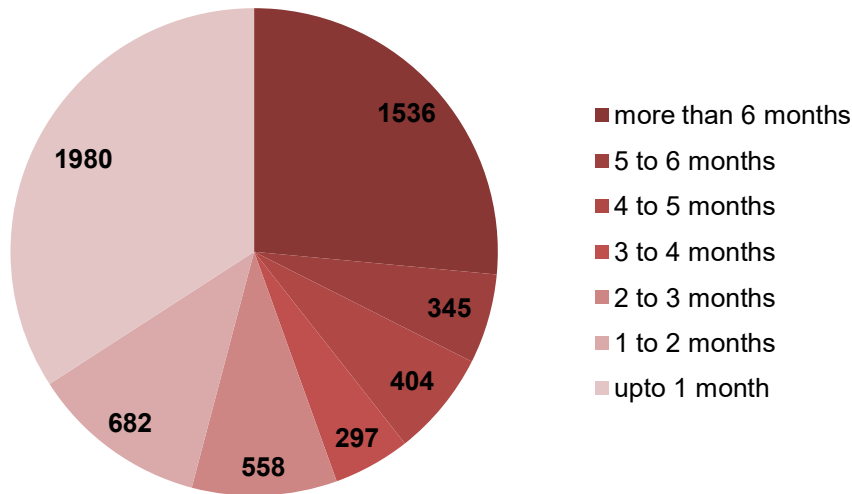

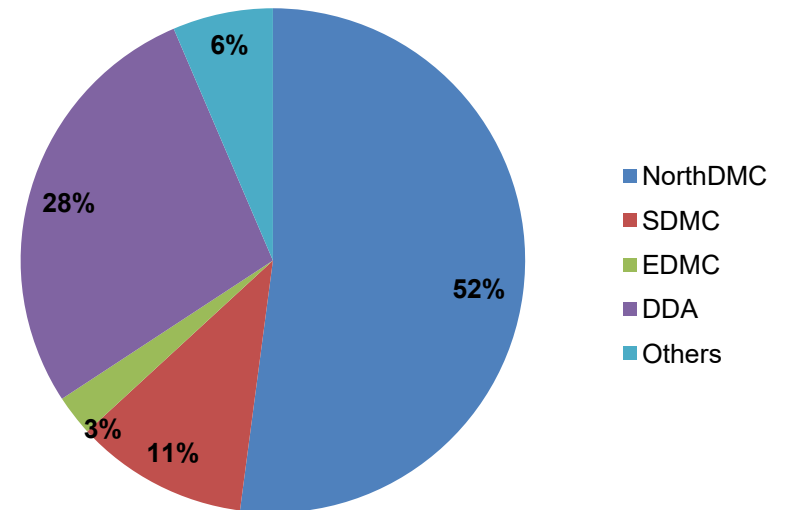

Age wise analysis of pendency

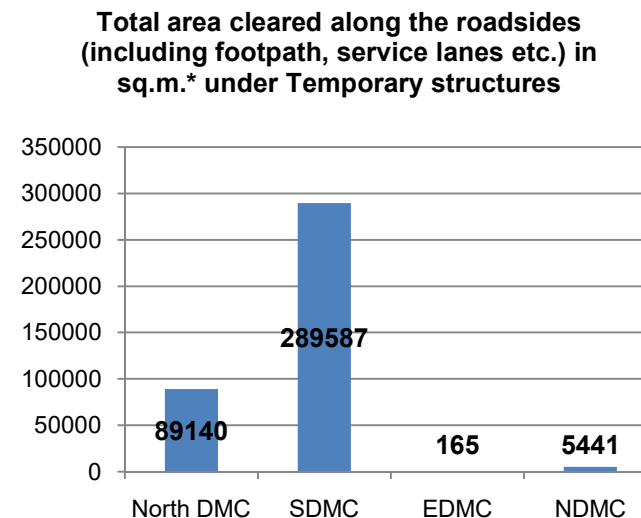
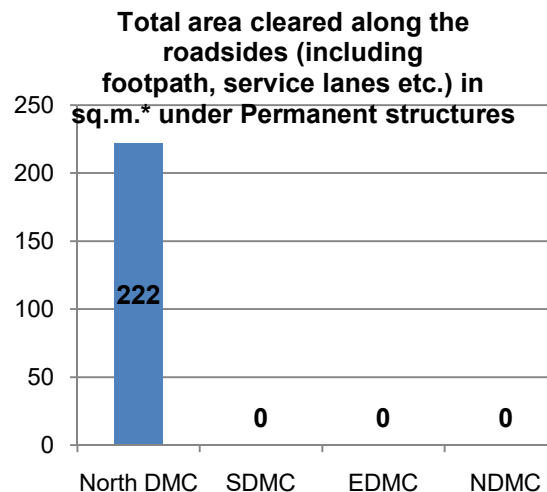
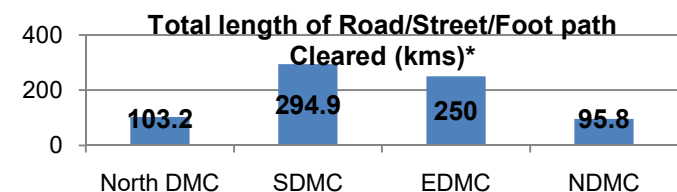
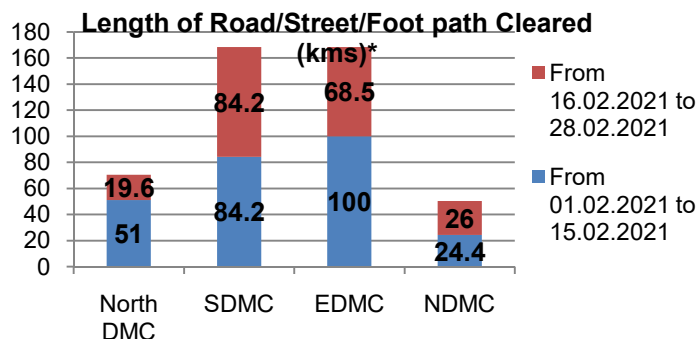


6 months old pendency-ULB wise split up

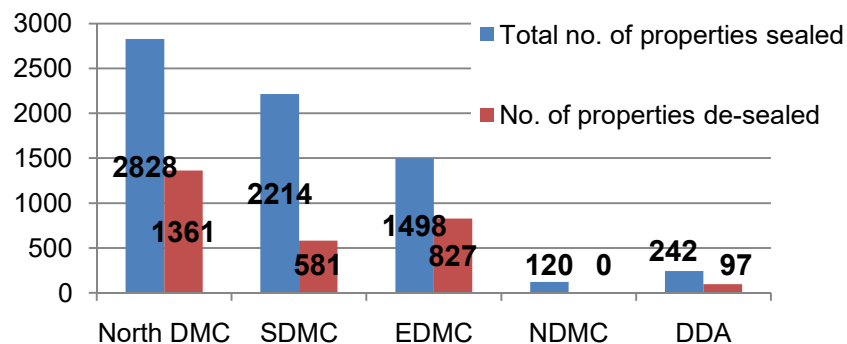

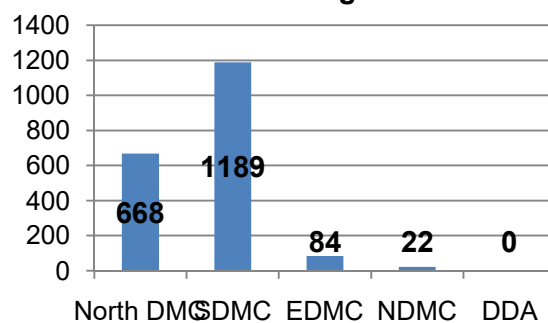

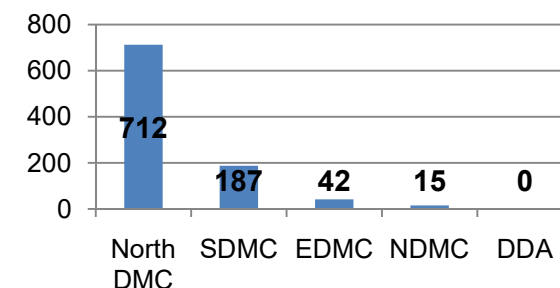
Total number of properties sealed and de-sealed
