The situation has not been improved in-spite of repeated directions from Chairman STF, the ULBs have not taken any action.
- ii. Direction to Revenue Deptt. to ensure the presence of the deputed official in the STF office at Vikas Minar: Revenue Deptt. to post the official in STF.
- iii. Member Monitoring Committee vide letter no MC/SC/IHC/2020/D-410 dated 2.3.2020 has requested the Commissioners of all three MCDs as well as Head of the departments to issue necessary directions to the officials concerned to take timely action on such complaints and submit ATRs to the Monitoring Committee as per stipulated time-frame.
- iv. Under Secretary to Govt. of India, MoHUA vide letter No. J-13036/14/2019-DD-IV (1453896) dated 06.01.2020 has forwarded the Notice from NHRC case No. 5538/30/1/2019/UC dated 09.12.19. building owner/shopkeepers/ individuals /firms, who are conducting commercial activities in the residential areas by encroaching public roads in connivance with public officials of different agencies and submit the requisite information/report within 6 weeks from the date of receipt of the notice. The ministry has entrusted the responsibility to STF and requested to submit the ATR in 3 weeks from the date of receipt of the letter to enable the ministry to prepare a suitable reply. The matter was referred to the Committee under Chief Town Planner, SDMC. A report dated 15.6.20 was received in STF from Chief Town Planner, SDMC. The report has been forwarded to all members of STF through e-mail on 1.7.2020 to send comments /. Observation by 7.7.2020 for discussion in STF and approval of the report to be forwarded to MoUHA. **No observations/ comments received**

v. Pr. Secretary, PWD,Govt. of NCT of Delhi vide letter No ENC/DIR/M/Court Case /196(E)/1352 dated 12.3.20 in response to the DO letter from Chairman STF dated 20.12.19 on removal of encroachment from PWD Roads has submitted that the MCDs are road owning agencies and they give the bazari, advertisements, weekly markets rights etc on all roads. MCD has power to confiscate and seize goods stored and kept on roads. PWD has no such punitive Powers as per law and without support of empowered agencies, any target given to PWD for encroachment removal from any road or land is meaningless.

It has been requested to direct MCDs and Revenue Deptt. and DDA as case may be for removal/ vacation of encroachment. PWD will provide logistical assistance as mandated as various levels, as deployment of labour and JCB/Tipper/Truck during the encroachment drive. PWD cannot lead encroachment drives due to lack of authority, staff, knowledge and records.
