5. **The list of officers at territorial grid/Unit to be identified upto to field level with delineated area of jurisdiction. All officers in the grid will be responsible for all future irregulars and unauthorised construction/violations as per MPD-2021/DMC Act and UBBL-2016:**
  - a) No information has been received from East DMC, PWD and Revenue Deptt., GNCTD till date.
  - b) Information regarding areas concerned under each territorial grids/unit/ward is still not provided.
6. **Action Taken Report by the concerned agencies regarding the stopping of new construction activity in the unauthorised colony as per orders of Hon'ble Supreme Court dated 24.04.2018.**
  - No information has been received till date from the concerned local bodies/govt. deptts.
7. **Action Taken Report on the application provided by the concerned agencies are not as per prescribed format.**
  - a) Most of the ATRs are unsigned, not legible and incomplete.
  - b) ATRs provided by the concerned agencies does not contain any specific dispatch number of STF number, hence data cannot be compiled.
8. **Consolidated monthly ATR in the general matters of removal of encroachment/unauthorised construction etc. to be submitted in every STF meeting by the respective concerned local bodies/Govt. Deptts. :**
  - Till date, consolidated ATR has been received only from South DMC, East DMC and North DMC.
9. **ATR regarding following issues is to be submitted at the earliest:**
  - a) Encroachment / illegal structures on DDA land in Kathputli Project and its surrounding area. [concerned deptt.: South DMC]
  - b) Removal of encroachment from public verandas, Govt./DDA land in Khan Market, Sanjay Market (Mangolpur Kalan) and Masoodpur (Harijan Basti). [concerned deptt.: South DMC, North DMC & DDA]
10. **Other Issues:**
  - Reg. unauthorised construction of Toba colony, Jogabai Extn., Batla House, extn. Dhobi Ghat (Okhla) on the flood plain of River Yamuna.
