- 3. In the matter of Sh. PC Pande wherein the complainant is requesting for appointing a Three Member Committee as per the provision at para 2(i & ii) of Office Memorandum No. O-33011/1/2006-DD.I, MoHUA, GOI dated 23.05.2019 in which the STF has to take immediate cognizance on such complaints, to examine & verify the allegations and identify of the officers(s) responsible for un-authorised constructions. Two issues were raised:
 - a) Complaints on removal of encroachment from common staircase by the complainant MCD officials targeted the complainant and damaged the Balcony which requires investigation
 - b) Proposal for additional coverage by covering the backyard of the flat rejected by MCD where as people have covered unauthorisedly in flats in the locality.
- 4. **Nodal officer from ULB / Govt. agencies:** To avoid confusion in forwarding the complaints to the ULBs/govt. agency, one Nodal officer to be nominated who'll have to forward the complaints to the concerned grid officers. But in case of DJB, NDMC and DDA more than one nodal officers name has been uploaded in the web portal. The name of Nodal officer/grid officers from Irrigation and Flood Control, GNCTD has not been intimated to STF hence the complaints can not be forwarded to I & FC Deptt. The above mentioned ULBs / govt. agencies to Nominate one nodal officer and grid officer and intimate the same to STF for uploading on web portal.
- 5. Month wise pendency list/status/reasons for delay of all the complaints to be submitted. The list of complaints pending for 3 months or more has been received from EDMC only. The same need to be submitted by the rest of the organizations positively in this meeting.
- 6. Till date 2000 grievances received through hard copy have been uploaded on the Integrated web portal. All the Nodal officers / Grid officers of the concerned ULBs / govt. agencies to upload their Action Taken Report (ATR) for every grievance received through e-mail/post on the integrated web portal to facilitate generation of consolidated action taken / status report. In addition to this 1468 complaints have been uploaded directly on the STF web portal which is required to be seen by the Nodal and Grid officer for taking action and uploading the ATR on STF web-portal.
- 7. A court case CWP No. 1174/2019 in the matter of Shri Puran Chand Tamta Vs Vice Chairman, DDA, Commissioner SDMC regarding illegal construction work at B-1/23, Safdarjung Enclave, New Delhi-110029 is filed in the High Court. All the paras pertains to SDMC and the actions to be taken by SDMC. The hearing is scheduled on 13.02.2019. Matter pertains to SDMC.
- 8. List of 129 issues discussed in previous STF meetings including 2 PMOPG reference, 19 Court Cases, 42 issues referred in Public Hearing, 7 complaints against Erring officials and 59 other case specific issues is placed opp. at *Annexure-1 pg no. 1*. Action taken report in respect of 106 references yet to be received.
- 9. With respect to 305 complaints forwarded by Monitoring committee, received in STF till 06.02.2019, Action taken report is pending for 189 cases. (*Refer Annexure-2 pg. no.* 13)

1. Court Matter received after the circulation of Agenda:

- a. Regarding illegal construction upto 5th Floor at H.No. 254, in the sealed building near green garden public school, main brahmpuri road, Rajpur Mohalla, opp. Ghonda Chowk, Delhi raised by Mr. Anil Rawal. **Dy. Registrat (PIL) vide letter No. 1160-W/PIL/234/DHC/2018 dated 17.01.2019** has forwarded this case to STF **to take necessary action**. The matter pertains to EDMC.
- b. In the matter of Sh. Lalit Kumar Bakshi Vs SDMC through its Chairman and Ors. regarding demolition of **illegal construction on property bearing no. 64-A front portion (earlier central bank) main chowk, Badarpur,** New Delhi-110044 WP(C) / 2019 filed in the High Court of Delhi, Date of Hearing 07.02.2019 STF has been made a party in the case at Respondent-2. The matter pertains to SDMC.
- c. In the matter of Sh. Suraj Mal Vs Dy. Commissioner SDMC and Ors. regarding unauthorized **construction and demolish the same on the property no. E-72 A, Jawahar Park, Devli Road**, New Delhi-110080. The matter WP(C) 19 is in High Court of Delhi likely to be listed as 08.02.2019. The matter pertains to SDMC.
- d. In the matter of Abhishek Yadav Vs Deputy Commissioner, North Delhi Municipal Corporation regarding **unauthorized construction at property no. 1 and 1A, 6B under Hill Road Civil Lines** Delhi-110054 without sanction of Building plan and violation of MPD-2021 filed in **Hon'ble Supreme court of India** in IA No. 15872 of 2018 in WP(C) No. 4677 of 1985 with IA No. 158420/18, 155421/18 and 158422/18.
- 2. **Public Hearing:** Regarding **De-Sealing of Bawa poultry**, Vasant Kunj, New Delhi. This matter pertains to SDMC.
- 3. The complaint of Sh. Prakash Goswami regarding **unauthorized construction at A-3**, **Neeti Bagh**: As reported by EE Building-I, South Zone vide note dated 11.01.2019, it has been submitted that "At rear set back the owner / occupier was continuing with repair work as is permitted under Unified Building Bye Laws 2016, Since, there noticed nothing objectionable, as regards afresh construction in violation of prevailing Building byelaws-2016, at this Junction, no punitive action is called for".
 - The complainant has again filed a complaint stating that MCD has taken no action on the same.
- 4. **Illegal encroachment / constructions on Pt. Lekhram Sharma Marg** (Rampura Main Road) in Rampura municipal ward no. 70N, North DMC has earlier reported reported that encroachment has been removed and 13 items seized on 17.09.2018.
 - The complainant has again filed a complaint to consider the case and arrange to conduct site check to validate the contents of ATR submitted by North DMC.

5. Vice-Chairman, DDA vide note dated 16.01.2019 has referred the case **of vacant land adjoining Subash Camp at Badarpur for development as park** for locals to Chief Engineer East Zone and Comm.(LM) to remove the Jhuggis and demarcation of the site and the matter was referred to STF with the direction that the concerned officers to submit the report within weeks time.

A report has been received from Chief Engineer (East Zone) vide note dated 31.01.2019 in which the following information are given:

'There are two types of Encroachment f Residential and Commercial. A demolition programme was fixed for 13.12.2018 to remove commercial encroachment which could not be carried out due to non-availability of sufficient police force. Again demolition programme for removal of encroachment was fixed on 27.12.2018. The same also could not be carried out due to stay by Hon'ble High Court on 20.12.2018. it was directed by the Hon.ble Court to **maintain status quo**.
