Status on the 6960 complaints in which detail ATR is not available to be uploaded by ULBs & Govt. Agencies. SDMC has to upload ATR on 5569 old cases, 809 for North DMC, 564 for DDA and remaining pertains to other ULBs/Govt. Agencies. The situation has not been improved in-spite of repeated directions from Chairman STF, the ULBs have not taken any action.

14. Direction to North DMC and Revenue Deptt. to ensure the presence of the deputed officers in the STF office at Vikas Minar. The direction of Chairman STF is yet to be complied by North DMC and Revenue Deptt.. It is difficult to co-ordinate with both the organization.

15. Issue in STF Web-Portal:

It is to inform that based on existing scenario, the STF Web-Portal as well as DDA-311Mobile App are working on two different data bases handled separately by Systems Deptt. DDA and Civic Solutions Pvt. Ltd respectively. This has resulted in serious issues in Integrating the two i.e. STF Web-Portal as well as DDA-311 Mobile App which is creating discrepancy in the final Integrated data. As the data is to be submitted in Hon'ble Supreme Court on a regular basis. It may be considered that instead of two separate databases, only a single database be created and managed by a single agency. Commissioner (Plg) also forwarded the issue on data base 19.12.19 to PC(Systems) but the same is yet to be resolved. This has resulted in delay on filling report for the period 15.11.19 to 30.11.19 & 1.12.19 to 15.12.19 in the Hon'ble Supreme court.

16. Uploading of Wrong ATR on Court Case:

The action taken report uploaded by the grid officer S.C. Meena E.E.(B)-I/ CSPZ on Reference ID: SNS2019072335 is not related to the writ petition and is wrong. In spite of repeated direction, in many cases the ATRs are uploaded without signature of the grid officer. This needs to be discontinued.
