Sub: Minutes of 9th meeting of the Special Task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions of MPD-2021

The ninth meeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 16.08.2018. List of officers who attended the meeting is annexed. During the meeting the following was deliberated and decided:

1. At the outset of the meeting, Chairman, STF was apprised with the Action Taken Report on the complaints received from the applicant either through online app or by hand.
 - a) All the concerned local bodies were repeatedly requested to submit a consolidated ATR. However, no action was taken in this regard. Hence, all the agencies / members of the STF were provided a standard format for submission of consolidated ATR on weekly basis duly signed by the concerned nodal officer.
 - b) In case of ATRs related to the application / grievances received directly from the Monitoring Committee or forwarded through Monitoring Committee. Chairman, STF directed all the concerned agencies to submit the ATR by 23.08.2018 for compilation and for onward submission before the Hon'ble Supreme Court on 28.8.2018.
2. Chairman, STF directed all the concerned agencies to submit their comments on the draft guidelines for blacklisting of builders/contractors/architects so that the same can be finalised before the next date of hearing of Hon'ble Supreme Court.
3. In order to explore the possibility of digital mapping in Delhi the representative of GSDL presented the brief profile and works associated with their company. In addition to above, System Deptt., DDA briefed about the Memorandum of Understanding (MOU) signed between the DDA and National Remote Sensing Centre (NRSC). It was also suggested by DDA's system department that data can be shared with the ULB's.
4. Chairperson, STF directed the GSDL to co-ordinate with the System Deptt. , DDA for necessary actions in consultation with the Line Deptts of Government in Delhi including local bodies.

5. Nodal Officer/ Grid Officer of local bodies informed about the discrepancies in the operation of online smart phone mobile app. of STF. Accordingly, Chairperson, STF directed DDA and concerned local body to have a joint meeting/ presentation on 20.8.2018 wherein System Deptt., DDA shall provide training for use of the STF Mobile app and web portal to the agencies at different intervals of time to North DMC, South DMC & East DMC.

The next meeting is scheduled to be held on 30.08.2018 at 3:00 pm for which no separate meeting notice will be issued. All the members of the STF are requested to attend the meeting in person.

Meeting ended with thanks to the chair.
