Minutes of the Meeting 1st Quarterly meeting to review the progress achieved by Special Task Force (STF) and to review plans for future, held under the chairmanship of Secretary, Ministry of Housing and Urban Affairs, Govt. of India on 21.08.2018 at 2:30 pm

- 1. Secretary (HUA) chaired the 1st quarterly meeting to review the progress achieved by STF and to review plans for future, at 2.30 pm on 21.08.2018, at Nirman Bhawan, New Delhi. The list of participants is at Annexure.
- 2. Member Secretary / Convener, STF gave a detailed presentation on various issues coordinated and monitored by STF since its formation on 25.04.2018, including the details of anti-encroachment drive undertaken mainly covering the following points:
 - i. 09 meetings of STF have taken place so far.
 - ii. STF assesses the Action Taken Report on anti-encroachment drive, curbing illegal/unauthorized activities and sealing of premises undertaken by local bodies/government agencies.
 - iii. A total of 722 complaints/grievances in physical form and 1723 complaints/grievances through mobile app linked with web portal (launched on 09.07.2018) have been received by STF. The meeting noted the action taken there on by the STF.
 - iv. So far STF has cleared encroachment in 1095497 sq. meters of area and in approx. 1900.53 km length of road/street/footpath, seized 8486 nos of vehicles and 23581 nos of items and issued 10800 nos. of challans. Besides since April 2018, a total of 324.173 acre of DDA land has been cleared of encroachments.
- 3. The chair was also apprised of the following actions taken in compliance of order dated 18.07.2018 of Hon'ble Supreme Court (SC) in the matter of M.C. Mehta v/s Union of India & Others (WP (C) 4677/1985):
 - Guidelines for blacklisting Builders/Contractors/Architects: DDA has framed the guidelines and circulated to all the concerned local bodies and Amicus Curiae for their suggestions. The guidelines are, however, pending as no response has been received from Amicus Curiae despite reminders.
 - ii. <u>Digital mapping of Delhi to check unauthorized construction</u>: It was informed that GSDL has been asked to co-ordinate with System Deptt. of DDA to work out an appropriate mechanism for digital mapping as per ground realities.
 - iii. <u>Co-opting ASI representative in STF</u>: It was informed that Dy. Superintending Archeologist of ASI has been co-opted as the Member of the STF. Besides, the representatives from NHAI and DUSIB have also been co-opted as the Members of the STF.



- iv. It was informed that as desired by the Monitoring Committee, the re-survey wherever required, has been completed for all the 351 roads and the proposal for notification of the roads stands referred to the UD Deptt. of GNCTD.
- 4. After detailed discussions, the following decisions were taken:
 - a. The guidelines for blacklisting of builders/contractors/ architects be finalized immediately without any further delay.
 - b. The process of digital mapping of Delhi by DDA in consultation with Geospatial Delhi Limited (GSDL) should be expedited.
 - c. The details regarding anti-encroachment drive by Urban Local Bodies and other department needs to be more clearly stated and the figures/ date given be verified so that the same can be apprised to the Hon'ble Supreme Court.
 - d. Order of Hon'ble SC should be strictly complied with and there should be no tolerance for illegal/unauthorized constructions/encroachments on public areas.

The meeting ended with the vote of thanks to the Chair.
