Minutes of the 3rd quarterly meeting to review the progress achieved by Special Task Force (STF) and to review plans for future, held under the chairmanship of Secretary, Ministry of Housing and Urban Affairs, Govt. of India on 02.07.2019 at 05:00 PM.

Secretary (HUA) chaired the 3rd quarterly meeting to review the progress achieved by STF and to review plans for future at 05:00 PM on 02.07.2019 at Nirman Bhawan, New Delhi. **The list of participants is Annexed.**

2. Member-Secretary/ Convener, STF made a detailed presentation on various issues coordinated, monitored and undertaken by the STF including the action taken on the issues arising out of the 2nd quarterly review meeting held on 04.12.2018. It was noted that a Special Task Force Cell has been created in DDA in January 2019, under the Member-Secretary STF with staff drawn from local bodies. Secretary (HUA) hoped that having this Cell will ensure better coordination, disposal and monitoring of the work of STF.

3. It was noted that based on the decision taken in the 2nd meeting, STF has filed an affidavit in the Hon'ble Supreme Court on 10.01.2019 listing out details of properties sealed and those which could not be de-sealed due to rejection by the Monitoring Committee. In this affidavit, STF has also proposed a draft procedure for temporary and permanent de-sealing of the premises where action for Hon'ble Courts decision in coordination with the urban local bodies / authorities. Secretary



(HUA) directed that response to Report No. 147 of the MC should also be filed immediately.

4. The following key features of the work done by the STF were noted:

- I. Out of about 22,000 complaints received by STF as on 19.06.2019, ATRs in more than 15,000 complaints have been received.
- II. Approx. 5700 kms. of road/ street/ footpath has been cleared from encroachment.
- III. More than 600 Ha of area under permanent/ temporary structures has been cleared along the roads.
- IV. Nearly 200 Ha of land pockets (other than road, footpath etc.) have been cleared from encroachment.
- V. Nearly 1 lakh items and approximately 32,000 vehicles were removed from public places/ road/ footpath etc.

5. It was noted that regular fortnightly reports of the work done by the STF are being submitted to the Hon'ble Supreme Court. Secretary (HUA) appreciated the work done by the STF. After detailed discussion, the following decisions were taken:

- I. Regarding Sanjay Market, it was noted that the information is pending from Director (Panchayat)/ DM (North West)/ BDO. It was decided that the matter may be taken up at higher level to expedite the response.
- II. Regarding Amar Colony, L&DO was asked to submit adequate response in the Hon'ble Supreme Court and also expedite the proposal with regard to the colony.



- III. Regarding the issue of finalisation of guidelines for blacklisting of contractors/ architects, it was decided that Ld. Amicus Curie may be reminded periodically in the matter.
- IV. Regarding the large number of pending complaints forwarded by the Monitoring Committee to STF, it was decided that all the cases will be dealt on top priority and the pendency in this regard would be substantially reduced.
Similarly, the pending complaints received from court cases would also be given special attention and the pendency should be reduced substantially.
- V. Urban local bodies to deliberate the issue of negligible fine due to which the roads are being encroached again by paying the existing meagre fine, and propose remedial measures.
6. The meeting ended with a Vote of thanks to the Chair and participants.
