Minutes of the 62nd meeting of Special Task Force (STF)

The 62nd meeting of Special Task Force (STF) was held on 12.02.2021 (Friday) under the Chairmanship of Vice-Chairman, DDA. The list of officers who attended the meeting is placed at Annexure 1. The following was decided.

1. Minutes of the 61st STF meeting held on 12.02.2021 circulated on 08.02.2021 were confirmed.

2. Details of Action Taken Report received from ULBs / Govt. Agencies (Mobile App + Web-Portal + Hard Copy) up to 15.01.2021 was reviewed.

Action has been initiated on 67111 complaints out of 73757 complaints received till 31.01.2021. Action was taken on 614 complaints during the last fortnight.

Age wise pendency status was discussed. 1787 complaints are pending for more than 6 months and 1002 complaints were less than a month old. It was discussed that complaints need to be responded as soon as these are received thereby ensuring that these are put in process without delay. Priority be accorded for disposal of complaints which are more than 6 months old.

It was informed that Commissioner, SDMC has reviewed the STF matters and all Addl. Commissioners have been directed to take expeditious action to reduce the pendency. North MCD officers informed about the glitches in the software due to which ATR's of old complaints are not visible on the website. It was also informed that due to change/transfers of officers, the officers in the current charge of duties are unable to access the old complaints which is hampering in the reduction of the pendency. It was directed that Director Systems along with Coordinator STF shall hold a meeting with the concerned officers of ULBs on 15th Feb, 2021 and resolve the issue.

3. Anti-encroachment drive on roads/footpaths during 16th to 31st January 2021-133.6km
road length has been cleared with the following break up - North DMC: 19.4 km, SDMC: 69.4 km, EDMC: 23.5km and NDMC: 20.3km.

4. Action Taken Report on anti-encroachment drive on challans/bookings submitted by ULB/Delhi Police from 16th to 31st January, 2021.
North DMC- 352 items, 125 vehicles, 69 challans
South DMC - 1246 items, 29 vehicles, 9 challans
EDMC - 104 items, 56 vehicles, 69 challans
NDMC - 821 items, 4 vehicles, 129 challans
Delhi Police - 544 vehicles, 1397 challans

5. Properties sealed/ de-sealed as per direction of Monitoring Committee: 2224 applications
have been received for de-sealing out of the total 6716 properties sealed at the behest of Monitoring Committee. De-sealing of 8 properties has been approved by the Monitoring Committee in the last fortnight. It was pointed out that there is a mismatch in the data on

details of properties sealed/de sealed by the ULBs for including in the Annual report vis a vis the data on the regularly discussed and documented in the STF meetings. The anomaly in the data was arising as the fresh data received was inclusive of all the actions taken by the ULBs (inclusive of Sealing/De sealing as per MC). It was directed that the data be forwarded to STF after due verification and categorization under suitable headings such as total properties sealed –as per the directions of Monitoring Committee, sealed under unauthorized construction, sealed under misuse, properties de-sealed and properties liable for de-sealing etc. The verified data be forwarded to STF without delay as the same is part of annual report.

6. Removal of encroachment on govt. land by the owners of ground floor on the areas meant for Tot lots / parking / open space: Hon'ble High Court vide order dated 14.1.2021 has noted that lot of work needs to be done for developing the park.

7. **ATR on Court matters and Public Hearing cases** as listed out in the agenda concerned agencies informed the status and the following was decided.

- i. Removal of the unauthorized and illegal encroachments on the main road from Badali Railway Station to GT Karnal Road (Sr. no. 1)– Action completed. ATR uploaded.


- a. Regarding the report of NHRC, SDMC has submitted the report. Chairman, STF suggested a separate meeting be held to discuss the report.


