Minutes of the 64th meeting of Special Task Force (STF)

The 64th meeting of Special Task Force (STF) was held on 12.03.2021 (Friday) under the Chairmanship of Vice-Chairman, DDA. The list of officers who attended the meeting is placed at Annexure A. The following was decided.

1. Minutes of the 63rd STF meeting held on 25.02.2021 circulated on 05.03.2021 were confirmed.
2. Details of Action Taken Report received from ULBs / Govt. Agencies (Mobile App + Web-Portal + Hard Copy) up to 28.02.2021 was reviewed.

Action has been initiated on 71531 complaints out of the 77186 complaints received till 15.02.2021. Action was initiated on 2011 complaints during the last fortnight.

Age wise pendency status was discussed. 1536 complaints are pending for more than 6 months and 1980 complaints were pending less than a month old were pending. It was reiterated that the pendency in the category of complaints more than 6 months old needs to be expeditiously resolved. All agencies to ensure that any given point of time the pendency of any complaint shall not be more than a month old.

Nodal officers were issued directions to resolve the long pending issue of old ATRs.

3. Anti-encroachment drive on roads/footpaths during 16th to 28th February 2021- 198.3km road length has been cleared with the following break up - North MCD: 19.6 km, SDMC: 84.2 km, EDMC: 68.5 km and NDMC: 26 km.

To prevent recurrence of encroachment, an SOP be prepared by a committee comprising of Members from Traffic Police, concerned ULB's & PWD under Addl. CP(Traffic).

The details of lifting of vehicles/ Items/ challans are as under.

EDMC -629 items, 399 vehicles, 206 challans, North MCD 311 items, 12 vehicles

NDMC -1076 items, 5 vehicles, 190 challans, SDMC 1108 items, 105 vehicles

Delhi Police -575 vehicles, 1372 challans.

North MCD and SDMC to expedite issue of challans as no challans were issued during the said period.

4. Properties sealed/ de-sealed as per direction of Monitoring Committee: A total of 6902 properties were sealed out of which 1997 were sealed due to unauthorized construction and 4905 were sealed due to misuse.

1963 applications were received for de-sealing out of which 956 applications for de-sealing were approved by the Monitoring Committee.

2866 properties have been de-sealed by the ULBs as the follow up of the order of the Hon'ble Supreme Court dtd. 14.08.2020.

5. ULBs submitted the data on total sealing and de-sealing since inception of STF including the property sealed by Monitoring Committee: 9377 properties were sealed out of which 4348 were sealed under the category of unauthorized construction and 4991 under misuse. 3584 properties have been de-sealed.
6. Regular monitored Cases: Regarding entry in to the reclaimed Tot lots which has been obstructed by the owners of the ground floor by putting temporary hurdles at the gates, locking of the gates, EDMC informed that the locks have been removed with the help of the police.
7. **ATR on Court matters and Public Hearing cases** as listed out in the agenda was presented by the concerned agencies and the following was decided.

A. North Delhi Municipal Corporation (North MCD):

- i. In the matter Fight for Right Social Welfare Society vs VC, DDA and Commr North MCD regarding demolition of unauthorized construction in Kishanganj, MotiBagh, and other areas (Sr.no.2)-It was informed that there is no change in the status as already discussed in the 63rd STF meeting. North MCD to take expeditious action on properties where notices for demolition/sealing have been issued.
- ii. Court matter titled Anil Kumar v/s DDA, North MCD and PWD related to removal of unauthorized constructions on Pt. Lekh Ram Marg(Sr.no.2)-. PWD and North MCD to study the demarcation, Hon'ble Court order and take legal opinion wrt removal of encroachments. The detail report be submitted in the next STF meeting. The next date of hearing is 27.04.2021.
- iii. WP(C)No. 1395/2021, Swarna Aastha Educational and Social Welfare Society vs NDMC &Anr on action against illegal construction on the plot no.424, Bhai Parmanand Colony (Sl.no.3)- North MCD informed that part demolition action has been taken and the next programme has been scheduled on 23.3.2021.
- iv. W.P. (C) No. 5976/2019, in the High court, Anand Puri Govindgarh Residential Welfare Associates vs the Govt. of NCT of Delhi &ors. order dated 27.05.2019 regarding unauthorized construction in Kalindi college, (Sl.no.5)- It was informed that in response to the letter from North MCD, the Principal of the college has sought time for submission of documents.
- v. Removal of the encroachment on the park land (Tikonika Park) at Adarsh Nagar (Sr.no.5)-Joint action date to be taken for removal of encroachment.
- vi. Complaint by the Secretary, RWA, Mohan Park, Block K, forwarded by Sh. O.P. Sharma, Authority Member regarding closure of road by Illegal Construction of a wall at 31/28 K Block, Mohan Park (Sl.no.6) -It was

informed that the joint inspection has been done. CLM, DDA to examine the status of allotment of land to Police vis a vis Zonal Plan of the said area.

- vii. Public hearing: Sh. Akash Jain(Sr.no7), regarding no action since 3 months against illegal encroachment at Paharganj - North MCD was directed to remove the encroachment and upload ATR before the next meeting.
- viii. In the High Court matter, Mohd. Abrar vs North MCD & Ors., regarding raising illegal, unlawful and unauthorized construction in the shape of 2nd and 3rd floor over property no.152 to 158, Main Bazar, Ajmeri gate, (Sr.no 8) - It was informed that no new construction activity is in progress. As per record of EE(B)-II/ City SP Zone, no booking of unauthorized construction is available and no action is required. North MCD to submit the report in the court.
- ix. In the High Court matter, Mukesh Sethi & Anr. Vs STF & Ors., to set aside the decision made in 42nd meeting to 46th meeting of STF and the letter issued by AE Karol Bagh Zone on provision of stair case to first floor of the property B-24, ground floor, Kirti Nagar, WHS timber market - North MCD to submit the detailed report in the Court. North MCD may call both the parties and attempt to get the dispute resolved mutually.
- x. W.P.(C) No. 12794/2018, in the High Court, Virender Kumar Vs Shri Tarun Kapoor & Ors., regarding illegal construction in the property bearing no. 2105, DBG Road, Karol Bagh, without any sanctioned site plan – Action to be taken up on priority and submit the status report in the Court as well as in STF.
- xi. In the High Court matter, Mohd. Zakir Vs North MCD and Ors., regarding unauthorized construction on the 4th floor and Terrace of the building at property no. 1527, Gali Kautana Suiwalan, Darya Ganj - inspection has been conducted on 12.03.2021. Status report to be filed in the Court.
- xii. Sh.Mathews Wilson regarding the removal of 2ft high pavement in front of 265, Ground floor, DDA SFS flats, Dr Mukherji Nagar - programme scheduled on 18.03.2021.

B. South Delhi Municipal Corporation (SDMC):

- i. SLP (Civil) No.5731/2020 in Supreme Court, Monu Bhadana vs UoI and Ors., regarding the illegal construction at Mehrauli (Sr.no.1)- It was informed that during the period from 16.02.2021 to 28.2.2021, demolition action taken on one property.

During the action roof panels, internal walls and door windows at 3rd floor were demolished. Further the property was also sealed.

- iii. W.P.(C) No10704/2020, in the High Court, Nyaya Manch (NGO) Vs Chairman STF &Ors., and complaint of Sh. Deepak Singh regarding illegal construction at Mohan Singh Market (Sr.no.3)- It was informed that the encroachments are existing since 1995 and the matter is being examined.
- iv. W.P.(C) No. 976/2018, in the High Court, Universal Human Right Foundation Vs Commissioner &Ors., regarding illegal/unauthorized construction in property no. C-37, Shiv Park, Khanpur Village (Sr.no.4) - Stay has been granted from High Court. Next date of hearing is 13.4.2021.
- v. W.P.(C) No. 8233/2019, in the High Court, Naveen Tokas Vs Government of NCT of Delhi, STF, SDMC and Ors. regarding unauthorized and illegal construction at Vedanta Restaurant and a gymnasium at House No. 209-B/3, Village Munirka (Sr.no 5) - The license for Restaurants has been renewed till 31.3. 2021. Show cause notice has been issued to the owner of Gym on 11.03.2021 and has been directed to close down the trade.
- vi. Maninder Singh Sawhney V/s Gurpreet Singh Kohli and Ors. Illegal construction raised by defendant No. 1 at the backside of the property no. D-7, Jangpura-B (Sr.no.6) –Interim Stay has been granted by Saket Court. Next date of hearing 07.04.2021.
- vii. W.P.(C) No. 11008/2019, in the High Court, Anil Kumar Vs DDA and Ors. order dated 16.10.2019 regarding stopping the illegal construction upon the property bearing no. 111 ward no. 9, Kishangarh (Sl.no.7) - action scheduled for 23.03.2021.

 - ii. Barat Ghar in Adchini - SDMC to take up removal of encroachment on the road.

- i. Sh. Jai Prakash; in the matter WP(C) 8993/2018, regarding removal of encroachment and un-authorized construction at Asola Village on Khasra No. 46, 1354 etc.(Sr. No. 1) -SDM(Saket) informed that the property is protected under Special Provision Act. Report to be uploaded.
- ii. W.P.(C) No. 9300/2019, Aryawart Janjagrat Welfare Association Vs DDA, North MCD &Ors. order dated 27.08.2019 regarding unauthorized encroachment on public land in village Basaidarapur(Sr.no.2) - Demarcation to be conducted on 15.3.2021

fixed on 12.03.2021. Forest and Revenue Deptt were directed to co-ordinate and take expeditious action on removal of encroachment.
