Fire in Building with illegal units in heart of city kills 43" published in Times of India dated 09.12.2019. The following direction was given:

"NHRC has directed this Ministry to form a committee of experts to look into matters relating to violation of norms by building owner/shopkeepers/individuals/firms, conducting who are commercial activities in the residential areas by encroaching public roads in connivance with public officials of different agencies and submit the requisite information/report within 6 weeks from the date of receipt of the notice. NHRC has also directed the committee must look into the Master Plan of Delhi and to take all adequate and appropriate measures by examining all issues of illegal construction, misuse of rules/norms and use of factory area for residential purposes, thoroughly and submit its report with their suggestions to streamline all the congested areas within Delhi to make it more safe and worth living for the citizens."

The ministry has entrusted the responsibility to STF and requested to submit the ATR in 3 weeks from the date of receipt of the letter to enable the ministry to prepare a suitable reply. The above reference has been e-mailed to the members of STF and Nodal Officers with a standard format for providing information on 14.01.2019. Direction from Chairman to all ULBs and concerned Govt. agencies is requested for submission of the report to STF as well as MoHUA by all concerned ULBs and Govt. Agencies.
