Sub: Minutes of 46thmeeting of the Special Task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions of MPD-2021.

The 46thmeeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 16.03.2020. List of the officersattended the meeting, is annexed.

During the meeting, the following were deliberated and decided: -

1. Confirmation of the minutes of 45th Meeting of STF: The representative of NDMC pointed out that the issue of retrieval of Govt. land from encroachers/ villagers of Pilanji Village is DDA land. The action is to be taken by DDA not NDMC and this is to be incorporated. The minutes were approved with the above said observation.

- 3. The consolidated status report given in Report 1 and Report 2 were discussed. It was pointed out by Chairman that although Total ATRs on complaints received is good but actual actions taken in the form of Sealing/ demolition on the complaint on ground is very less which is not desired. The ULBs and Govt. Agencies must take action without delaying indefinitely. This issue will also be reviewed by the HODs and will be discussed in the next STF meeting.
- **4. Regular Monitored Case**: Removal of encroachment on govt. land by the owners of ground floor on the areas meant for Tot lots / parking / open space: EDMC, is progressing on the work which will be completed within 2 months' time. Other ULBs were directed to take action on the existing encroachment.

- 7. ATR on 55 Public Hearing Cases: Out of a total of 55 complaints received in Public Hearing forwarded to the concerned ULBs/Govt. Agency, 23 updated ATR are awaited and 32 cases are pending in which no Action Taken Report (ATR) have been submitted till date. The ULBs and Govt Agencies were directed to take action on these cases which have been heard by Chairman, STF.
- 8. ATR on the orders of Hon'ble High Court: 563 Hon'ble court orders received in STF have been forwarded to concerned ULBs and Govt. agencies and uploaded on the STF portal. ATR on 445 complaints in excel format have been forwarded to the ULBs / govt. agencies to provide latest status of the case one month ago.Nodal/Grid officers were directed to review the court matters seriously and take action based on the content of writ petition/court direction.
- 9. ATR on Complaints forwarded by the Monitoring Committee: 1413complaints have already been forwarded to the ULBs/Govt. Agencies and uploaded on the STF portal. ATR on 1092 complaints have been uploaded on the web portal and the pendency is 22.71%. Chairman, STF pointed out that the pendency in disposal of Monitoring Committee complaints is highest in North DMC followed by DDA and SDMC. This requires review by HODs to reduce the pendency. All concerned agencies to take action on pending cases expeditiously.
- **10.ATR on the Complaints more than 6 months old:** At present 1637 complaints received from hard copy are pending for more than 6 months. Chairman, STF directed that action on pending complaints be taken at the earliest and the ATR be uploaded the same on the web-portal.
- **11.ATR** on the Complaints regarding On-going unauthorized construction: The action on ongoing unauthorized construction has not been taken seriously by the local bodies. Again, and again it has been reiterated in the meeting that zero tolerance to be adopted in these cases which has not been maintained by ULBs. ATR with property detail and photograph to be submitted and uploaded.
