The total pendency is 3937 and has decreased by 1718 in comparison to the previous period (from 5655 on 28.02.2021). NDMC, Delhi Fire Service, Delhi Jal Board, Revenue, DUSIB and Forest Department have had their pendency increased. It has reduced for North DMC, SDMC, EDMC, DDA, Delhi Police, PWD and ASI. North DMC and DDA have highest pendency of 1318 and 1127 respectively. The number of cases under old ATR has been reduced from 7099 on 01.01.2021(60<sup>th</sup> STF meeting) to 4178 on 15.03.2021; major action on this aspect has been taken by SDMC and DDA.



### Split up of ATR

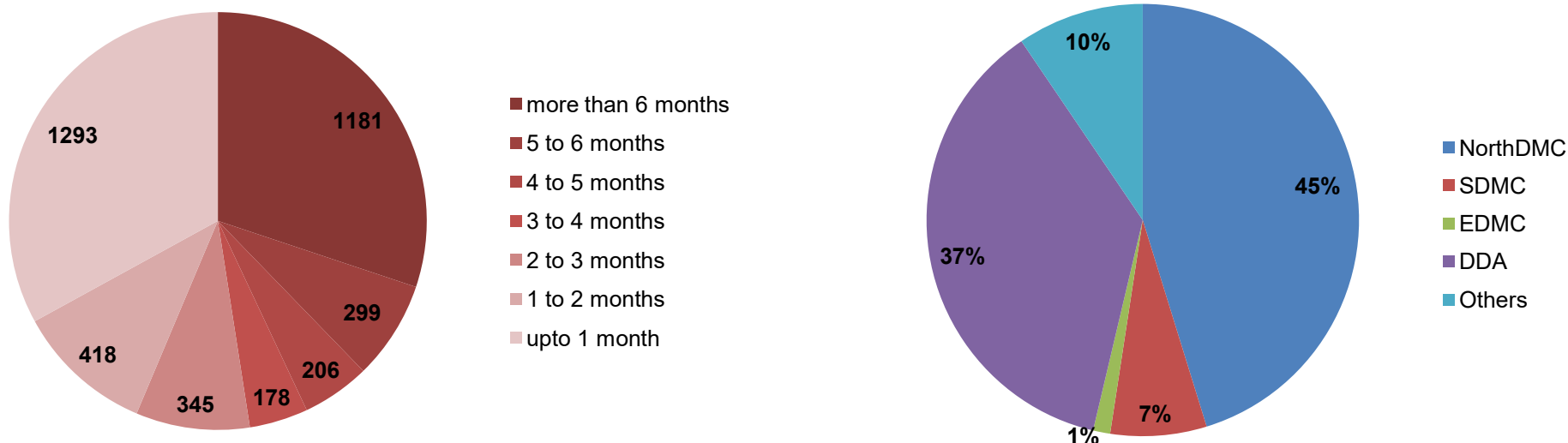

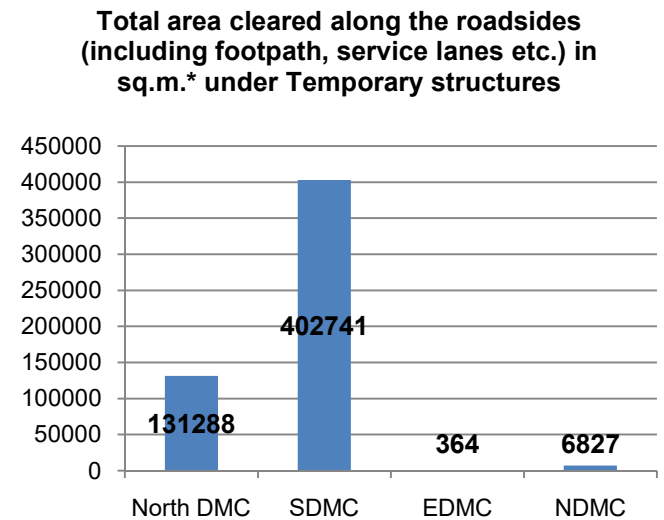

For more than 6 months old cases, North DMC has highest pendency of 534 cases followed by DDA with 435 cases. The overall pendency for more than 6 months has increased for DDA and also in the case of Revenue Deptt..The pendency has been reduced considerably for North DMC, SDMC and EDMC.

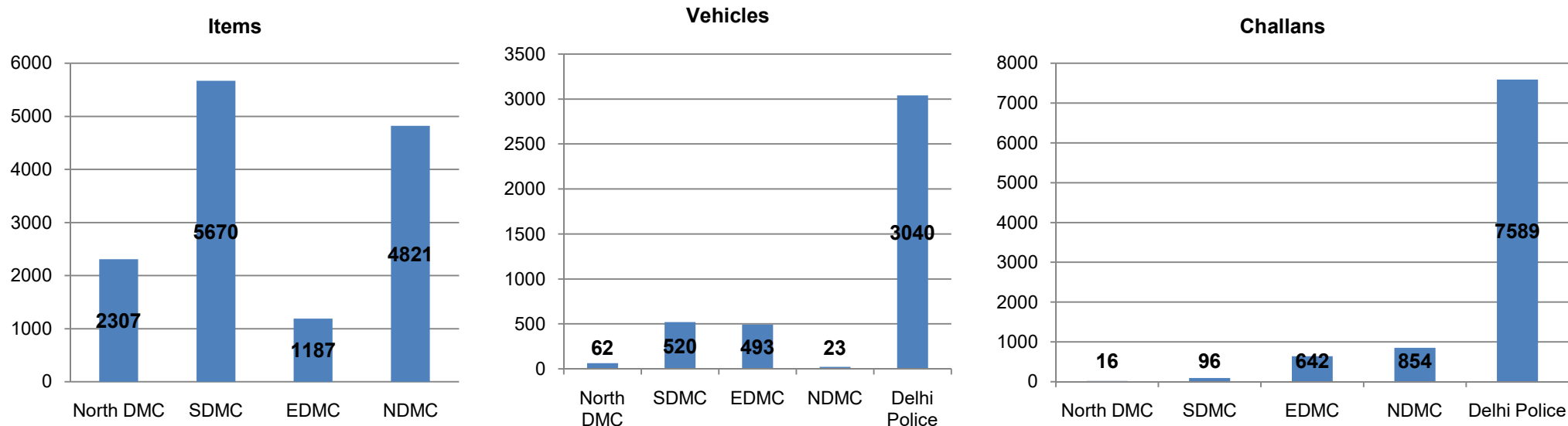
A total of 296.1 km road length has been cleared during the period. North DMC has cleared 46.4 km, SDMC 122.2 km, EDMC 103.5 km and NDMC 24 km.

A three-member committee with members from Traffic Police, concerned ULBs & PWD under Addl. CP(Traffic) was decided to be constituted to work out action plan for micro planning for removal of recurrence of encroachment and their systemic improvement in joint coordination. The recommendations are to be placed before STF.

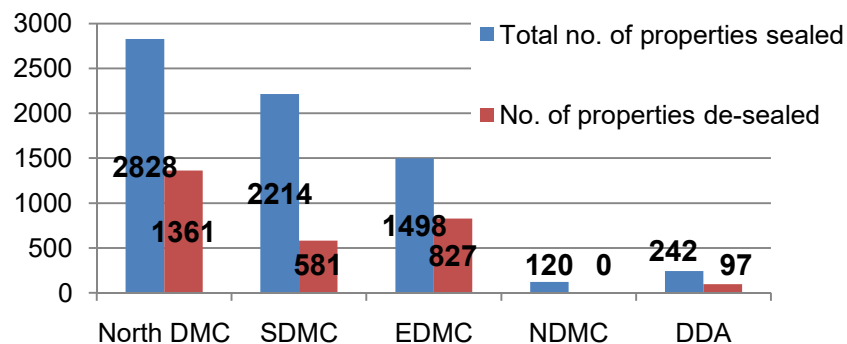

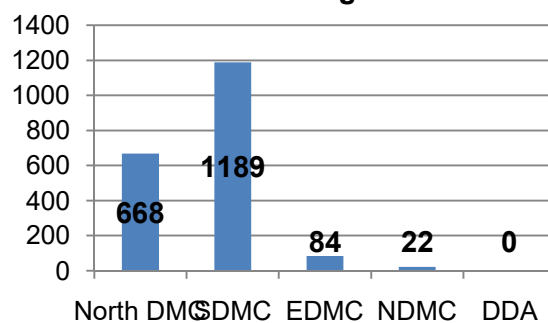

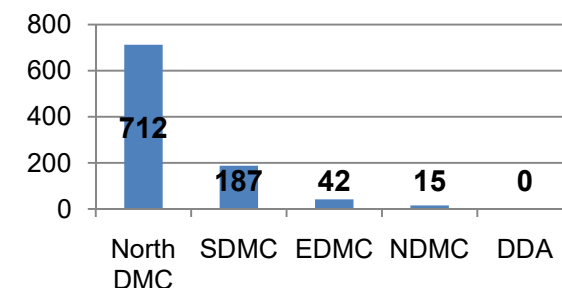
**Total number of properties sealed and de-sealed**

Zero tolerance to be adopted towards ongoing unauthorised construction. The overall pendency has decreased from 698 to 514 (decreased by 184). SDMC has the highest pendency of 213 (3.31%) followed by North DMC having 144 (3.40%), DDA having 110 (25.52%) and EDMC having 35(2.13%).

**13. Status of Complaints against Erring Officials/Officers:** Till 15.03.2021, 913 complaints against Erring Officials/Officers have been forwarded to STF out of which ATR on unauthorized construction have been uploaded on 877complaints. No ATR on the erring officials is available.

- c. Encroachment Removal Action by **NDMC** at areas including Connaught Place, Palika Bazar, Gole Market, India Gate, Man Singh Road, Lodhi Road, Khan market, Janpath, Regal and Rivoli and Shanker Market, Sarojini Nagar and Chanakyapuri and Yusuf Sarai, AIIMS, Delhi Haat, Kidwai Nagar during the fortnight.

#### **15. Other issues**

- a. Issues raised by Addl.Commr.(Traffic)- The detail report on the site visit to Five traffic congestion location identified by Addl.Commr.(Traffic) were discussed in the 58<sup>th</sup> meeting held on 11.12.2020. Chairman STF directed PWD to submit a timeline for action for removal of encroachments which were causing traffic congestion” in the 59<sup>th</sup> Meeting held on 31.12.2020. Timeline is yet to be given by PWD.
- b. The report prepared by the Committee incorporating the above has been forwarded to MoHUA on 15.03.2021. The nature of work is an ongoing one and phase wise implementation shall be done within a prescribed monitoring framework, mutually agreed by all agencies. Meetings to be conducted by the Chairman of the Committee to finalise the report within the stipulated time period. The documents submitted to MoHUA have been forwarded to all stake holders with request to participate in the meetings under Chief Town Planner, SDMC to finalise the document.
- c. The Monitoring Committee in the Report no 156 has submitted before the Hon'ble Supreme Court for order to the Revenue Authority and local bodies for detail survey of all plots/ properties allotted under 20 point programme all over Delhi. The information is awaited.
- d. Letter from DCP, Traffic (Mod.) dated 10.3.21 regarding encroachments by squatters/ Beggars at 61 junctions identified by Traffic Police causing problems in the traffic circulation and requested for inclusion of the matter in the STF meeting agenda for discussion and necessary direction/action for a hassle free traffic circulation. The letter has been forwarded to SDMC, North DMC and PWD on 23.03.2021 vide SNS2021032319
