13. Other issues

- a. NHRC case No. 5538/30/1/2019/UC dated 09.12.2019: The matter was discussed in 53rd meeting where it was decided to revisit the proposal.. As suggested in the meeting, the committee was reconstituted with 14 members. The meeting of the Committee was held on 21.10.2020, in which the issues highlighted in the report and suggestive measures were discussed. It was decided that the comments of the stakeholders are to be forwarded to Chief Town Planner, SDMC within 4 days to finalise the report. It was also decided in the meeting that the suggestions could be discussed in the first meeting of STF in the month of November.
- b. Additional Secretary, CVC vide D.O. letter no. 009/MCD/077-46215 dated 28.09.2020 to VC, DDA has forwarded the OM no. 019/MCD/031-458487 dated 27.08.2020 issued by Director-CVC. It has been informed that the reports on encroachment and unauthorized construction received from MCDs were discussed in the Commission and it has been desired that DDA may examine whether it is possible to establish a mechanism to have regular and surprise checks for encroachment and unauthorized construction.
- c. Regarding the complaint of Dinesh Chand Jain regarding encroachment of Govt DDA land of approximately 10000 square yards by the owner of Bhatia Acid Pvt Ltd. which was encroached by the said owner since last 70 years matter would be taken up on priority
- d. The old ATR as seen on the web-portal is found to have increased to 7381. There is discrepancy in the data regarding the same, which is to be fixed by the Systems Department.

Temporary structures have been removed by SDMC from road stretches in various locations at Dakshinpuri, Madangir, EPDP Road, Hansraj Sethi Marg, Shiv Mandir Marg, Jagdamba Road, Madhya Marg Tuglakabad Extn, Loadhi Road Complex, Okhla Industrial Area, Mehrauli, Amar Colony, Nehru Nagar, East of Kailash and Kailash Colony Metro station.
