- They/he shall be eligible to submit tenders for civil works upto Rs.10.00 Crore (Rupees Ten Crore only) in this department.
- (a) They shall be required to deposit earnest money with each tender as per terms and conditions
  of the Notice Inviting Tenders.
  - (b) Security Deposit will be recovered from their/his bills in accordance with the rules in force from time to time.
- 4. For the provisional revalidation of enlistment to continue beyond 30.12.2010 the contractor shall have to fulfill the conditions in respect of securing / completing works of appropriate magnitude as per the enlistment rules 2007 and department is fully satisfied that the documents so submitted are in order.

If the contractor fails to submit the required documents within the prescribed period aforesaid or the documents submitted are not found in order, the provisional revalidation shall be liable for cancellation.

- They shall employ the required staff and / or tools & plants as per terms and conditions of each contract / agreement.
- They shall have to abide by the terms and conditions of the NIT/contract/agreement as they stand or as may be altered from time to time.
- 7. They shall have to apply to the Works Contract Cell of the area in which they are assessed for grant of Sales Tax Clearance Certificate. The copy of said STCC duly attested by a Gazetted Officer or a Notary Public issued at his registered office/head office address should be submitted to this office after its receipt within a month every year. If they fail to submit the STCC, their names shall be liable to be removed from the approved list of contractors. In case of partnership firm, the names of all the partners should be mentioned in the STCC.

- They shall be issued tender on production of valid ITCC/STCC in the name and style in which they are registered bearing the name/names of the sole proprietor / partners as notified in the enlistment 9.
- They shall not be permitted to tender for works in DDA Zone responsible for award and execution of 10. contract in which their near relative is posted as Divisional Accountant or as an Officer between the grade of Chief Engineer & Junior Engineer (both inclusive). They shall also intimate to the department, the names of persons who are working with them and who are near relatives of any gazetted/first class officer in DDA. Any breach of the condition by the contractor shall render them liable to be removed from the approved list of contractors in the department.
- The enlistment notified in this order is valid for a period of 3 (three) years from the date of expiry of 11. previous registration i.e. valid upto 02.10.2013. The contractors will be required to apply for revalidations of their enlistment in the prescribed form along with all required documents so as to reach the enlistment authority atleast 6 months before the date of expiry of his enlistment.
- They are required to secure works of appropriate magnitudes in the department. In case they fail to 12. complete the work of specified magnitude during the period of enlistment, the contractor is liable to be not revalidated.
- They shall also intimate the change in their address (registered / head office) if any, in future. In case 13. they fail to intimate such change to the department, their name shall liable to be removed from the approved list of contractors.
- They shall be bound by the enlistment rules of the department as amended from time to time. 14.
- The firm shall be got registered under registration act of GNCTD before expiry of enlistment and a 15. copy of the same shall be deposited with Secretary, CRB as early as possible.
