Sub: Constitution of Internal Grievance Committee for persons belonging to SC.

In pursuance of recommendations from NCST vide D.O.No.18/01/NCST(IGRC)2021-Coordn. Dated 03.08.2021 & NCSC vide file No. 39/Misc-2/IGR Committee/2020/SSW-I dated 28.07.2020, VC/DDA had constituted an "Internal Grievance Committee" at work place for persons belonging to Scheduled Tribes & Scheduled Castes Community respectively vide circular No. F.20(03)2018/Resvn.Cell/DDA/14 dated 13.02.2023 & F.20(03)2018/Resvn.Cell/DDA/85 dated 13.09.2024. Accordingly, as per approval of Commissioner (P), DDA the new composition of the committee for Scheduled Caste is as under:

The Internal Grievance Committee will examine the complaints of the employees belonging to Scheduled Castes on matters such as (i) Non-maintenance of reservation roster and not filling up of reserved vacancies, (ii) Discrimination in promotion/seniority/MACP/ACP, (iii) Non-appointment on compassionate grounds, (iv) Adverse/downgrading of APARs, (v) Termination/dismissal from services, (vi) Discrimination in transfer/posting (vii) Denial of pensioner benefits etc. and take necessary action for immediate redressal of the grievances. The Committee will prepare monthly report and submit to the Head of Organization who will monitor the action taken on the grievances and submit a quarterly report to the commission including the reports received from the offices under the administrative control of the department.
- 3. Reservation Cell/DDA shall provide assistance to the Committee, prepare and submit Quarterly report to the Commission with approval of the Competent Authority.
- 4. Any Complaint/Grievance to the Internal Grievance Committee needs to be submitted in Reservation Cell.
- 5. This issues with the approval of the Competent Authority.
