## **NOTICE**

Delhi Development Authority had declared the list of 61 provisionally shortlisted candidates in alphabetical order on 18.10.2022 on the basis of performance of the individual candidate in Computer Based Test held on 16th August, 2022 for appearing in stage –II examination for the post of Junior Translator (Official Language).

- 2. DoPT vide O.M No. 15012/1/2022-Estt. dated 06.09.2022 has issued compilation of all relevant instructions on "Grant of relaxation of upper age limit to various categories for direct recruitment to central civil services/posts." The para 8 of aforesaid O.M deals with grant of relaxation of upper age limit for Ex-Servicemen which inter-alia provides as under:
  - "8. Ex-servicemen
  - 8.1 For appointment to vacancies in Group B (Non-Gazetted) or Group C posts in Central Government, an ex-serviceman shall be allowed to deduct the period of actual military service from his actual age and if the resultant age does not exceed the maximum age limit prescribed for the post for which he is seeking appointment by more than three years, he shall be deemed to satisfy the condition regarding age limit......"
- 3. The post of Junior Translator (Official Language) is in Level 6 equal to Grade Pay of ₹4200/- in the scale of pay of ₹9300 34,800/- in PB-2 and as such aforesaid para 8.1 is applicable to Ex-Servicemen candidate subject to fulfilling the eligibility criteria.
- 4. Sh. Akhilesh Kumar S/o Gobardhan Prasad (OBC social category & Ex-Servicemen), Roll No 110100200617, App. Ref. no DDA024909 for the post of Junior Translator (OL), was not included in the list of shortlisted candidates for Stage II examination due to his age exceeding the upper age limit and the name of Sh. Manish Kumar S/o Sh. Bijendra Singh, Roll No. 110100200368, App Ref. no DDA028731 (OBC social category) was included in the list of provisionally shortlisted candidates as per Combined Merit List and as per the criteria for the shortlisting of candidates approved by the competent authority, .
- 5. The matter has been examined in view of aforesaid DoPT O.M. and following changes is being made in the list of provisionally shortlisted candidates for Stage II examination for the post of Junior Translator (Official Language) (Post Code 05).
  - "The name of Sh. Akhilesh Kumar S/o Gobardhan Prasad (OBC social category & Ex-Servicemen), Roll No 110100200617, App. Ref. no DDA024909 has been included in the list of provisionally shortlisted candidates for Stage II examination and the name of Sh. Manish Kumar S/o Sh. Bijendra Singh, Roll No. 110100200368, App Ref. no DDA028731 (OBC social category) has been deleted from the list of provisionally shortlisted candidates for Stage II examination for the post of Junior Translator (Official Language)."
- 6. The list of provisionally shortlisted candidates declared on 18.10.2022 will remain unchanged except changes as mentioned in Para 05 above.
