Title of Agenda: Sub-division Plan of CS/OCF Pocket between B-2 & B-3 (Residential Pocket), Sector-XVII, Rohini, Phase – I & II.

Synopsis

There is a request from I.L. Branch for the allotment of land for Dispensary of Delhi Government in Sector - XVII, Rohini, Phase – I & II. The proposal for sub-division of vacant CS/OCF Pocket between B-2 & B-3 is placed before Screening Committee for consideration and approval.

### 1. BACKGROUND

In the approved Layout Plan of Sector XVII, Rohini, Phase –I & II, there are two CS/OCF Pockets. Out of which, one Pocket of CS/OCF between A-1 & A-7 is already designed and developed and other Pocket of CS/OCF between B-2 & B-3 is lying vacant and needs to be planned and design to fulfil the requirement of neighbourhood level facilities.

### 2. EXAMINATION

- (i) There is a request from I.L. Branch vide letter No. F.22(Misc)2011/IL/954 dated 25.5.2012 for the allotment of land for construction of Delhi Government Dispensary building in Sector 9, 15, 16, 17, 24 & 26, Rohini. In this regard, a letter was sent by Dir. (Plg.) Rohini vide letter No. PPR/Misc/2003/210/17 dated 09.01.2012 to Dy. Dir. (I.L.) with the observation for possibility of dispensary to be explored in unplanned O.C.F. Pocket in Sector XVII.
- (ii) In the CS/OCF Pockets, E.S.S. measuring 243.0 m<sup>2</sup> and Police Post measuring 1462.5 m<sup>2</sup> are already existing. On the basis of the joint inspection of site by L.M Branch and Asstt. Dir. (S) Rohini dated 09.12.2013, the area measuring 273.75 m<sup>2</sup> yet to be acquired and is not a DDA land in CS/OCF Pocket.
- (iii) The Proposal for the remaining vacant land is based on the survey supplied by Dy. Dir. (S)/ Rohini dated 12.04.2013. As per Master Plan for Delhi-2021 and Zonal Development Plan of Zone 'H', the landuse of this Pocket is "Residential".

# 3. PROPOSAL

The proposal for the sub-division of CS/OCF Pocket between B-2 & B-3, Sector XVII, Rohini is as per details given in area statement placed for consideration and approval by the Screening Committee DDA. The development control norms will be as per MPD-2021.
