Synopsis

Modified Plan of LS&OCF Plot in Pocket G-20 & G-21 and Pocket B-5 & B-6 Sector VII, Rohini, Ph-I & II is placed before Screening Committee for consideration and approval.

1.0 Background:

A meeting was held under the chairmanship of VC,DDA to discuss the issues raised by Sh. Vijendra Gupta, Authority Member/Hon'ble MLA on 27/08/2015and 08/02/2016. In the meeting, it was discussed to carve out a plot for Multipurpose Community Hall from the site earmarked for LSC/OCF near pocket G-20 & G-21,sector-VII, Rohini, Ph-I & II.

2.0 Examination:

- i. As per Master Plan for Delhi-2021 and Zonal Development Plan of Zone-'H', the landuse of the pocket under reference is 'Residential'.
- ii. The layout plan of Sector-VII, Rohini was earlier approved. As per the vacant land inventory sent by Engineering Wing, DDA, the plot under reference is lying vacant and reserved for LS/OCF use for residents of the area.
- iii. As per the approved layout plan of Sector –VII, Rohini, total twelve nos. of LS/CS/OCF pockets are earmarked. Out of which nine nos. of pockets have already been developed and remaining three are lying vacant.
- iv. LS/OCF plot is earmarked between G-20 and G-21 pocket and another LSC/OCF plot between pocket B-5 & B-6 having nearly equal area is earmarked and lying vacant at site. Since both the plots are earmarked for LS/OCF plots having approx. equal area, LSC/OCF plot between G-20 & G-21 pocket is proposed for other community facilities plot (Multipurpose Community hall) and another plot is between B-5 & B-6 is proposed for Local shopping Centre.
