I, DVB vide letter dated 7/10.2.97 has submitted the proposal for the laying down of 2 Nos. 33 KV 3X300 sqmm XLFE under ground connecting cables the existing 33 KV S/Stn. at Karkardooma to proposed 33 KV S/Stn. at Krishna Nagar (Old Seelampur) as per Delhi Vidyut Board this is required to meet the growing power demand of Krishna Nagar, police staff quarters under construction, Kanti Nagar, Old Seelampur and its adjoining areas. A plot has been handed over to DVB on 20.9.96 by FWD, GNCTD. The length of this proposed under ground route is 3.4 Km. as shown in the DVB drawing No.13-4508(laid/on table) The location plan is placed at Annexure.....I.

2.0 ROUTE DETAILS:

The route starts from the existing 33 KV s/stn. at Karkardooma facing road no. 58. The cables have been proposed in the green area at a distance of 8.5 M from the boundary wall of the Distt. Court Shahdara. (Ref. Section A-B).

- 2.2 On Road no. 57 the cables have been proposed in the Eastern foot path at a distance of 14 M and 13.25 M from the centre of the existing centre verge (Ref. Section BB and CC).
- 2.3 The cable have been proposed in the carriage way of the 5 M wide road between the Kanti Nagar (West) and Drain no. 1 at distance of 1 M from the boundary wall of the Drain/Nallah. (Ref. Sec.DD).

3.0 DDA OBSERVATIONS

As per the Master Plan and Zonal Plan the right of way of the road No. 58 is 45 M. But the available R/W is 57 M. at this specific location. The alignment plan of this road stretch has not been prepared/approved by the DDA. The cables be laid at a distance of 22.8 M from the centre of the existing

Central verge as per section(AA) on the Northern side of the road.

- 3.2 As per the Master Plan and Zonal Plan the R/W of the Road no. 57 is 45 M. The elignment plan of this road has not been approved by the DDA. The cables be laid in the eastern footpath at a distance of 13.5 M from the centre of the existing centre verge.
- 3.3 As per the plan prepared and approved by the DDA for the site of Police Line, as approach road of 18 M R/W has been proposed for providing the entry to the Police Sines the route be taken from this road but this road has been encroached and is sub-judice.
- 3.4 The route has been proposed below the carriageway by DVB on the 5 M road adjoining the Drain at a distance of 1 M from the boundary wall of the Nala/Drain is not desireable due to less R/W of the road and has been proposed to be taken under the main carriageway of the road.

4.0 FEASIBILITY

As per the feasibility report sent by the FE(Plg.) I'DVB that no trees and structures are affected in this proposal as explained in para 2.0 above and is feasible economically viable.



Executive Engineer (Plg.V) DVB vide letter dated 2.2.98 has submitted the above said route proposed to . face Jasola Residential Scheme which includes Commercial Centre and Facility Centra

The proposed 66 KV D/C Tower line shall connect the existing 66 KV D/C Tower line at Sarita Vihar and will pass along Road No. 13A to connect proposed 66 KV S/Stn. at Jamola.

The length of the route is 500 mtr. and is overhead as shown in the drawing No. XEN PL-2-14 (laid on table). The location plan is placed at Anne.I.

- 2.0 ROUTE DETAILS:
- 2.1 The route starts from the 66 KV DC/Tower line existing along North side on Road No.13-A by Loop in Loop out to connect proposed 66 KV S/Stn. Jasola on H.T. Pylons width of the corridor varies from 3 m to 3,8 m. 11 Nos towers has been proposed in this route proposal.
- 3.0 DDA OBSERVATIONS:
- 3.1 Two alternatives for U/G route were suggested by the Dir./Landscape.

Alternative-I: was suggested to pass along the periphery of the Sports Complex from H.T. Tower to proposed S/Stn. at Jasola.

Alternative-II: has been proposed on the Internal Road of Jasola Scheme in the footpath portion.

- 3.2 EE (DVB) vide letter dt. 9.6.98 has intimated that the underground route is not possible due to the high cost factor and then proposed the over head route passing through the Road No.13A of the Jasola Scheme with 7 Nos of H.T. Poles/Towers.
- in the meeting held under the Chairmanship of Commr. (Plg.). After considering the constraints explained by DVB it was agreed that DVB shall provide only two towers of 3 mtr. S.Q. Base. One H.T. Tower has been proposed in the Foot Path portion at the junction of 45 M. R/W Road (Road No. 13A) and Jasola Scheme Road and Second Tower is proposed on the footpath near the proposed 66 KV S/Sto. and then taken the route in the proposed S/Sto. directly (The modified route is shown on Annexure-I).

This has been agreed by Commr. (plg.) as a very special circumstance & advised DVB to provide U/G H.T. lines specially on 24 mtr. R/W roads.

4.0 FEASIBILITY:

As per the feasibility report sent by EE(Plg.-V) dt. 2.2.98 no trees and structures are affected in this proposal.

5.0 RECOMPENDATIONS FOR CONSIDERATIONS

The route proposed by DVB as explained in para 2 and modifications as per para 3.3 is placed before the Technical Committee for consideration and approval.

1.0 INTRODUCTION:

has submitted the above said route proposal to give additional feed to Dwarks Puri Sub. Station to meet the growing power requirement of Navin Shahdars.
Subhash Park Welcome Colony etc. The Kashmere gate 5-Stn. 220-33 KT Tower line are existing and D-warks Puri S/Stn. is under Contruction. The length of the route is 2.65 km and proposed to be laid under ground as showing in PVS drawing No. 13-4535(laid on table). The location plan is placed at Annexure-I.

2.0 ROUTE PSTALLS

- 2.1 The route starts from the H.T. Tower No.11 which is part of Kashmere Gate-South of Wazirabad 220 KV Tower Line, the present proposal will be passing below the foot path of approach road to I.S.B.T. bridge at a distance of 16.50 meters from the centre of the existing central verge (ref. section AA!) up to the GT Shahdara Road.
- 2.2 On G.T. Shahdara Road, the route has been proposed after crossing this road on the Southern footpath at a distance of 13.75 m/14m from the centre of the existing centre werge (ref. station 'BB' and 'CC' upto Bhishampitamah marg/ Road No. 57).
- The route now proposed will be cross over from the G.T. Shahdara Road to the Eastern side of the road below the foot path at a distance of 9.5m from centre of the existing 15 M wide carriage way of Bhisam Pitamah Mang and connect to proposed S/stn. at Dwarka Puri by crossing the road.

3.0 DDA OBSERVATIONS:

The R/W of the approach road to ISBT is 60 m and the cables has been proposed below the Northern foot path at a distance of 16.5m from the existing centre verge is acceptable.

3.2 • The route could not be proposed along the Northern foot path of G.T. Shahdara road as number of under ground cables are existing as informed by officer of DVB.

However, as per the approved plan of G.T. Shahdara
Road prepared by NATPAC for MCD(Approved by Authority
on dt. 1.12.92 vide item No.151/92) the cable provision has been made under the proposed Southern Foot
path at a distance of 16 metre from the existing Centre of the central verge up to the junction with
Bhisham Pitamah Marg. Where as DVB proposed the cable
at 13.75 M/14M which is not acceptable to DDA. Ther efore it is proposed that this should be proposed at
16.0 M from the centre of the central verge under
the foot path.

As per the MPD-2001 the r/w of the Bhisham pitamah road is 45 m where as in the Zonal plan of Zone 'E' this has been shown as 30m. An alignment plan of the road was approved by the DDA on dt. 4.12.75 vide item No.118 with a r/w of 45 m. It is now recommended by us that this cables may be laid on the western side of the road with in the r/w at a distance of 8.5 m. from the western edge of the r/w line along with the other two under ground electricity cables.

4.0 FEASIBILITY:

As per the feasibility report sent by EE(plg.) DVB no tree are affected in this proposal and there is no other possible route as it is Techno-economical viable.

The route proposed by DVB as explained in para 2 above and the modifications proposed in para 3 above is placed before the Tech. Committee for Consideration and approval.

Sub: Proposed modifications in building permission on residential plots in Rohini. F.PA/Dir.(Bldg.)97/DDA/4162

- 1.1 In the Robini Scheme plots of various sizes from 26sqm. onwards had been allotted to EWS/LIG/MIG categories. Standard design for such plots were also prepared and supplied by the DDA to the allottees so that they could get instant sanction for construction of houses as per design.
- 1.2 It has been observed that there are frequent deviations from approved building plans some of which are non-compoundable attracting action under section 30,31A of Delhi Development Act, 1957.
- 1.3 This was discussed earlier in the Technical Committee in its meeting held on 14.9.93 (Item No.94/93) which decided the following: -

Development Controls provided in Development of MPD-2001, applicable to residential plots with regard to coverage, FAR, height, basement, setback, be followed. Extra coverage/FAR only to the extent of 5% or 13.5 sqm. whichever is less, as being followed may also apply on plots in Rohini Scheme. In no case, building should be allowed on road and common lands".

- 1.4 Keeping in view various representations, the matter was further considered by the Technical Committee in its meeting held on 12.11.97 vide item no.53/97. The proposals included regularisation of porjections on public lan d, regularising ramps upto 90 cm. outside the plot and additional FAR etc.
- 1.5 Technical Committee deferred its decision and recommended a site visit alongwith VC,DDA.

Accordingly, a site visit was undertaken by the VC alongwith other officers on 27.2.98. A copy of the inspection note is placed at Annexure 'A' for information of the Technical Committee.

1.6 According to the inspection note as well as Technical Committee decision dt.14.9.93, it is recommended that the provisions of MPD-2001 may be made applicable in Rohini also.

According to Building Bye-laws, 83 Robini has been excluded. However, under clause 2.03 of BBL the following is mentioned:-

"All mandatory Master Plan/Zonal Regulations regarding use, coverage, FAR, setbacks, open space, height, number of storeys, number of DU's, parking standards etc. for various categories of buildings including modifications thereia made from time to time shall be applicable mutatis-mutandis in the building regulations under this, clause. All amendments/modifications made in these regulations will automatically be included as part of these Bye Laws".

In view of the above, the development control norms for residential plots as given in MPD-2001 are applicable in Rohini and accordingly their building plans/completion plans are recommended to be processed as per the provision of MPD-2001. However, for extra floor space permitted over and above the standard plans, betterment charges may be recovered at already prescribed rates. The compoundable limit and other provisions including projections, chajjas, ramps shall be regulated as per the provisions of MPD-2001 and BBL. It is expected that this will provide substantial relief to the plot owners of Rohini and pendency of completion certificate will also be reduced.

The above proposal is put up for consideration of the Technical Committe.

- 1. During the site inspection, it was noted that the projections on public land are frequently occurring in Rohini. It was observed by VC that as a basic principle, any encroachment or projection on public land which does not affect or cause hazard to the community, or affects services and pedestrian movement can only be considered for compounding or regularisation.
- Wherever the provisions of MPD-2001/BBL-83 (with respect to ground coverage, FAR etc.) are not applicable, action may be initiated to get the permission so that they are applicable to Rohini also.
- 3. For access to the plots, a ramp or steps upto 90 cm. length and 90 cm. width may be allowed which should be constructed in such a way that it does not hamper smooth flow of drain and allows its regular cleaning.
