HON'BLE LG DELHI CHAIRS AUTHORITY MEETING, APPROVES MASTER PLAN 2041

The Delhi Development Authority (DDA) in its meeting chaired by Lt. Governor, Shri V.K. Saxena, who is also Chairman, DDA, took major decisions, including approval of the draft Master Plan 2041, which will usher a new era of development and will guide future growth of the national capital. The Authority also took a decision for relaxation in guidelines pertaining to female beneficiaries for In-Situ Rehabilitation under Jahan Jhuggi Wahan Makan programme.

Opening a marathon meeting that went on for more than three and a half hours, the Lt. Governor, Shri V.K. Saxena said that, the thrust of MPD-2041, was inclusive development, environmental sustainability, green economy, infrastructure development that included sufficient housing for all sections of the society, innovative interventions like TOD Hubs, Land Pooling, Green Area Development and Rejuvenation and Regeneration of the City.

The Authority Meeting was attended by Shri Subhasish Panda, Vice Chairman, DDA, and other members.

Details of the major decisions taken are:

Master Plan 2041:

Master Plan for Delhi prepared by Delhi Development Authority is a statutory document that facilitates Delhi's development by assessing the present condition and guiding how to achieve the desired development.

The first Master Plan for Delhi was promulgated in 1962 under the Delhi Development Act 1957. These plans are prepared for 20 years' perspective period and provide a

holistic framework for planned development of Delhi. The Draft MPD-2041 is a 'strategic' and 'enabling' framework to guide future growth of the city, built upon the lessons learnt from the implementation of the previous plans and based on learnings from across the country with respect to implementation of various projects and schemes.

Draft Master Plan for Delhi-2041 (MPD-2041) has been divided into 2 Volumes & 10 Chapters. Vision for MPD-2041 is to **"Foster a Sustainable, Liveable and Vibrant Delhi"**.

The following three Goals will be pursued over this Plan period for overall happiness & well-being of its inhabitants:

- (i) Goal 1 (G1): Become an environmentally sustainable city that provides a healthy environment for its citizens, is resilient to impacts of climate change and disasters.
- (ii) Goal 2 (G2): Develop as a future-ready city that offers good quality, affordable and safe living environments with efficient services and green mobility systems.
- (iii) Goal 3 (G3): Emerge as a dynamic place for economic, creative and cultural development.

Structure and contents of MPD 2041 document

The Plan comprises of two volumes as given below:

- **Volume 1: Vision 2041 and Enabling Policy Framework**

First chapter, which further contains six chapters covering strategies for (i) Environment, (ii) Economy (including trade & commerce, wholesale trade, industry and Government offices), (iii) Heritage, Culture and Public Spaces,

- (iv) Shelter and Social Infrastructure, (v) Transport and Mobility, and
(vi) Physical Infrastructure.

- **Volume 2:** Framework for Spatial Development, Plan Monitoring and Development Code & Development Control Norms, which contains spatial strategies, planning and development control norms for guiding future development in Delhi.

This chapter also covers the Plan Monitoring and Evaluation Framework for the Master Plan with suggestive key performance indicators to monitor progress and an implementation framework to facilitate periodic review.

Salient Features of Draft Master Plan for Delhi-2041

The Draft Master Plan for Delhi- 2041 is prepared based on extensive citizen and stakeholder engagement which includes Govt. Departments, Local Bodies, RWAs, Traders and Market Associations, NGOs, Organizations, Professionals, Experts and Individuals, etc. which form the basis of the exercise for vision of future for Delhi

The key features of the plan are:

- i. Master Plan will be a more people-friendly document, easy-to-read and understand by general public apart from professionals.
- ii. GIS-based land use plan is developed which will enable stakeholders in ease of understanding of applicability of policies/provisions of Draft Master Plan on ground more precisely.
- iii. Development control norms related to use premises and activities, flexibility in use, parking requirements, mixing of uses, etc. have been simplified and enable flexibility to meet future developments and people's needs.

- iv. The Draft Plan prioritizes protection and improvement of good quality green-blue assets for active/passive recreation and leisure. This includes biodiversity parks, integrated floodplain planning, revival of baolis/ water bodies, development of walking and cycling trails along with the rejuvenation of drain buffers. Buildings will also be required to meet Green-Blue Factor (GBF) conditions to ensure sustainable development practices.
- v. Additionally, the plan also proposes the rejuvenation of the Yamuna River and its floodplain through preparation of Comprehensive River Development Plan for river Yamuna.
- vi. Enhance Delhi's preparedness for Climate Change impacts and in tackling pollution.
- vii. Plan proposes to promote clean economies such as IT/cyber hubs, knowledge-based industries, and R&D facilities. New industrial activity in the National Capital Territory of Delhi is restricted to hi-tech and service-based industries.
- viii. The plan proposes to provide development strategies for strategic hubs and centers, including Business Promotion Districts and Transit-Oriented Development Nodes, as well as modernization of existing District Centers.
- ix. Plan proposes to encourage the development of a Night Time Economy for safe and vibrant city.
- x. The Plan includes norms for Heritage Zones, Archaeological Parks, and Cultural Precincts, as well as instruments for improving conservation of heritage building to promote Delhi's rich history and culture.
- xi. Plan suggests for identification and preparation of Conservation and Revitalization Management Plans (CRMPs) for cultural precincts, permits adaptive reuse of heritage building.

- xii. The plan also proposes to promote the development of cultural and entertainment hubs.
- xiii. Emphasis on development of city hubs, circuits, plazas, and night time circuits. Specific corridors and trails will be identified for promoting the night time economy.
- xiv. Boost housing supply, by private participation through land pooling & regeneration of planned and unplanned areas with incentive FAR.
- xv. Plan proposes development of non-ownership/Rental Housing and Affordable Rental Housing Complexes (particularly close to mass transit) with new formats like serviced apartments, condominiums, hostels, student housing, worker housing, etc. to meet housing supply demand in existing developed areas
- xvi. Plan proposes for preparation of Comprehensive Mobility Plan (CMP) to integrate land use and transportation, Transit-Oriented Development, and strategic mobility corridors for intra-city and inter-city movement.
- xvii. Plan proposes parking management and promotes green mobility, such as the use of E-vehicles and E-charging infrastructure.
- xviii. Physical infrastructure plays a crucial role in urban development, as it provides the basic framework for any urban area to function and grow sustainably. Strategies are provided for reuse of treated waste water, dual-piping systems, green rating, promotion of renewable energy, optimizing utilization of resources, waste management including C&D waste.
- xix. Plan permits flexible loading of Floor Area Ratio (FAR), Transfer of Development Rights (TDR) receiving areas, and additional development controls to promote walkability, sustainable design, active frontage, and other sustainable urban planning principles in land pooling areas.

- xx. GDA proposes to provide an integrated policy covering Low-Density Residential Area (LDRA) and Green Belt.
- xxi. Provisions made for regeneration of existing/ brownfield areas through retrofitting, reconstruction or area-level redevelopment which shall cover planned areas such as planned residential colonies, Commercial, Industrial, PSP & BPD, and unplanned areas such as Un-authorized Colonies, JJ Clusters, Urban Villages, Non-Conforming Godown Clusters & Non-Conforming Industrial Clusters.
- xxii. Regeneration in the old and dilapidated areas, re-densification of areas by providing incentives for planned redevelopment and/or retrofitting of areas; improve area-level safety and disaster resilience and increase availability of social infrastructure.
- xxiii. Improving social infrastructure in existing areas through regeneration, particularly dense areas like urban villages and unauthorized colonies.
- xxiv. Compact and sustainable development through TOD based projects to bring jobs and homes closer to mass transit. Provisions made for identification of more potential TOD nodes.
- xxv. Twenty Key Performance Indicators (KPI) are suggested for motioning and periodic review of the plan.

The Draft Master Plan for Delhi -2041 was approved today by the Authority and now it will be forwarded to Ministry of Housing and Urban Affairs for final approval and notification.

Regarding resolution of the issues arisen in the cases of eligible beneficiaries of In-situ rehabilitation projects being undertaken by DDA: Policy of Delhi Development

Authority stipulates that allotment of Flats/ Dwelling units has to be made in the joint name of Husband & Wife even though the allottee may be male spouse. It has been prescribed with the objective to ensure that female becomes partner in ownership of the allotted flat and thereby empowering the women. However, while making allotment in favor of JJ Dwellers under the In-Situ Rehabilitation Scheme at Kalkaji, it has been observed that in a number of cases only female spouse is occupying Jhuggi Jhopdi and male spouse is reported to be missing, deserted or dead. Such female beneficiaries don't have the legal documents such as valid decree of divorce, death certificate or any declaration w.r.t. missing person by the competent authority/ court. Need has been felt to relax the above condition so that benefits of In-Situ Rehabilitation Scheme are not denied to genuine female beneficiaries.

For successful implementation of in-situ Rehabilitation projects and in order to provide relief to the beneficiaries of all such projects, it was decided that possession letter may be issued in the single name of women spouse occupying the jhuggi in such cases.

HON'BLE LG DELHI VISITS PALAASH FLOWER FESTIVAL IN ROHINI



The Lt. Governor of Delhi, Shri Vinai Kumar Saxena, visited Palaash, the two-day flower festival at Swarn Jayanti Park, Rohini on the 25th of February. While appreciating the flora put on display, Shri Saxena said that along with others, this festival was another step towards in making Delhi - a City of Flowers. Shri Subhasish Panda, Vice Chairman (DDA) along with officials of DDA were also present during the visit.

The event, starting from 25th February, is named Palaash after the flower of Butea Monosperma, which blooms in the capital during this time. Palaash is also known as the "Flame of the forest" because of its bright and invigorating fire-like blossoms and the flower has many dimensions to itself. The Goddess of knowledge, creativity and music, Devi Saraswati, is fond of Palaash flowers. The festival has a goal towards a cleaner and greener Delhi and will raise awareness about ecological development.

The objective of the festival is to promote and encourage employees of the organization to work towards the betterment of DDA greens. The grass-root level workers got an opportunity to display their skills while a healthy competition amongst them was promoted. During the festival, various divisions of Horticulture Department of DDA competed, showcasing the beautiful work done by them, which was judged by a learned jury.

A positive by-product of the competition was an opportunity given to the public to enjoy a display of flowers with various attractions like folk performances organized by the Ministry of Culture, pottery making for those who have the knack for it, painting competitions for school children, and much more. Food stalls with lip-smacking street delicacies from different regions of India acted as an attraction for the visitors at the festival.

There was an exhibition of species like, Geranium, Gerberas, Gladiolus, Ferns, Palms, Philodendrons, Crotons, Dracaenas, Ficus, Asters, Candytuft, Carnations,

Gazania, Marigolds, Nasturtium, Pansies, Petunia, Phlox, Lilies, Salvia, Verbena, etc, their arrangements in bouquets, garlands, hanging baskets etc.

The event captivated a big crowd, which was acquainted with different aspects of flowers, ornamental, seasonal and perennials, shrubs, hedges, succulents, trees, their propagation and gardening. The visitors also got insights to the efforts and contributions being made by DDA for fighting with the alarming levels of pollution in Delhi and beautifying the National Capital Territory.



RELAXATION IN HOUSING REGULATIONS

Ministry of Housing and Urban Affairs (MoHUA) has approved modifications/ relaxations proposed by Delhi Development Authority (DDA) in Housing Regulations 1968 which were issued under section 57 of DDA Act, 1957. The objective of the modification/relaxation was to enable general public to buy DDA Flats without much restriction/hassle. The salient features of approved modifications/relaxations in Regulations are as follows: -

- I. Any person having less than 67 sq. mtrs. Flat or Plot in Delhi now became eligible to apply for allotment of newly constructed flat offered by DDA for the first time. The main Regulations didn't allow any person to apply for allotment of DDA flats, if he/she or family members were having any flat/plot irrespective of area of flat/plot.
- II. Waiting list of a main Housing Scheme shall be 100% of the total flats offered under the respective Housing Scheme. Till now numbers of wait listed applicant were restricted upto 25%. These wait listed applicants are allotted, surrendered/cancelled flats through a mini draw.
- III. If more than 25% flats remain unsold in any area/locality on closing of the Housing Scheme in which they offered for the first time, such locality/area shall be deemed to be a 'Developing area'.
- IV. No restriction in terms of having flat/land in Delhi shall be applied on applicants as and when such unsold flats located in developing area are offered under the subsequent Housing Scheme.
- V. Apart from individual/s, certain Government entities like Central Govt., State Govt., Local Bodies, Autonomous Bodies of Central/State Govt. shall be eligible for allotment of flats.

VI. Apart from disposal of flats through launch of regular Housing Scheme, unsold flats in developing area may be offered through online mode on FIRST COME FIRST SERVE BASIS.

The above modifications/relaxations on the one hand will enable those individuals to buy DDA flats who were not eligible due to having land/flat in Delhi either his/her own name or in the name of his/her family members. On the other hand, it will adequately generate demand for DDA flats.

DDA TAKES VARIOUS STEPS TOWARDS COMPLETE DIGITALIZATION OF ITS PROCESSES

To promote Government of India's Digital India initiative for general public to avail services at their own convenience, DDA has taken various steps to move towards complete digitalization of its processes.

Some of the recent initiatives introduced are various applications like, AWAAS for Housing (Applicants can do all the formalities for application, payment and possession online), BHOOMI for Land Disposal (Design, development and implementation of online services in Land Disposal Department), Provakil for Court


Computerized Nagric Suvidha Kendras & PMUDAY Processing Centres established throughout Delhi

Case Management (To track court proceedings and compliances), DDA-311 for Grievances Monitoring and STF for Complaints Management. These are implemented fully online in a seamless manner.

Computerized Nagric Suvidha Kendras and PMUDAY Processing Centres have also been established throughout Delhi.


Public-centric activities like conversion, lease restoration, allotments, bookings, tendering, E-auction, procurements, payments, engineering measurements, grievance redressal, visitor appointments are now functional online. This will increase transparency and services would be completed in a time-bound manner.

In addition, for MPD-2041, for receiving suggestion and feedbacks from general public, an online system is already established.

Geographical Information System for digitized layout plans of Delhi has been launched for easy access to public.

A special software LIMS (Land Information Management System), has been developed to manage land records and to digitize maps of about 240 villages of Delhi. It includes online damage collection, online demolition programs management etc. as well.



Steps towards DIGITALIZED DDA

Digitalized Services

- MPD-2041 online system already established for receiving feedback from public
- Geographical Information System (GIS) launched for easy access to digitized layout plans of Delhi
- Land Information Management System (LIMS) developed to manage land records & digitize maps of about 240 villages of Delhi
- For physically pointing any allotted plot on the field, layout plans of Delhi have been digitized under Geo-MAPS-Geoportal
- For Encroachment detection & control 3000 vacant land parcels digitized & handed over to ISRO for mapping

For physically pointing any allotted plot on the field, the layout plans of Delhi have been digitised under Geo-MAPS-Geoportal.

For encroachment detection and control on DDA Land, about 3000 vacant land parcels of DDA have been digitized and handed over to ISRO (Indian Space Research Organization) for mapping.

A new website (www.dda.gov.in), of DDA has been launched with substantial information which would be useful for public. The website is de-centralized and respective departments are uploading their contents regularly. This would help the public to keep themselves well informed with the current and upcoming launches related to DDA for affordable housing and other offers.

Furthermore, about 6 lacs files have been digitized and computerized record rooms have been setup for fast record and files retrieval.

DDA has also introduced various other e-Governance initiatives.

E-Office, E-HRMS and E-mail services of NIC Govt. of India have been implemented for online file and paper movements and for employee to manage the daily processes with their digital signatures. About 15000 files are now online.

Projects in pipeline

There are still many other projects under development to further the scope of digitalized DDA:



1. Online user-friendly Public Grievance Redressal, Accounts department's in-depth automation, Latest Bio Metric Attendance and Computerisation of the Sports Complex activities.
2. Possibility is being explored to develop applications using artificial intelligence for grievance redressal purpose and analysis of social media to find out the real cause of grievances of the public for their due redressal.
3. All data of automation activities is being migrated to NIC Servers for security and protection of data.
4. All remote offices of DDA are also being connected through lease lines to have seamless functioning and integration.
5. The integration with DG Locker will be done to issue all documents online and also for record keeping.



DDA TAKES VARIOUS MEASURES IN PROMOTING SPORTS INFRASTRUCTURE IN DELHI

Sports play a pivotal role in overall growth and development by contributing to physical fitness and mental health. Realizing this, Delhi Development Authority has taken various measures in promoting sports infrastructure in the national capital.

At present, DDA has 15 sports complexes, 3 mini sports complexes, 2 public golf courses, 17 swimming pools and 40 multi-gyms in various parts of Delhi so that general public can use the facilities closer to their residence by paying a nominal fee.

CWG Village Sports Complex, Chilla Sports Complex, Poorvi Delhi Khel Parisar and Yamuna Sports Complex are located in East Delhi while Dwarka Sports Complex, Hari Nagar Sports Complex and Paschim Vihar Sports Complex are in West Delhi. In North Delhi, DDA has Major Dhyan Chand Sports Complex, Rashtriya Swabhiman Khel Parisar and Rohini Sports Complex, while Netaji Subhash Sports Complex, Saket Sports Complex, Siri Fort Sports Complex, Squash & Badminton Stadium and Vasant Kunj Sports Complex are located in South Delhi.

Besides, DDA is also managing 2 world class golf courses- Qutab Golf Course and Bhalswa Golf Course.

Besides, Centre of Excellence is being developed in many sports like wrestling, weight lifting, boxing, judo, kabaddi, tennis, shooting, football and hockey. A public golf course is also being developed at Sector-24 Dwarka, which is likely to be completed by December 2023.

In Sector-8 Dwarka, Centre for Excellence for Wrestling, Boxing, Judo/Karate is being developed, while Centre for Excellence for Hockey & Football is coming up at Sector-23 Dwarka. At Sector 19 Dwarka, Centre for Excellence for Tennis and Shooting is being developed. All these projects are likely to be completed by end of this year.

Centre for Excellence for Aquatics is coming up at Sector-33 Rohini, which is likely to be completed by mid of next year. Besides, Centre for Excellence for Athletics is coming up at Sector A-7 Narela. Another Sports Complex is also being developed at Sector 34 Rohini.

At Sector-19B Dwarka, Integrated Multi-Sports Arena is in the pipeline on Design, Build, Finance, Operate and Transfer (DBFOT) Basis on PPP Mode.

These mega projects will not only promote sports in the city, but will also contribute to the Ease of Living for the people of Delhi. It will contribute immensely in nurturing future champions and young talent of the nation.
