Online tenders are re-invited through e-tendering mode on behalf of Chairman, Delhi Development Authority for the following works at Qutab Golf Course, DDA for a period of one year (twelve months) and same shall be extendable upto three years on monthly license fee basis. **The tender shall be in two parts viz ‘Part -I’ containing Technical Bid and ‘Part – II’ comprising ‘Financial Bid’.** Only those agencies having a minimum of two years experience in the field of running a caddy canteen (Breakfast, Food and snack etc.) during the last five years in government department/public sector undertaking with **minimum turnover of Rs. 5 lacs in the last two financial year are ending March 2020 duly certified and audited Chartered Accountants having valid UDIN No. are entitled to apply. Bids not submitted in accordance with the prescribed manner will not be accounted for.** The caddy Canteen is located at Qutab Golf Course, DDA, Press Enclave Road, New Delhi – 110017.

**In Part – I** of the tender, i.e. Technical Bid, the tenderer shall upload details of ownership/management of the agency, experience of similar nature of works undertaken by them i.e. copies of award letters and certificates of satisfactory completion, duly attested, authenticated proof showing annual turnover, manpower available with them, their qualifications and experience in the field etc. In case of company / firm, an attested copy of registration certificate and Article of Association is also to be furnished. In case of a partnership firm, the partnership deed and registration will be submitted and in case of a proprietorship firm the details of all proprietors and the percentage ownership in the proprietorship concern.

**In Part – II** of the tender should contain financial bid indicating monthly licence fee (per month) offered by the tenderer. The offer should be given in both words & figures.
