- a) Should have satisfactorily completed the works as mentioned below during the Last Seven Years ending Last Date of the Month Previous to the one in which Tenders are invited.

Criteria of eligibility for submission of bid documents:

Definition of Similar Works:- "SITC of Fire detection, fire alarm & PA system "."

i) Experience certificate: -

The bidder should have satisfactorily completed the similar works in Central Govt. / State Govt. (PSUS during the Last 7 (Seven) Years ending Last Date of the Month Previous to the one in which Tenders are invited.

Three Similar Works each of value not less than Rs. 4,00,854/- (40% of Rs. 10,02,134/-)

OR

Two Similar Works each of value not less than Rs. 6,01,280/-(60% of Rs. 10,02,134)

OR

One Similar Work of value not less than Rs. 8,01,707/- (80% of Rs. 10,02,134)

The value of executed works shall be brought to current costing level by enhancing the actual value of work at Simple Rate of 7% Per Annum calculated from the date of completion to last date of receipt of submission for bid.

- b) Should have had Average Annual Financial Turnover of Rs.....on construction works during the last three years ending 31st March.....
- c) The bidder should not have incurred any Loss (Profit after tax should be Positive) in more than Two Years during available Last Five consecutive Balance Sheets.

d) Solvency Certificate or Net Worth Certificate: -

Solvency of the amount equal to 40% of the Estimated Cost put to the Tender (ECPT).

Net Worth Certificate of Minimum 10% of the Estimated Cost put to Tender issued by certified Chartered Accountants (On the format prescribed in Form B-1).

e) Financial Information: -

The bidder should furnish the Annual Financial Statement for the Last Five Years in (Form- 'A'). Solvency Certificate in (Form- 'B') or Net Worth Certificate in (Form- 'B-1').

- The intending bidder must read the terms and conditions of CPWD-6 carefully, He should only submit his bid if he consider himself eligible and he is in possession of all the documents required.
- Information and instructions for bidders will form part of NIT & to be uploaded on website.
- Information and instructions for bidders posted on website shall form of bid document.
- The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen fromwww.dda.org.inor central public procurement portal https:// eprocure.gov.in/eprocure/app free of cost.

Those contracts not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online tendering process as per details available on the website. The intending bidder must have valid class - II digital signature to submit the bid.

6. But the bid can only be submitted after depositing E-tendering processing fee, and uploading the mandatory scanned documents.

The bidders who are not registered in DDA and wish to bid in DDA tenders are required to pay annual charge of e-tendering to Secretary CRB, DDA in prescribed form as under:

GST shall also have to be deposited @ 18% i.e. (CGST @ 9% & SGST @ 9%) along with tendering/processing fee to be deposited in the shape of DD/RTGS in favour of PAO(E/W)/DDA VikasMinar with GST no. for all the registered/non-registered/ to be contractors. Documentary proof in support thereof shall have to be uploaded by the bidders. Earnest money has to be deposited through separate transaction. Interested contractor who wish to participate in the bid has also to make following payments.

- The intending bidder must have valid class-II digital signature to submit the bid. 8.
- On opening date, the contractor can login and see the bid opening process. After opening of bids he 9. will receive the competitor bid sheets.
- Contractor can upload documents in the form of JPG format and PDF format. 10.
- Certificate of financial turn over: At the time of submission of bid contractor may upload affidavit 11 certificate from CA mentioning financial turnover of last 3 years or for the period as specified in the bid documents and further details if required may be asked from the contractor after opening of technical bids. There is no need to upload entire voluminous balance sheet.

Contractor must ensure to quote percentage rate. If a tenderer does not quote any percentage above / below on 12. the total amount of the tender or any section / sub head in percentage rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer.

The eligibility and / or technical bid shall be opened first on due date and time as mentioned above. The time and date of opening of financial bid of contractors qualifying the technical bid shall be communicated to them
