The enlistment of the contractors should be valid on the last date of submission of tenders. In case only the last date of submission of tender is extended, the enlistment of contractor should be valid on the original date of submission of tenders.

Those contractors not registered on the website mentioned above are required to get registered beforehand. The intending bidder must have valid class-II digital signature to submit the bid.

**Note 1:-** The bidder will use one UTR for one work only. In case, it is found that he has used one UTR number for different tenders, the entire tender submitted by him will be rejected and he will be debarred from further tendering in DDA in future.

1. If needed they can be imparted training on online tendering process as per details available on the website. The intending bidder must have valid class-II or class-III digital signature to submit the bid.

2. Bidders registered in Contractor's Registration Board (CRB) of DDA are required to pay the e-tendering annual charges as under:

Other contractors not listed with DDA will deposit Rs.20000/- + GST as applicable per year to upload their tender online.

The bidders who are not registered in DDA and wish to bid in DDA tenders are required to pay annual charge of e-tendering of Rs. 20,000 + GST.

Earnest money shall be deposited through RTGS/NEFT through separate transactions in the account of Sr. Accounts Officer, CAU (Horticulture) having Account No. 01201110000010, HDFC Bank, GF 01,02,03 Laxmi Deep Building, Laxmi Nagar, Distt. Centre, Vikas Marg, Delhi-110090 Branch (IFSC code HDFC0000120). The unique transaction reference of RTGS/NEFT shall have to be uploaded by the tendered in the e-tendering system by the prescribed date.

A part of earnest money is acceptable in the form of bank guarantee also. Earnest money up to Rs.20.00 lacs, will have to be deposited RTGS/NEFT mode. If the amount of E.M in more than Rs. 20.00 lacs then the amount of E.M beyond Rs. 20.00 lacs can be deposited in the form of Bank Guarantee also. Such Bank guarantee is to be scanned and uploaded to the e-tendering website within the periods of tender submissions.

Online tender documents submitted by intending bidders shall be opened only those bidders whose Earnest Money deposit and other documents are found in order.

- (i) No hard copy of any document will be required to be submitted by the tenderer till the opening of the tenders. Hard copies of relevant documents will be required from the lowest tenderer (L1) only.”
- (ii) Copy of Enlistment Order and other documents as specified in the press notice shall be scanned and uploaded to the e-tendering website (CPP Portal) within the period of tender submission.

Online tender documents, submitted by intending bidders, shall be opened only of those bidders, whose Performa for earnest money deposit declaration, Document and other documents uploaded on web site (CPP Portal) be found in order.


Any tender found lacking with respect to the necessary information and/or documents and/or earnest money deposit declaration will not be considered.
