1. The unique transaction reference on RTGS against EMD, Tender fee shall be placed online at specified location for Tender for Electronic Time and Attendance Recording System. First cover containing "Technical Bid" as well as "Reference of EMD, Tender Fee
2. The Tenderer technically qualified will be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt or they can view the bid opening event online at their remote end.

3. The Tenderer should furnish **Rs. 6,48,791.00** as Earnest Money. The amount will be retained by DDA as part of security deposit, in case tender is accepted, otherwise it will be refunded. However, no interest shall be payable on the earnest money.
4. The tender shall be submitted online in two parts, viz., technical bid and price bid.
5. The bidder will use one UTR for one work only. In case it is found that he has used one UTR number for different tenders, all the tenders submitted by him will be rejected and he will be debarred from further tendering in DDA in future.



1. Scanned copy of unique transaction reference of RTGS/NEFT of EMD.
2. Scanned copy of Proof of Payment of E-tendering fee in CRB of DDA valid till last date of submission of tender.
3. Scanned copy of Enlistment Order in Contractor's Registration Board (CRB) DDA.
4. In case of partnership firm, General Power of attorney in favour of person who is authorized to sign the documents and partnership deed shall also be uploaded.
5. Scanned copy of certificate of Registration under GST and acknowledgement of up to date filed return (not older than December 2025). GSR registration must be of Delhi State.
6. Documents of ownership of batch type hot mix plant along with NOC/Consent letter to operate the plant/unit (i.e. Consent to operate the plant/unit) from Central Pollution Control Board/National Green Tribunal or other statutory authority. Or MOU (Memorandum of undertaking) on duly notarized non-judicial stamp papers of Rs. 100/- with the plant owners for batch type hot mix plant along with NOC/Consent letter to operate the plant/unit (i.e. Consent to operate the plant/unit) from Central Board/ State Pollution Control Board/ National Green Tribunal or other statutory authority. The MOU should be specific to the work/NIT. GPS enabled photographs (not older than 30 days from the last date of submission of bid) of the plant from different sides.
7. Documents of ownership of batch mix concrete plant along with NOC/Consent letter to operate the plant/unit (i.e. Consent to operate the plant/unit) from Central Pollution Control Board/National Green Tribunal or other statutory authority. Or MOU (Memorandum of undertaking) on duly notarized non-judicial stamp papers of Rs. 100/- with the plant owners for batch mix concrete plant along with NOC/Consent letter to operate the plant/unit (i.e. Consent to operate the plant/unit) from Central Board/ State Pollution Control Board/ National Green Tribunal or other statutory authority. The MOU should be specific to the work/NIT. GPS enabled photographs (not older than 30 days from the last date of submission of bid) of the plant from different sides.

NOTE: The tender acceptance letter should clearly mention the N.O.W/S.H./N.I.T reference and it shall be signed & dated after the uploading of tender.

11. Bank account details of the firm/contractor (Bank Name & Address, account number & IFSC code).
12. Scanned copy of PAN card of the Agency/Bidder.
13. Scanned copy of Certificate of work Experience of similar works.
14. Scanned copy of certificate of registration with ESIC & EPFO.
15. Any other document specified in the tender document.


